Report on the 23rd meeting of the Standing Committee of Voluntary Agencies (SCOVA) held on 20th September, 2013

The 23rd meeting of the Standing Committee of Voluntary Agencies (SCOVA) organised by Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare was held on 20th September, 2013 under the Chairmanship of the Hon'ble Minister of State(Personnel and Public Grievances) at Committee Room-A, Ground floor, Vigyan Bhavan Annex, New Delhi. The meeting commenced at 4.00 p.m.as scheduled with the Hon'ble Minister in the chair. The meeting was well attended with all the Official Members and most of the Non-Official Members attending the meeting.

The proceedings commenced with the Welcome speech delivered by Smt. Vandana Sharma, Joint Secretary, DoP &PW. After introduction of the members of SCOVA, the Hon'ble Minister addressed the gathering. In his speech he dealt at length about the purpose of institution of SCOVA and its objectives, the Pensioners' Portal and the Pensioners Grievance Redress and

PENSIONERS' CHAMPION



Railways and by the CDAP, Ministry of Defence invited much discussion and the Representatives from the respective Pensioners' Associations expressed their displeasure over the inordinate delay in issue of RPAs. Sri.Saniav Kothari, Secretary, DoP & PW stated that revised pension, as per VI CPC recommendations, is being paid to all the Pensioners and the guestion of issue of RPAs only is still pending. The main impediment in solving this problem is non availability of service records in some cases and sought the help from the Pensioners' Associations in furnishing the required information to the PAOs. He stated that a report on this subject is being submitted to the Cabinet Secretary, which he hoped would facilitate early settlement of this long pending grievance of the pensioners. The Representatives of Ministry of Railways explained that they are facing a lot of problems and stated that it would be extremely difficult for them to meet the deadline of 30th September fixed for issue of RPAs. The Minister intervened and asked the Representatives to ensure early action in the matter. The Representatives from the Ministry of Defence informed that the Pension disbursing Authorities do not have correct data and in many cases there is a mismatch between the data available with them and the data available with the pension Sanctioning Authorities. However, they have started action in this regard suo motu to revise the pension of about 4.5 lakh Defence Pensioners and hope to complete issue of RPAs by 30th September, 2014. At this juncture colonel Handa, Representative from the" Disabled War Veterans" pointed out that Disability Pension granted to disabled pensioners has not been revised and they continue to get pension at the rate of Rs.160 p.m. Hon'ble Minister remarked that it is quite inhuman to pay a paltry sum as pension to disabled Defence pensioners and the Department should initiate immediate action to revise their pension. He also stated that he would speak to the Hon'ble Defence Minister on this subject. One member pointed out that the crux of the problem lies in the fact that most of the Defence pensioners do not have a document with them which shows the amount of pension due to them and therefore issue of RPAs becomes very important.

2. Raising the issue of CPF beneficiaries one of the Representatives pointed out that the recent revision of the amount of ex-gratia to Rs.645/- p.m. is insufficient

and the amount should be increased. Secretary, DoP & PW informed the member that it is ex-gratia and not pension. However, as promised by the Hon'ble Minister in the previous SCOVA meeting the rate of ex-gratia has been revised after obtaining Central Cabinet's approval. Sri S.K.Vyas, member, National Council(Staff Side) JCM, stated that while ex-gratia to CPF beneficiaries was revised on implementation of V CPC recommendations, the same has not been revised after VI CPC. The Minister remarked that this may be referred to the VII CPC.

- 3. On CGHS matters, the Jt. Secretary DoP & PW informed that order has since been issued by the M/H &FW for merger of 19 P&T dispensaries with CGHS in 12 cities and therefore the problem of P&T pensioners who were not entitled to medical facilities under CGHS for not participating in CGHS while in service, has been solved and they can now become CGHS beneficiaries. Sri S.K.Vyas while appreciating the action taken to merge 19 P&T dispensaries with CGHS suggested that the remaining 32 P&T dispensaries may also function like CGHS dispensaries to cover other pensioners also. The Hon'ble Minister replied that he will talk to the Health Minister on CGHs matters.
- 4. Regarding opening of CGHS Wellness Centres one at Mohali, second at Panchakula and one more at Chandighar it was informed that due to financial and logistic constraints it is not possible to open more CGHS Wellness Centres.
- 5. On the question of anomaly in fixation of pension of DoT employees absorbed in BSNL, who retired between 1-10-2000 and 31-7-2001 the Official Representative of BSNL stated that DoT has come up with some suggestion and BSNL is working on it and they will finalize the proposal and send it to DoT before 30-9-2013. Sri S.K.Vyas suggested that last pay drawn may be taken as emoluments for computation of pension.
- 6. Regarding merger of 78.2% of IDA with pension in respect of BSNL pensioners the Official Representative of DoT/BSNL stated that a decision has already been taken to extend the benefit of merger of 78.2% of IDA with basic pension w.e.f.10-6-2013 and orders will be issued before 30.9.2013.

Agenda Items for 23rd meeting of SCOVA held on 20.9.2013.

1. The first item of the agenda regarding dispensing with

the submission of application in form-14 for sanction of Family Pension to the spouse of the deceased pensioner, which was one of the 12 items submitted by the Karnataka P&T Pensioners' Association, Bangalore, one of the 15 Non-Official Members nominated to the recently reconstituted SCOVA submitted to DoP &PW for inclusion in the agenda (out of which 3 items were included) was taken up and it was intimated that DoP & PW has accepted the suggestion and necessary order has been issued. It is heartening to note that necessary order has since been issued.

2. When the 2nd item (which was also one of the items submitted by Karnataka P&T Pensioners' Association) regarding taking Grade Pay of Rs.4,600 instead of Grade Pay of Rs.4,200 in to account for computation of revised pension of pre-2006 pensioners who had retired from the pre-revised pay scale of Rs.6,500-10,500 (S-12) was taken up, Sri K.B.Krishna Rao, Committee Member, KP&TPA pointed out that DoE, MoF vide its O.M. dated 13.11.2009 had revised the Grade Pay of S-12 grade from Rs.4,200 to Rs.4600 with retrospective effect from 1.1.2006 and therefore Grade Pay of Rs.4,600 must not be treated as the one granted to an upgraded pay scale and necessary modifications to the first schedule. Part-A, Section-1 of CCS(RP)Rules, 2008 may kindly be issued by MoF and to the concordance table annexed to the O.M. dated 28.1.2013 by DoP & PW to facilitate revision of pension by PAOs after taking in to account Rs.4,600 as Grade Pay instead of Rs.4,200. To this request, the Official Representative of DoE, MoF stated that O.M. dated 13.11.2009 was issued by DoE to clarify some doubts expressed by some of the Departments and the Grade Pay of Rs.4,600 was granted to the pay scale of Rs.6,500-10,500 only on its up gradation to the pay scale of 7,450-11,500 and therefore it cannot be taken into account for computation of revised pension of pre-2006 pensioners who had retired from the pay scale of 6,500-10,500 and further that the matter was before the CAT. At this stage, Karnataka P&T Pensioners' Association's Representative earnestly requested the Benevolent Govt, the MOF and the Dept of Pension and PW which has liberalized pension rules over the years with a view to help all pensioners and has introduced several pensioner friendly measures/schemes, to accept the present demand of the Association, which will go a long way in helping the pensioners who retired from the

- grade S-12. Responding to this, the Hon'ble Minister said that since the Pensioners' Association and DoE have different views on this issue the matter may be kept open and may be re-examined after obtaining a copy of the order passed by the CAT.
- 3. Regarding appointment of Specialists and General Medical Officers in CGHS on contract basis, the Official Representative of MoH & FW informed that a proposal to delegate powers to CGHS City level Officers to explore the possibility of appointment of Specialists on contract basis like Railways is under consideration. The Hon'ble Minister remarked that appointments through regular recruitment rules take a long time and hence appointment of specialists on contract basis will be expedited. The Representative of All India Federation of Pensioners' Association, Chennai, complained that though there are 2 ENT Specialists in Chennai, CGHS beneficiaries are referred to General Hospitals for Specialist consultation putting them to lot of inconvenience.
- 4. On problems faced by non-smart card holders of CGHS for availing medical facilities while on a visit to another CGHS City, it was informed that the problem gets solved when action to issue plastic card to each of the CGHS beneficiary is completed. Representative of All India Federation of Pensioners' Association, Chennai pointed out that issue of individual plastic card has not yet been completed in Chennai and requested for early action in this regard. The Official Representative of the MoH & FW informed that arrangements have now been made to expedite the issue of Plastic Cards and the cards will be delivered to the beneficiaries by post.
- 5. On the last item of the agenda regarding extension benefit of O.M. dated 28.1.2013 w.e.f.1.1.2006 instead of w.e.f.24.9.2012, Joint Secretary, DoP & PW informed that the matter has been referred to the Department of Expenditure for advice on further course of action to be taken in the matter consequent upon dismissal of SLP by the Hon'ble Supreme Court on 29.7.2013.

The Hon'ble Minister, in his concluding remarks stated that the Hon'ble Prime Minister discusses with him the issues concerning pensioners welfare and wants to reassure the pensioner community that the Government has an open mind in attending to their problems. He thanked all the participants who had come from places all over the country. The meeting ended at 6 p.m.

Draft Annual Report for the year 2012-13 of Karnataka Posts & Telecommunications Pensioners' Assn.

The Executive Committee of the Association is pleased to place the Annual Report of the Association for the year 2012-13 before the Annual General Body Meeting of the Association to be held on Sunday the 27th October 2013

1.3. It was a unique privilege for us to hold the last Annual General Body Meeting of our Association on 24th June, 2012 in the premises of "Pensioners' Bhavan", located at 61/1, 1st Main, 11th Cross, Telecom Layout, Jakkur Cross, Bangalore-560 064, which was opened simultaneously by Justice Sri N.Santosh Hegde, Retd. Judge of Supreme Court and former Lokayukta, Karnataka. The launching of our website www.kptpa.org was also done on the occasion by Justice Sri Santosh Hegde, making us part of the elite group of Pensioners' Associations owning websites. As the Postal Department wanted the room from which our R.T.Nagar office was functioning, we surrendered the accommodation In October 2012. Our office at "Pensioners' Bhavan" began functioning from November 2012 with a Manager as incharge on Mondays, Wednesdays, Fridays and Second Saturdays. Our office in "Pensioners' Bhavan" has been got equipped with a computer and internet facility.

2. Activities

2.1. The demand for Modified Parity under VI CPC has been partially conceded by the Government by issue of an Order dated

28-1-2013 by the DoP & PW. This was possible through our repeated efforts and also on account of judicial intervention. We do hope that the Government will be generous enough to give effect to its Order from 1-1-2006 instead of from 24-9-2012.

- 2.2. Our demands for (i) Constitution of 7th Pav Commission (ii) Merger of 50% of DR with pension with effect from 1-1-2011 (iii) Age-related additional pension from 65 years onwards to 75 vears at the rate of 5% for every five years (iv) Restoration of commuted portion of pension after 12 years (v) Increase in Fixed Medical Allowance to Rs. 2.000/- from the present Rs. 300/- p.m. (vi) Improvement in medical facilities - Extension/ expansion of CGHS and RELHS and applicability of CS (MA) Rules 1944 to pensioners residing in non-CGHS areas (vii) Enhanced family pension for ten years in case of death after retirement (viii) Rectification of anomaly in pension of BSNL pensioners who retired within ten months of formation of BSNL - i.e., October 2000 to July 2001 and (ix) restoration of the facility of drawal of Medical Allowance without voucher under BSNL MRS are being vigorously pursued, though, now and then, we get negative reply from the Government.
- 2.3. Our Association has been included in the list of Rotating Group of SCOVA recently and we have notified as reproduced in the August 2013 issue of Pensioners' Champion twelve new items for discussion in the meeting of SCOVA scheduled to take place on 20th September 2013.
- 2.4. The delay in drawal of six-monthly increase in DR and quarterly increase in IDA has got reduced on account of the authorization given to drawing officers to act on the basis of order appearing in the internet.
- 2.5. Pensioners' Day was observed on 22nd December, 2012 jointly by Karnataka P&T Pensioners' Association, Coordination Committee of Central Government Pensioners' Associations, Karnataka and Coffee Board Pensioners, Association.
- 2.6. The Executive Committee of our Association met on every 2nd Saturday of the month during the year.

3. CGHS Matters

3.1. A recent significant achievement is the decision of the Government to merge 19 Postal Dispensaries in 12 cities from 1-8-2013 and also action to complete issue of Plastic Cards. The Advisory Committees of CGHS Wellness Centres are functioning well. A meeting of Pensioner-Nominees of CGHS Wellness Centres with Additional Director, CGHS, took place on 24-8-2012 followed by another one during this year on 8-8-2013. These meetings have been very useful on account of the co-operative attitude of the AD. CGHS. Bangalore and CMOs incharge of Wellness Centres, in whose presence issues were discussed. The initiative taken by CCCGPA in getting the "Appointment System" introduced for consultation with Specialists in Polyclinic has received appreciation especially from pensionerbeneficiaries. Medical reimbursement claims are being settled without much delay at present as a result of the effective steps taken by the AD, CGHS, Bangalore and introduction of the system of crediting the claim amount in the personal bank account of the individuals concerned through NEFT. The waiting period for consultation in Wellness Centres has got reduced as a result of the action taken to employ doctors on contract basis in short term vacancies and filling up of the vacant posts.

3.2. Six cases of reimbursement of medical claims of postal pensioners living in non-CGHS areas, which we were pursuing legally, were settled during the year consequent on the dismissal by the Supreme Court of the 34 SLPs filed by the Government against the decision of lower judiciary in favour of the pensioners.

4. Other matters of importance

- 4.1. As a result of the initiative taken up by our Association, the Department of Posts issued clarificatory Order on 9th July 2012 making applicable the scale of Rs. 15,600-39,100 (PB-3) to JTS Group 'A' pre-2006 retirees.
- 4.2. As part of our charitable activities, we donated a sum of Rs. 5,000/- to Anatha Sishu Nivas, N.R. Colony, Bangalore in November 2012. Students of Government Primary School, 4th Phase Yelahanaka Satellite town, Bangalore were gifted with note books, ball-point pens, cakes and fruits in February 2013

5. Our role in connection with "Pensioners' Portal"

We filed four cases making use of the facility under CPENGRAMS and are pursuing the same. Suggestions have been made by our Association to DoP & PW for furnishing additional information in Pensioners' Portal. We received the Grant-in-Aid for 2012-13. Grant-in-Aid for 2013-14 has been released in the month of August 2013.

6. Our Publications

6.1 We continue to maintain regularity in publishing "Pensioners' Champion", through which we provide latest information on pension and CGHS matters. Members are requested to renew their annual subscription promptly without giving room for repeated reminders. Suggestions for improvement of the journal are always welcome.

6.2 The 8th Edition of "Compendium on Pension, CGHS and Medical Facilities for Central Government and BSNL Pensioners" updated up to June 2013 is being released during the AGB meeting of our Association on 27th October 2013. In re-editing the book, we would like to place on record the services rendered by Sri K.B.Krishna Rao and Sri B.L.Channappa, both Executive Committee Members of our Association and Sri A.Ramamurthy, Member of our Association

7. Membership and Finance

- 7.1 Our membership has steadily increased during the year and has now crossed 2,100. With the rent we get from letting out some portions of our building and the interest from the Life Membership deposited in Fixed Deposit and also the liberal donations from some members, we have been able to stabilize financially.
- 7.2 Audited Statement of Accounts for the year 2012-13 and Statement of Accounts in connection with construction of our building, "Pensioners' Bhavan" are appended to this Annual Report.

Eligibility of widowed/divorced daughters for grant of family pension - clarification regarding

(No. 1/13/19-P&PW (E) dated 11.9.2013 of DoP & PW)

Provision for grant of family pension to a widowed/divorced daughter beyond the age of 25 years has been made vide OM date 30.8.2004. This provision has been included in clause (iii) of sub-rule 54 (6) of the CCS (Pension), Rules, 1972. For settlement of old cases, it was clarified, vide OM dated 28.4.2011, that the family pension may be granted to eligible widowed/divorced daughters with effect from 30.8.2004, in case the death of the Govt. Servant/pensioner occured before this date.

- 2. This Department has been receiving communications from various Ministries/Departments seeking clarification regarding eligibility of a daughter who became widowed/divorced after the death of the employee/pensioner.
- 3. As indicated in Rule 54(8) of the CCS (Pension) rules, 1972, the turn of unmarried children below 25 years of age comes after the death or remarriage of their mother/father, i.e., the pensioner and his/her spouse. Thereafter, the family pension is payable to the disabled children for life and then to the unmarried/widowed/divorced daughters above the age of 25 years.
- 4. It is clarified that the family pension is payable to the children as they are considered to be dependent on the Government servant/pensioner or his/her spouse. A child who is not earning equal to or more than the sum of minimum family pension and dearness relief thereon is considered to be dependent on his/her parents. Therefore, only those children who are dependent and meet other conditions of eligibility for family pension at the time of death of the Government servant or his/her spouse, whichever is later, are eligible for family pension.

If two or more children are eligible for family pension at that time, family pension will be payable to each child on his/her turn provided he/she is still eligible for family pension when the turn comes. Similarily, family pension to a widowed/divorced daughter is payable provided she fulfills all eligibility conditions at the time of death/ineligibility of her parents and on the date her turn to receive family pension comes.

5. As regards opening of old cases, a daughter if eligible, as explained in the preceding paragraph, may be granted family pension with effect from 30th August, 2004. The position is illustrated through an example. Shri A, a pensioner, died in 1986. He was survived by his wife, Smt. B, a son Shri C and a daughter, Kumari D, the daughter being the younger. Kumari D married in 1990 and got widowed in 1996. Smt. B died in 2001. Thereafter, Shri C was getting family pension, being disabled, and died in 2003. Thereafter, the family pension was stopped as Kumari D was not eligible for it at that time. She applied for family pension on the basis of O.M., dated 30th August, 2004. Since she was a widow and had to independent source of income at the time of death of her mother and on the date her turn came, she may be granted family pension. The family pension will continue only till she remarries or starts earning her livelihood egual to or more than the sum of minimum family pension and dearness relief thereon.

This is only a clarification and the entitlement of widowed/divorced daughters would continue to be determined in terms of O.M. dated 25/30th August, 2004, read with O.M. dated 28.4.2011.

Agenda Items for 23rd Meeting of Standing Committee of Voluntary Agencies (SCOVA) to be held on 20th September, 2013, at Vigyan Bhavan Annexe, New Delhi

Agenda Items

1. Submission of application in Form 14 be dispensed with for sanction of Family Pension:-

As details of family members eligible for family pension in the event of the death of the pensioner, joint photograph with the spouse and the amount of family pension payable in the event of death of the pensioner are available under Part II of the Pension Payment Order issued by the Pay and Accounts Officer or other Designated Authority, it is redundant and unnecessary to insist on submission of all these details in Form 14 for sanction of family pension. On the death of the pensioner, a written request from the spouse along with a death certificate of the pensioner is sufficient to sanction the family pension. So the extant cumbersome procedure may be dispensed with and a simplified procedure introduced.

2. Extension of benefit of upgrated Grade Pay to pre-2006 retirees of S-12 grade:-

Benefit of upgraded Grade Pay Rs. 4600, introduced subsequently in place of already implemented GP Rs. 4,200/- for S-12 grade in pre-revised scale of Rs. 6,500-10,500 w.e.f. 1.1.2006 in terms of O.M. No. F.No 1.1.2008-IC dated 13.11.2009 of M/o. Finance, Department of Expenditure is not extended to pre-2006 pensioners retired from S-12 grade. The clarification assuems importance in view of the need for protection of 50% of the minimum Pay in the Pay Band & Grade Pay in O.M. dated 28.1.2013.

3. Complaints to Public Grievance:-

At present the complaints lodged with Public Grievances is forwarded to the Ministry. Therefore, complaints on Subordinate Officer take a long time to reach them (Subordinate Officer). It is therefore necessary that the complaints are forwarded directly to the officers against which the complaint is lodged to avoid undue delay.

4. Broad Banding of Disability Element for Pre-1996 cases.

In implementation of the 5th CPC recommendations, Dept. of Pensions & PW had issued OM dated 3.2.2000 for revision of disability and family pensions for post 1996 disabled pensioners which, inter alia, applied the principle

of broad-banding to compute reckonable percentage disability. Vide OM dated 11.9.2001, the same benefits were extended to pre-1996 pensioners with effect from 1.1.1996. These orders, like others issued by DoP&PW, are equally applicable to civil as well as defence pensioners. MoD, however, extended the broadbanding benefit to post-96 disabled pensioners only, vide its order dated 31.1.2001, denying it to the pre-96 lot. The 2009 Cabinet Secretary's Committee, agreed to eliminate this anomaly, However, MoD (DESW) orders dated 19.1.2010 granted the benefit w.e.f. 1.7.2009 only, comptetely ignoring the fact that the same benefit on the civil side has been extended w.e.f. 1.1.1996. The matter was again raised with Deptt/ESW in August 2010. The need to apply the orders w.e.f. 1.1.96 was accepted. However, the revised orders are vet to be issued even after lapse of nearly 2-1/2 years.

5. Appointment of Specialists and General Medical Officers in CGHS:-

Aged Pensioners are unable to go to crowded Government Hospitals and obtain specialist's prescription as the Specialists in the Government Hospitals are not only reluctant to issue such prescription on one hand but also the waiting time is enormous in the hospital. It is suggested that Specialists of various disciplines may be appointed on contract as is now resorted to.

6. Problems faced by non-Smart Card (old card holders) of CGHS:-

As per instructions issued by the Govt. of India, Ministry of Health & Family Welfare vide letter No. 6024/2007/CGHS (HR) CGHS(P) dated 17.12.2012, the beneficiaries of CGHS can get treatment in all CGHS covered cities in India and there is no need for obtaining temporary attachment while on a visit to another CGHS city. It has been brought to the notice of this Association by the members that if they carry CGHS cards while on visit to out stations, their dependant members, who do not accompany them, face great difficulty, in case of emergency as without card, Wellness Centres do not entertain any patient. Even in case of emergency empanelled hospitals do not entertain any patient

if the CGHS card is not produced to them within four hours of admission and treat the CGHS beneficiaries as ordinary patients and cashless treatment is not permitted. Similar is the position of the card holder if he leaves the card behind for use of his dependents in his absence or the dependent(s) goes to outstation. The Ministry of Health & Family Welfare is requested to find out a viable solution to this problem so that the beneficiaries of CGHS do not suffer during their visit to outstation.

7. Extension of benefit of O.M. dt. 28.1.2013 w.e.f. 1.1.2006 instead of 24.9.2012;-

Govt. of India, M/o P&PG & Pensions,

Department of Pension and Pensioners Welfare, New Delhi's Order No. F-36/37/2006-P&PW(A) dated 28.1.2013. In the light of the judgement of the Hon'ble High Court of Delhi dated 29.4.2013 delivered with reference to Writ Petition No's WP(C) 1535/2012, WP(C) 2348/2012, WP(C) 2349/2012 and WP(C) 2350/2012 read with Hon'ble Supreme Court of India's decision in SLP (C) 23055 of 2013 of the Union of India Vs CG S-(29) (SAG) Pensioners Association dated 29.7.2013, the date of effect mentioned in the GoI order dated 28/1/13 may be revised retrospectively from 1.1.2006 and arrears paid to the eligible pensioners.

Issue raised in 22nd SCOVA meeting as per minutes

1. SI.No. 1 and 19 of ATR of para 5:

Issue of revised PPO for Pre-2006 retirees and also to communicate the amount of pension as well as Family Pension to be revised opnsequent to the 6th Central Pay Commission to Pre 1.1.2006 pensioners

Follow up Action

(i) DoP & PW & CPAO:-

- * All the Ministries have been requested to issue revised authority for all pensioners, all the pensioners/family pensioners afresh. Secondly, with a view to reconciling the pension payment records, it had been decided to monitor the Pre-2006 cases only on the basis of e-scrolls made available by the banks. The CPAO is in the process of reconciling the data with the banks and Ministries/Departments. The progress is being monitored in this Department. To strengthen the monitoring at the level of the Secretary of the administrative Min/Deptt., this item has been made a part of the Monthly d.o to the Cabinet Secretary.
- * Several meetings were arranged by the CPAO at the level of Controller General of Accounts, Addl., CGA, CC(P), CPAO with the CCAs/CAs of Ministries/Departments to discuss the problems and to plan strategies to complete the targets within stipulated time. Letters were also written at the level of CGA to AGs and Administrators of Union Territories.
- * Pension of all the live pensioners of pre-2006 and pre-1990 have already been revised as reported by banks.
- * As on 8.8.2013, 71,334 cases (34,733 pre-1990 and 36,601 pre-2006), of Civil Ministries/Deptts, are pending for revision. Approximately, 82% work of Civil Ministries/Departments has been completed.

* The major reason for non-revision of remianing cases by Ministries/Departments are reorganisation of various Departments/PAOs and non-availability of records of the pensioners in CPAO, Ministries/Departments and Banks. The efforts were also made through advertisements to approach to the pensioners, but poor response from pensioners/family pensioners has also become the reason of this slow progress as their pension has already been revised by the banks.

Action Plan:

- * Due to non-availability of complete information required for revisions (viz, updated address, date of birth of beneficiaries spouse, new a/c no. etc) with the Pension Santioning Authority, Railways could not revise the PPOs. *suo moto* Accordingly, the Railways published advertisements in news papers/TV etc. to call for requisite details through application form.
- * Assistance of RBI was also availed to issue instructions to the Banks to place notices in Banks premises requesting Railway pensioners to fill up application forms and send the same to Railways.
- * Revised PPOs have been issued in respect of application forms received from the pensioners.
- * However, all these efforts did not help in getting applications from all the pensioners/family pensioners. Therefore, PPOs could not be revised in remaining cases.
- * The position was reviewed in May, 2013, and it was decided to issue the PPOs. *suo moto* by collecting the requisite information/details form Banks.
- * Railways had been given a target of 30.9.2013 for completion of this work.

(iii) Department of Posts:-

Out of the 2,12,995 identified cases of pre-2006 pensioners/family pensioners, 1,55,957 PPOs have been revised and issued upto 31.7.2013, thus 73.22% works stands completed. All the Heads of the Circles/Postal Accounts Officers have been requested to complete the balance work at the earliest.

The work regarding revision of pension and PPOs of Post-2006 pensioners has been completed almost cent percent.

(c) M/o Defence (D/o Ex-Servicemen Welfare):-

Corrigendum PPOs could not be issued by the concerned Pension Sanctioning Authorities (PSAs) for want of computerised data. There was some mismatch in data available with the PSAs and with the current pensions PDAs. Accordingly, a Task Force was created during one of the meetings held on 9.5.2013 comprising reps of SBI, PNB (large pension Disbursing Banks) and CGDA to sort out the matter. It has been reported that the records in respect of post-2006 pensioners have since been computerised and data base exists for 4.5. lac pensioners (approx). Digital records of 5.88 lac pensioners have also been created in respect of pre-2006 pensioners under Project Sangam so far. It has been proposed to create print file of approx. 1 lac cases every month for the next 4-5 months commencing August 2-13. It has been assured that digitisation of pensioners both pre-2006 and post-2006 pensioners would be finalised for approx 15.5 lac pensioners by December 2013.

* No specific grievances have been pointed out. However, it is submitted that CGDA has prepared pension guide for the benfit of pensioners as well as the Pension Disbursing Agencies/Head of Offices/Record Offices apart from developing a computerised pension enquiry project (SUVIGYA). It is online pension enquiry system which enables the ex-service men to know their entitlements of pension at the click of a button after giving certain basic inputs. There is a Public Grievance Officer (PGO) in the O/o PCDA(P). Allahabad for redressal of pensioners grievances. A cell also exists there to attend to the grievances relating to pension. Another mechanism developed in the Office of PCDA(P), Allahabad is to lodge the pension related complaints online through the official website or through e-mail.

Arbitrary orders dated 1.8.1996 and 1.9.1996 issued by Ministry of Health and Director of CGHS may be withdrawn and the benefit of CGHS facilities be allowed to the pensioners of Department of Post and Department of Telecom as specially provided

D/o Telecommunications:-

DOT is not providing any medical facility to Pensioners. Ministry of Health and FW issues CGHS Card directly to the pensioners on payment of requisite fees. CS(MA) Rules, medical facilities under CGHS is a subject matter of Ministry of Health & Family Welfare. As per MoH & FW O.M. No. S-11011/46/95-CGSD-II/CGHS(P) dated 1.8.96 P&T Pensioners who were not participating in CGHS while in service are not eligible for CGHS facility after retirement.

D/o Posts & M/o Health & FW:-

* Regarding merger of P&T dispensaries with CGHS:-

Recently, CGHS has taken over 19 P&T dispensaries in 12 cities w.e.f. 1st August, 2013 vide MoH & FW's notification dated 9.7.2013 circulated by Department of Posts vide circular No. 2-3/2009- Medical dated 18.7.2013. Accordingly, P&T pensioners residing in these cities may join CGHS to avail its facilities including inpatient medical treatment/hospitalisation etc. The issue stands settled.

- (16)-(i) The existing Pensioners of Department of Posts and Telecom covered by P&T Dispensaries are neither considered for treatment of hospitalization facilities nor for Fixed Medical Allowance &
- (ii) Pensioners falling within the limit of P&T Dispensaries / CGHS Hosptials may be allowed to opt for P&T Dispensaries or drawal of FMA.

Issue regarding opening of new Dispensary at Panchkula:-

D.oP & PW:-

Issue was taken up by the Hon'ble Minister of State (PP) with the Minister of Health & FW vide D.O. letter dated 26.2.2013.

M/o Health and Family Welfare:-

Due to the financial and logistic constraints it is not possible to open a new dispensary at Panchkula. The Ministry has mooted a proposal for opening at least one dispensary each in the capital city of States which do not have the presence of CGHS as yet.

The matter is under process regarding computerisation of CGHS dispensary at Jammu.

Dissemination of information in real time:

Department of Posts:-

D/o Posts vide letter dt. 11.10.2012 has issued instructions for payment of DR to pensioners on the basis of O.M issued by Department of Pensions and Pensioners Welfare, and without waiting for the separate circular, the same instructions were again reiterated vide letter dt. 25.6.2013

5. 6.5 of Para 6

Nomination facility for Family Pensioners drawing Life Time Arrears:

DoP & PW:-

The matter has been again examined in consultation with the D/o Legal Affairs. It has been decided that since family pension is granted only for the sustenance of the family of the deceased Govt. servant/pensioner it is not legally correct to consider the same as property of the family pensioner and therefore to facilitate nomination for the same. At the same time, instructions have been issued to allow payment of lifetime arrears up to Rs. 2,50,00 without succession certificate when no member in the family is eligible for family pension.

In view of the foregoing, it is proposed that the item may be dropped.

7. 12. Nomination for reimbursement in CGHS: DoP & PW:-

Ministry of Health & FW informed that it would be administratively difficult to monitor nomination on a regular basis as the facility for change of nomination at any time would also have to be provided.

However, in our letter dated 30.7.2013, Ministry of Health was informed that seeking affidavits/ NOC etc. on stamp paper from the legal heirs/ family members may cause avoidable inconvenience to them. The feasibility of reimbursing the hospitalization expenses in respect of the deceased employee/pensioner to the nominee for the purpose of GPF, gratuity, CGEGIS, etc. could, therefore, be examined. Ministry of Health & FW is again requested to reconsider the matter and to inform the decision taken in this regard.

The working hours of CGHS dispensaries have since been revised to 8.00 a.m. to 3.00 p.m. with a 30 minutes lunch break from 1.00 to 1.30. It has been made applicable across the country at all CGHS locations.

But, Department of Expenditure did not agree to the same. However, a fresh proposal for calculation of pension to such absorbees on notional basis is under examination in the Department.

The inputs had been received from BSNL. The proposal for revision of pension/family pension of pre-2007 and post-2007 BSNL IDA pensioners/family pensioners by allowing the benefit of merger of 50% of DA/DR effectively amounting to 78.2% as on 1.1.2007 w.e.f. 10.6.2013 based on the pay revision of BSNL serving employees w.e.f. 10.6.2013 is under consideration.



Submission of Form 14 by spouse to the Pension Disbursing Bank after the death of the pensioner-instructions reg.

(O.M. No. 1/27/2011-P&PW(E) dated 20.9.2013 of DoP & PW)

The undersigned is directed to draw attention to the requirement of applying for family pension in Form 14 as given in rule 81 (2) (A) (ii) of the CCS (Pension) Rules, 1972.

- 2. This Department has been receiving representations from various quarters to do away with the condition of applying for family pension in Form 14 as it is causing inconvenience to widows, who find it difficult and embarrassing to present themselves before two Gazetted Officers/Persons of repute for attestation of Form 14.
- 3. Before commencement of family pension, personal identification details of the spouse such as speciment signature, personal mark of identification and left hand thumb impression, proof of age/date of birth of spouse and an undertaking from him/her for recovery of excess payment are to be obtained by the Bank. Form 14 serves as a standard processing sheet, which defines and delineates the exact requirement of information to be given to the pension disbursing Bank. It was apprehended that in the absence of this standard, the widows may be asked to submit any relevant or irrelevant information by the Bank. This could also lead to delay in commencement of the family pension.
- 4. The matter has been examined and it has been agreed that in case the pensioner and spouse are holding a joint account, the possibility of claim for family pension from someone else does not arise. Therefore, in such cases, there is no requirement of Form 14. The spouse may inform the Bank of death of the pensioner and request the Bank for

commencement of family pension, through a simple letter. He/she may enclose a copy of death certificate of pensioner, PPO, proof of his/her own age/date of birth and an undertaking for recovery of excess payment. In other cases, i.e., where the pension is not being credited to the joint bank account of the pensioner and his/her spouse, Form 14 will be continued to be obtained by the Banks. However, the condition of attestation of Form 14 has been done away with and witnessing by two persons has been considered as sufficeint.

- 5. For all future cases, Head of Office will forward to the PAO, along with similar details for the pensioner, the speciamen signature, personal mark of identification, left hand thumb impression, the proof of age/date of birth and an undertaking from the spouse regarding recovery of excess payment. After the death of the pensioner, the spouse of the deceased pensioner will be required to provide only death certificate to the paying Bank, who will identify the spouse based on the information given in the PPO and its own "Know Your Customer" procedures. Where the pensioner and his/her spouse do not have a joint account, Form 14 will be required as in para 4 above.
- 6. This issues with the concurrence of Department of Expenditure, vide their ID No. 601/E,V/2013, dated 13.9.2013.
