Department of Administrative Reforms & Public Grievances has been requesting States, UTs and Central Ministries to adopt self-certification and for abolition of Affidavits and several communications have been sent in this regard.

## CGHS Matter

Reimbursement for purchase of Hearing-Aid under CSMA and CGHS (Gol, Ministry of Health and Family Welfare, Department of Health and Family Welfare, O M No.S.14025/10/2002/MS Dated the 26th May, 2015)

Revision of rate and guideline for reimbursement of expenses on purchase of Hearing-Aid Under CS(MA) Rules, 1944 and CGHS

With reference to the above mentioned subject the undersigned is directed to refer to the Office Memorandum of even no dated 21.03.2012, 17.11.2006 and 28.10.2002 and OM No S.14025/36/93/MS dated 26.03.94 and 17.08.99 and to state that on the basis of recommendation of an Expert Committee, it has been decided to revise the rates and guidelines for hearing-aids to be reimbursed under CS(MA) Rules, 1944 and CGHS.

2. The revised ceiling rates fixed for various types of hearing-aids (for one ear) are as under:-

- Body worn/Pocket type
  Rs. 3000/-
- Analogue BTE Digital Rs. 7000/-
- BTE Digital Rs. 15000/-
- ITC/CIC Rs. 20000/The cost of hearing-aids shall include

all taxes, in including VAT and shall carry 3 year warranty. The cost of analogue BTE/ Digital BTE/ITC/CIC type hearing-aid shall also include the cost of hearing mould.

3. Beneficiaries covered under CS (MA) Rules CGHS shall be eligible to obtain hearing-aid as per the following guidelines:

- (i) Patients/Beneficiaries should be properly referred to CGHS/Government Hospital ENT Specialist from the parent CGHS Wellness Centre (A computerized referral printout should be made wherever computerization has been done).
- (ii) It would be mandatory to carry CGHS Beneficiary's ID card (in original) whenever the CGHS Beneficiaries visit the CGHS/Govt. ENT Specialist for consultation and Audiometric test.
- (iii) The ENT Specialist of CGHS /Govt. Hospital shall then recommend a hearing-aid on basis of Audiometric and Audiological assessment, specifying the type of hearing-aid most suited for the

Beneficiary. The 'Audiogram report' shall be authenticated by the ENT Specialist/ Consultant of the CGHS/Government Hospital.

4. The permission to procure hearing-aid shall be granted by the Additional Director(Zonal) of CGHS Zonal Office in case of CGHS Pensioner Beneficiaries and by the Head of Department/ Office in case of Serving Employees and CGHS Beneficiaries of Autonomous Bodies on the basis of recommendation of a CGHS/ Government ENT Specialist, and an 'undertaking' that the Beneficiary has not been reimbursed the cost of hearing-aid in the preceding five years.

5. Reimbursement claim shall be submitted to CGHS Zonal Office through the CMO Incharge of the concerned Dispensary by CGHS Pensioner Beneficiaries in the prescribed medical reimbursement claim form along with the following documents:-

- a) Referral letter from parent CGHS Wellness Centre (computerized slip where computerization is done already).
- b) Copy of 'prescription' of ENT consultant (CGHS/Govt.Hospital) with the 'Audiogram' report duly authenticated by the treating ENT Consultant (CGHS/ Govt).
- c) Copy of CGHS Card.
- d) Bill/Receipt (in original) carrying details of the hearing-aid seller i.e. NAME, QUALIFICATION and RCI/MCI REGISTRATION NUMBER of the hearingaid seller.
- e) The 'permission letter' to purchase hearing-aid (in original).
- f) Empty Box/boxes or the Carton(s) with the label showing details of the hearing aid supplied.

In case of the other Beneficiaries, the medical claim shall be submitted to the

concerned Ministry/Department/Office. Reimbursement shall be limited to the ceiling rate or actual cost of the hearing-aid, whichever is less.

6. Records of permissions granted for procurement of hearing-aids shall be maintained by CGHS in respect of Pensioner CGHS Beneficiaries and by the concerned Ministry/ Department/ Office in respect of other Beneficiaries.

7. Replacement of hearing-aid may be permitted after 5 years on the basis of condemnation certificate issued by a technical expert and on approval of CGHS/Government ENT Surgeon. Maintenance and repair will be the responsibility of the Beneficiary.

8. These Orders shall supersede all the earlier Orders issued on the subject.

9. The revised rates and guidelines shall come into force from the date of issue and shall be valid for a period of two years or till further revision, whichever is earlier.

I0. This issues with the approval of Integrated Finance Division of Ministry of Health and Family Welfare.

#### Subject: - Clarifications regarding Introduction of Pension Scheme and Post Superannuation Medical Benefits in CPSEs.

The undersigned is directed to refer to this Department OM of even number dated 21.05.2014 on the above subject and to state that para (xix) in the said OM may be read as under:

"In case of Pension Scheme, ideally there should be no provision of 'commutation' since the provision of pension in 2007 pay revision guidelines was introduced so that employees have social security and get substantial monthly pension after superannuation".

All other provisions of the said OM remain same.

# **Emergency Facilities in CGHS Dispensaries**

The CGHS Dispensaries have all the medicines required in emergency. As per the CGHS guidelines, a provision is there to keep medicines available to counter any medical emergency that might arise within the Wellness Centre. There is an Emergency Tray available with the nursing staff which contains most of the medicines required under emergency situation. The availability of the medicines with their valid date of expiry in this Emergency Tray is checked on a regular basis and also during surprise checks.

A complaint was received on 7.9.2013 from Shri R.C. Khuntia, the then Member of Parliament in respect of Pensioner Beneficiary, Shri B.K. Joshi regarding non-supply of life saving drugs on time by CGHS Bhubaneswar. The delay in supply was due to non availability of cancer medicine with the authorized stockist.

In case the medicines are not available at the Wellness Centre, they are procured through local purchase. If any medicine is prescribed by the treating doctor that is required to be used immediately and if that medicine is not available in the Wellness Centre, authority slip is issued to the patient to collect the medicine from the authorized local chemist free of cost.

The Management Committee Meeting was held at the Auditorium of Udayabhanu Kala Sanhgha, Kempegowdanagara, Gavipuram, Bengaluru 560019 at 1000 hrs on 31-5-2015.

Sri K.B. Krishna Rao Chairman presided over the meeting and conducted the proceedings.

Sri S.Radhakrishna, General Secretary welcomed the participants and informed that meeting will commence with a lecture on the subject "Leading Healthy Life After 60 Years" by Dr. Rajendir P Joshi, CMO, CGHS Wellness Centre, Koramangala, Bengaluru and introduced the gathering. Dr. Joshi to Then. Sri K.B.Krishna Rao, Chairman, CCCGPA, welcomed Dr.Joshi, Sri N.Bhaskaran, Advisor to CCCGPA, Representatives of Affiliate Assns. from Bengaluru, Udupi and Bijapur, and all others.

Dr. Rajendir P Joshi delivered his lecture along with a power point presentation of the subject, which was both educative and informative. He touched upon relation between health and life management. He said that health is not merely the absence of disease or infirmity, but a complete physical, mental and social wellbeing. He advised the audience to avoid preventable illnesses; enjoy life in the present tense; avoid premature death by leading life carefully. He described symptoms of some common old age ailments like diabetes, hypertension (BP) and other serious diseases like kidney failure, hyper/hypo thyroid, paralysis, cancer. He emphasized on importance of stress management after 60 years.

On conclusion of his lecture, Dr. Joshi was thanked and honoured by the Chairman. Dr. Joshi thanked the Management Committee for the honour and for arranging the lecture. His discourse was appreciated by all present.

AGB:** The Secretary said that in view of the construction activities going on in the premises of Uday Bhanu Kala Sangha, the date for holding the AGB cannot be fixed right now, but it will be held before the end of September by which time the venue for holding the AGB may be available. Exact date will be informed to all.

**3. Revision of Pension of Pre-2006 Pensioners:** The Chairman, Sri K.B.Krishna Rao, intimated that since all the SLPs filed by the Government before the Hon'ble Supreme Court have been dismissed, the issue has attained legal finality and the Government may have to now implement the O.M. dt. 28-1-2013 from 1-1-2006 instead of from 24-9-2012.

**4. 7th CPC-** The General Secretary, Sri Radhakrishna, explained that tendering of evidence before 7th CPC by all Stakeholders is over except the one on minimum wages. One more sitting will be held on 9<sup>th</sup> June on this. CPC is likely to submit its report before 31.8.2015.

**5. CGHS:** The General Secretary informed that since the last meeting, CGHS rates of about 30 medicines and some diagnostic tests have been revised. There is improvement in empanelment of Hospitals also and now there are 14 Hospitals, 5 Diagnostic Centres, 3 Eye Care Centres and 4 Dental Clinics empaneled under CGHS.

5.1. Sri H.K.Mallya, President, Udupi District P&T Pensioners' Assn. expressed dissatisfaction over medical facilities available for Pensioners in other Cities. He wanted to know why CGHS Wellness Centres cannot be opened in other Cities or, if that is not done, what are the alternatives and what CCCGPA is doing about it. He stated that the demand regarding extension of CS (MA) Rules to Pensioners is pending since several

years and no serious action has been taken by CCCGPA in this regard. The General Secretary informed that Pensioners' Associations have been fighting on the issues. The Government is not agreeable to open new CGHS Centres at all. The reimbursement of medical expenses has been allowed for some pensioners who filed cases before CAT. Apart from that, Pensioners residing in non-CGHS areas can also avail CGHS benefits in case of hospitalization for serious illness. Chairman informed the Members that the proposal for introduction of a Health Insurance Scheme for Employees and Pensioners is under active consideration of the Government and the Scheme has been cleared by the NITI Ayog (Planning Commission) as revealed by the Govt. in the last meeting of SCOVA.

6. **Pension Adalat:** Members complained that Pension Adalat is not being held regularly by many Departments since 2 years. Sri Dabade, Secretary CGPA, Bijapur stated that Adalat must be held regularly whether there are grievances or not.

7. **Any other subject:** a) The General Secretary proposed that Shri B.Sadashiva Rao, Founder Chairman CCCGPA, may be nominated as Permanent Advisor to CCCGPA. His proposal was unanimously accepted.

b) Sri N.Bhaskaran suggested that as Udaya Bhanu Kala Sangha has undertaken construction of 'Silver Jubilee Memorial Building' we may contribute some money to them, which was agreed to by all. After discussion, it was decided to collect Rs.500/- each from Affiliated Associations and donate Rs.10,000/- to the Sangha during the AGB of CCCGPA.

c) BSNL Pensioners Welfare Association, Karnataka Circle, Bengaluru volunteered to host the next Management Committee Meeting to be combined with Annual General Body Meeting.

The Chairman thanked Sri T.V.Surya Praksh, Joint General Secretary, CCCGPA & Secretary, Coffee Board Pensioners' Association for fixing the Venue, Caterer and for making all arrangements, including arrangements for power point presentation by Dr. Joshi, which paved the way for a smooth conduct of the meeting. Sri T.V.Surya Prakash, proposed vote of thanks. The Meeting concluded at 1400 hrs with lunch.

#### 1. CGHS Facility to P&T Pensioners who were not participating in CGHS while in service

Ministry of Health vide its OM No. S-11011/46/95-CGHS-D11/CGHS (P) dated 1-8-1996 stated that " **P&T** Pensioners who were not participating in CGHS while in service are not to be extended this facility"

Hence, P&T pensioners who were not beneficiaries of CHGS at the time of their retirement were denied this facility even if they were living in areas covered under CGHS.

Late Sri N.Nanjundaiah & some other Members, under the guidance of Sri B.Sadashiva Rao, former President, K P&T PA, filed applications before CAT, Bangalore, which were allowed by the CAT. In its Judgement delivered on 20-11-2001 in MoH OA No. 304/2001, CAT held the MoH OM dated 1-8-1996 as *"discriminatory, arbitrary, unjust, and against the principles of law and violative of Article 14 & 16 of the Constitution".* 

Writ petition filed by the Govt. before High Court of Karnataka was dismissed. Supreme Court refused to grant Stay on the Orders of the High Court.

Consequently, CGHS issued temporary cards, to be renewed once in 6 months, to the Applicants, pending disposal of the case in Supreme Court. This is still continuing.

SLPs **10109 to10121 of 2010**, filed by the Govt. before the Supreme Court were dismissed on **22-8-2014**.

#### Extract of the Order

Upon hearing the Counsel, the Court made the following Order

No steps are taken to remove the defects in the application filed for bringing the LRs of the deceased respondent on record though sufficient time has been given for this purpose. No further time can be granted. Since

the application which is filed is not in proper form and has many defects as pointed out by the office in its report, such an application is dismissed for this reason. As a consequence, special leave petitions are dismissed as abated qua deceased respondents as per office report date 10th March, 2014

Since the case has attained legal finality consequent upon dismissal of the SLPs by the Supreme Court and as sufficient time has elapsed since dismissal of the SLPs on 22.8.2014, CGHS will have to now issue Permanent Cards to the Applicants and other P&T Pensioners, who have been issued with temporary CGHS Cards. K P&T PA will pursue the matter with the Additional Director, CGHS, Bengaluru and also will take up the matter with the Ministry of Health & FW, requesting it to withdraw its letter dated 1.8.1996. CGHS Beneficiaries, who have been issued with temporary cards, may write to the Addl. Director, CGHS, requesting for issue of Permanent Cards in view of the Supreme Court Order cited above. Members may contact the Secretary, K P&T PA for further information required, if any.

### Linking of Aadhaar No. with CGHS Beneficiary ID

Gol, Ministry of Health & Family Welfare, O.M. No. Z-15025/11/2015-Dir (CGHS) dated the 10th July, 2015.

As you are aware, CGHS is in the process of introducing web-based services for its Members. In this context, it is necessary to link Aadhaar number with the CGHS Beneficiary IDs of all Beneficiaries before such services can be launched.

2. The procedure for doing so is as follows:

(i) **Through CMOs-in-charge Module**-Beneficiary can visit CMO-in-charge of his Dispensary with Aadhaar Card to get his and family members Aadhaar registered.

(ii) **Registration of Aadhaar number by Beneficiary himself-** Following steps to be followed:

- a. Log on to cghs.nic.in
- b. Click 'Click here to view beneficiary details'

- c. Click 'login with Ben Id'
  - d. To get password click 'Generate Password'
  - e. Enter details and a password will be sent on the registered mobile phone no. of the beneficiary
  - f. Enter Ben Id and Password and sign in
  - g. Click 'update Aadhaar number'
  - h. Enter Aadhaar number for all family members and save.

3. This is an important initiative and is being monitored as a part of Pragati. It is, therefore, requested that all employees of the Ministries/ Departments may be motivated to seed their Aadhaar numbers through either of the modes mentioned above.

4. Co-operation of all Ministries/Departments in this regard would be highly appreciated.
