"PENSIONERS' DAY"- A DAY TO THANK THE JUDICIARY

Pensioners, all over India observe "Pensioners' Day" in the month of December, every year. It is necessary that every Pensioner understands its significance.

- 2. Present day Pensioners may not be aware that till late seventies, there was nothing like revision of pension, when once it is fixed and authorised at the time of retirement. The First, Second and Third Central Pay Commissions had not even discussed this aspect in their reports as they were not required to do so as per the Terms of Reference handed to them by the Government,
- 3. It is the famous judgment of the Supreme Court of India (Called-"Nakra Judgment") which changed the life of Pensioners. The Five Member Bench presided over by Hon'ble Justice Sri.Y.V.Chandrachud heard Writ Petition No: 5939-41/1980 filed under Article

- **B. Sadashiva Rao,** Former President, KP&TPA and Former Chairman, CCCGPA, Karnataka
- 32 of the Constitution by (late) Sri. D.S.Nakra, a civil servant who retired on superannuation as Financial Advisor in the Ministry of Defence, Rear Admiral (late) Sri. Satyendra Singh, who retired from the Armed Forces and "Common Cause", a Society registered under the Societies Registration Act, 1960 and delivered a brilliant decision, which put the Pensioners on a different pedestal a more dignified and respectful position. In fact, this judgment has found an entry in the *Guinness Book of World Records*!
- 4. Some of the important observations contained in the Nakra Judgment are reproduced below for the information of our brother Pensioners:-

- i) Para-22: "In the course of transformation of Society from feudal to Welfare and as socialistic thinking acquired respectability, State obligation to provide security in old age, an escape from undeserved want, was recognised and as a first step, pension was treated not only as a reward for past service but with a view to helping the employee to avoid destitution in old age. The quid pro quo was that when the employee was physically and mentally alert, he rendered unto master the best, expecting him to look after him in the fall of life. A retirement system therefore exists solely for the purpose of providing benefits......"
- ii) Para-26: "......A pension scheme, consistent with available resources, must provide that the Pensioner would be able to live:
- (I) Free from want and with decency, independence and self respect,
- (II) At a standard equivalent at the preretirement level....."
- iii) Para-31: "From the discussion three things emerge: (i) that pension is neither a bounty nor a matter of grace depending upon the sweet will of the employer and that it creates a vested right subject to 1972 Rules which are statutory in character because they are enacted in exercise of powers conferred by the proviso to Art.309 and clause (5) of Art. 148 of the Constitution; (ii) that the pension is not an ex-gratia payment but it is a payment for the past service rendered; and (iii) it is a social welfare measure rendering socio economic justice to those who in the heyday of their life ceaselessly toiled for the Employer on an assurance that in their old age they would not be left in the lurch....."
- iv) Para-39: ".....Those who rendered the same service earned less pension and are exposed to the vagary of rising prices consequent upon the inflationary inputs. If,

- 5. Coming back, let me explain, in brief what exactly the claims of the petitioners were. Government of India had issued two orders -1) on 25-5-1979- in the Ministry of Finance and 2) on 28-9-1979 in the Ministry of Defence extending certain benefits under the Liberalised Pension Scheme to 1) Government servants who were in service on 31-3-1979 and retire from service on or after that date and 2) to Armed Forces Personnel who become non-effective on or after 1-4-1979. Both Sri D.S. Nakra and Sri Satyendra Singh did not get the benefit of the liberalised Pension Scheme as they had retired under II CPC in 1972. In the circumstances, they had contended in the Petition that "If the pension is paid for past satisfactory service rendered and to avoid destitution in old age as well as a social welfare or Socio-economic justice measure, the differential treatment for those retiring prior to a certain date and those retiring subsequently, the choice of the date being wholly arbitrary, would be according different treatment to Pensioners who form a class, irrespective of the date of retirement and, therefore would be violative of Art. 14. They also contended that classification based on fortuitous circumstances of retirement before or subsequent to a date, fixing of which is not shown to be related to any rational principle would be equally violative of Art.14.
- 6. Holding the stipulations in the Government Orders as unconstitutional, the Apex Court declared that all Pensioners governed by the

- 1972 Rules and Army Pension Regulations shall be entitled to pension as computed under the Liberalised Pension Scheme from the specified date, irrespective of the date of retirement and that arrears of pensions prior to the specified date as per fresh computation is not admissible.
- 7. After delivery of this judgment (i.e. 17-12-1982) the IV Central Pay Commission was constituted in July, 1983 and the Government of India, for the first time issued a Supplementary Terms of Reference "including therein the case of past Pensioners." The IV CPC, in its report hailed the Nakra Judgment as the "Law of the Land"-i.e. pension to be treated as property and all Pensioners, irrespective of their date of retirement to be treated as a homogeneous group for the purpose of pension including relief. For the first time, basic pension fixed at the time of retirement was consolidated giving fitment weightage (Additional Relief) on par with serving employees. Pensioners got Dearness Relief at the same rates as admissible to employees calculated on slab formula fixed at 50% of slabs for serving employees. Calculation of Pension/Family Pension based on slab system was recommended to be discontinued and pension @ 50% of Average Emoluments and Family Pension @ 30% of basic pay drawn at the time of retirement was recommended. For the first time a minimum of Rs. 300/- was recommended for grant of Family Pension.
- 8. Soon thereafter, Sri Rajeev Gandhi who took over as Prime Minister of India (1984-'89) improved the lot of those, who were past 60 years. He gave them a dignified designation as "Senior Citizens" for the purpose of extending Government benefits. A separate Department as "Department of Pension and Pensioners' welfare" was constituted to look after the welfare of Pensioners. The SCOVA was constituted to facilitate periodical meetings with representatives of Pensioners' Assns."Pension Adalath" was ordered to be held at various

- levels to hear and redress Pensioners' grievances. Central Administrative Tribunals (CATs) were established to hasten settlement of disputes pertaining to service matters of Government employees/Pensioners.
- 9 . Successive Central Pay Commissions headed by Judicial Luminaries were also influenced by the Nakra judgment and a liberalized out look was followed towards demands of Pensioners as could be seen from the following liberalizations in pension matters recommended by them.
- i) 5th CENTRAL PAY COMMISSION (Headed by Justice Pandyan)
- 1) The principle of 'Complete Parity' and 'Modified Parity 'in pension fixation, 2) Full compensation for price rice @ 100% DR, 3) Introduction of the concept of 'Interim Relief', 4) Introduction of Fixed Medical Allowance, 5) Full DA to count for Gratuities, 6) Percentage of Commutation of pension raised to 40% instead of 331/3%, 7) Age of superannuation raised to 60 years from 58 years, 8) Employed Family Pensioners and reemployed Pensioners to get DR, 9) Family Pension to be uniformly @ 30% of last Pay drawn instead of on slab system. 10) Dearness Pay @50% to count for 'Emoluments' and 11) Merger of 97% of DA in pay for gratuity purpose for those Pensioners who retired between 1. 7. 93 and 31. 3. 95. (given effect to from 1-4-1995)
- ii) 6th CENTRAL PAY COMMISSION (Headed by Justice Sri Krishna)
- 1) Last Pay drawn or Average Emoluments whichever is more beneficial to count as 'Emoluments for computation of pension 2) Age related Additional Pension introduced, 3) Enhanced Family Pension for 10 years when the Govt. servant dies in harness and 4) Full pension for 20 years of service instead of 33 years.

- 10. Judiciary, at various levels began quoting extensively the law laid down in Nakra Judgment for deciding cases of Pensioners. The following are important cases decided in favour of Pensioners by the Supreme Court after the Nakra Judgment:
 - i) WP: 5870-93/81: Ponnammal & Another – Vs - U.O.I - Justice D.S. Desai and Justice Ranganath Misra(Date of judgment: 30-4-1985) Family Pension under the Family Pension Scheme, 1964 was made admissible to all those who retired prior to 1-1-1964 also.
 - ii) WP: 3958/61/83: Common Cause & Ors.— Vs UoI - Justice P.N. Bhagavati & Justice Ranganath Mishra. (Date of Judgment: 9-12-1986) - Restoration of Commuted portion of pension with effect from1.4.1985 or after 15 years of retirement, whichever is later.
 - iii) WP:11855/95: P.Sundararajan & Welfare Assn. of Absorbed employees of Public Sector Enterprises – Vs - U.o.I. Justice Kuldeep Singh, Justice K. Venkataswamy and Justice S. Rajendra Babu: Restoration of 1/3rd commuted portion of pension from the date of commutation or 1.4.1985, whichever is later of PSU Absorbee with consequential benefit of Family Pension.

And the recent judgments are:

iv) OA: 655/2010 in CAT, Principal Bench, Delhi-Central Govt.SAG(S-29) Pensioners' Assn. - Vs - U.o.I read with WP: 1535/ 2012 in Delhi High Court and SLP(C) 23055/13 in Supreme Court of India -Date of judgement: 1-11-2011 Extension of the benefit of Modified Parity (- as defined originally in the DoP&PW Resolution dated 29-8-2008). As all the Writ Petitions/ Special Leave Petitions filed by the Government in Delhi High Court/ Supreme Court were dismissed, the Govt. issued an order on 30.07 2015 to the effect that the Pension/ Family pension of all pre 2006 Pensioners/

- Family Pensioners may be revised in accordance with the order dated 28.1.2013 of DOP&PW WITH EFFECT FROM 1.1.2006 INSTEAD OF FROM 24.9.2012.
- OA:937/2010 with OA:2101/2010 in CAT Delhi. All India S30 Pensioners' Assn. Order dated 20.11.2014 as modified in RA.10/2015 dated 24.9.2015. The Tribunal has heavily relied upon the Nakra Judgment and passed Order to the effect that the Government (i.e Respondents) should consider the revised pay of the Applicants corresponding to the pay at which the concerned Pensioner had, in fact retired instead of considering the minimum of the said pay scale to determine the pension of pre 2006 retirees, adding in the order dated 24.9.2015 that the basic pension of pre 2006 retirees in grade S 30 should be fixed such that it is not less than Rs.38,500
- vi) Restoration of 2/3rd commuted portion of pension of PSU absorbees who had drawn a lump sum payment equivalent to 100% of their pension on their absorption in CPSUs. Union of India and another- Vs-(late) K.Ganesan in Civil Appeals Nos. 6048 of 2010 and 6371 of 2010 decided by the Supreme Court of India on 1-9-2016. The Appeal of the Union of India was dismissed and the judgment of Madras High court in WPNo. 22207 of 2002 was upheld. Though the case has thus attained legal finality, the Government of India is yet to issue an Order for implementation of the Madras High court judgment.
- 11. It could thus be seen that Pensioners, who were totally ignored by the Government in the past, secured justice from the Judiciary for improving their lot and therefore, it is but natural that they feel grateful to the Judiciary. Every year in the month of December, they celebrate "Pensioners' Day" only to thank the Judiciary as the Nakra Judgment was delivered in the month of December.

Letter received from the Chief Postmaster General, Karnataka, is reproduced for information of Postal Pensioners

Provision of life certificates

A copy of the D.O. letter No. 12-12(1)/ 2015-Comp D-578 dated 30.9.2016 addressed to the CPMG by name, received from Postal Directorate is enclosed for taking necessary action. Under the Pension Rules all Pensioners are to provide Life Certificates to the Authorized Pension Disbursing Agencies like Banks, Post Offices etc., Earlier in order to get the Life Certificated the Pensioner was required to either personally present before the Pension Disbursing Agency or have the Life Certificate issued by Authority where he/she has served and have it delivered to the Disbursing Agency. This had often become a major hurdle in the process of seamless transfer of pension amount to the Pensioner and caused a lot of hardship and unnecessary inconveniences particulars for the aged and infirm Pensioners.

Digital Life Certificate now streamlines the process of getting Life Certificate by making it hassle free and easy and also it cuts down the requirement of physical appearance of the Pensioner in front of the Disbursing Agency or the certification authority. For successful completion of acceptance of Digital Life Certificate, Aadhaar details are required to be updated in

Pensioner's Account details in PAIS (Pension Accounting and Information software).

For seeding of Aadhaar details in PAIS, NIC has provided login ID and pass word to all the HPOs. The progress of seeding Aadhaar Numbers is not very encouraging. DoPW has issued an advisory to the Department to complete 100% seeding of Aadhaar number. Hence it is requested to direct the HPOs to obtain Aadhaar details from the Pensioners and complete Aadhaar seeding by 31.10.2016.

In addition to this references were made to sensitize the Pensioners to register for Digital Life Certificate however only 30% Pensioners have registered so far. HPOs may launch a drive to educate the Pensioners for opting Digital Life Certificate in place of physical life certificate by highlighting benefits and also HPOs are required to accept/reject Pensioners' life certificate who have registered for Digital Life Certificate on Jeevan Pramaan Portal. It is therefore requested to issue suitable instructions to all the concerned offices to take action on the above points on priority, Weekly progress report in this regard be sent to this office without causing any delay in order to enable this office to send the report to the Postal Directorate.

D.R. Order

Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 1.7.2016 on implementation of deicision taken on recommendation of 7th Centaral Pay Commission.

Gol, Ministry of Personnel, Public Grievances & Pensions Department of Pension & Pensioners' Welfare O.M.No. F.No. 42/15/2016-P&PW(G) dated 16th, Nov. 2016.

The undersigned is directed to say that subsequent to implementation of the decision taken by the Government on the recommendation of the 7th Central Pay Commission, the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners shall be as follows:

Date from which payable	Rate of Dearness Relief per month
From 1.1.2016	No Dearness Relief
From 1.7.2016	2% of Basic Pension/Family Pension

Note:- Dearness Relief at the rates indicated in the above table will also be admissible on the additional basic pension/additional family pension available to older Pensioners/Family pensioners based on their age as indicated in this Department's OMs 38/37/2016-P&PW(A) (i) dated 4.8.2016 and 38/37/2016-P&PW(A) (ii) dated 4.8.2016.

- 2. These Orders apply to (i) Civilian Central Government Pensioners/Family Pensioners (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners/family pensioners.
- 3. These orders will not be applicable on following categories:-
- (i) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Pakistan, who are Indian Nationals but receiving pension on behalf of Government of Pakistan and are in receipt of adhoc ex-gratia allowance.
- (ii) Central Government Employees who had drawn lum sum amount on absorption in a PSU/ Autonomous body and are in receipt of 1/3rd restored commuted portion of pension.
- (iii) Pensioners who are in receipt of provisional pension in the pre-2016 pay scales/pay
- (iv) CPF beneficiaries, their widows and eligible children who are in receipt of ex-gratia payment in terms of this Department's OM No. 45/52/97-P&PW(E) dated 16.12.1997 and revised vide this Department's OM 1.10.2012-P&PW(E) dated 27.6.2013

Separate Orders will be issued in respect of the above categories.

- 4. Payment of DR involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 5. Other provisions governing grant of DR in respect of employed Family Pensioners and reemployed Central Government Pensioners will be regulated in accordance withe the provisions contained in this Department's OM No. 45/73/97-P&PW(G) dated 9th July, 2009. The provisions relating to regulation of DR where a Pensioner is in receipt of more than one pension will remain unchanged.
- 6. In the case of retired Judges of the Supreme Court and High Courts, necessary Orders will be issued by the Department of Justice separately.
- 7. It will be the responsibility of the Pension Disbursing Authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 8. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to Pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 9. In their application to the Pensioners/Family Pensioners belonging to Indian Audit and Accounts Department, these Orders issue after consultation with the C&AG.
- 10. This issues in pursuance of instructions of Ministry of Finance, Department of Expenditure vide their OM No. 1.2.2016-E II (B) dated 4th Nov. 2016.

7th CPC benefits to Pensioners of Autonomous bodies CCCGPA writes to the Prime Minister

Respected Sir,

Subject: Inordinate delay in implementation of the recommendations of 7th Central Pay Commission in respect of Pensioners of Statutory & Autonomous bodies

The Coordination Committee of Central Government Pensioners' Associations, Karnataka would like to bring to your kind notice the following few lines, seeking your kind intervention in the matter for immediate resolution of the grievance of Pensioners of Statutory/ Autonomous bodies.

Government of India, vide its resolution dated August 2016, accepted the recommendations of the 7th Central Pay Commission on pensionery benefits and all the Central Govt. Civil Pensioners have been granted the benefits of revised pension with retrospective effect from 1-1-2016 and the arrears of pension due was also paid to them on 31-8-2016 along with their revised pension for the month of August 2016.

2. But, the Pensioners of Statutory & Autonomous bodies like Coffee Board, Rubber Board, Tea Board, Spices Board and Tobacco Board (under the Department of Commerce, Ministry of Commerce and Industry) Kendriya Vidyalaya Sangathan (under the Ministry of HRD), Khadi & Village Industries Commission (under the Ministry of Micro, Small and Medium Enterprises) Central Silk Board (under the

Ministry of Textiles) and National Council of Science Museum (under the Ministry of Culture), whose pensionery benefits also are regulated under the Central Civil Services (Pension)Rules ,1972 on par with Central Government Civil Pensioners and who have been eagerly waiting for implementation of the pensionery benefits to them simultaneously with Central Civil Pensioners, have been disappointed by the inordinate delay in extension of 7th CPC benefits even after 3 months from its implementation to other Central Pensioners.

3. This issue was raised by the Staff Side in the Standing Committee Meeting of the Joint Consultative Machinery (JCM), National Council, held on 25/10/2016. The Official side, reportedly, informed the Staff side that an overall review regarding the performance and financial viability etc. of each of the Autonomous bodies is being carried out by the Government and only after completion of the process of the review, a decision regarding extension of 7th CPC revised pensionary benefits to the Pensioners of Statutory and Autonomous bodies will be taken.

- 4. The above said information came as' bolt from the blue' to the Pensioners of Statutory and Autonomous bodies who were already worried about the delay in extension of 7th CPC benefits to them and they are now disheartened by this sudden development in their retired life.
- 5. All the above mentioned Statutory and Autonomous bodies were formed by the Central Government by an Act of Parliament and they have been following the Central Civil Services Pay and Pension Rules. Recommendations of all the previous Central Pay Commissions on revision of Pay & Pension were extended to them simultaneously with the Central Civil Services Employees and Pensioners. But, now the benefits due to them in terms of the recommendations of the 7th CPC have not yet been given to them even after 3 months from the date of acceptance of the Pay Commission's report by the Government.
- 6. The Coordination Committee of Central Government Pensioners' Associations, Karnataka, to which some of the Pensioners' Associations of Statutory and Autonomous bodies are affiliated, is of the firm view that imposing the condition of "review of Financial Viability "of the Autonomous bodies at this stage, before extension of 7th CPC benefits to the Pensioners of those Bodies, is preposterous and tends to create fear and doubt in the minds of those Pensioners about the fruits of the Pay Commission being denied to them and therefore, immediate action needs to be taken to allay their fears.
- 7. We earnestly request the Hon'ble Prime Minister kindly to intervene in the matter and to order that the question of "Review of Financial Viability" of Statutory & Autonomous bodies should not be linked, at this stage, with the implementation of the recommendations of 7th CPC to the Pensioners, since such a move on the part of the Government will result in further delay in granting the Pensioners of their rightful monitory/pensionery benefits and will definitely

cause frustration among them, most of whom are in the evening of their lives yearning for betterment of their finances for a peaceful retired life.

8. We, therefore, strongly urge that immediate action may kindly be caused to be taken to extend the recommendations of 7th CPC to all Pensioners of Statutory and Autonomous bodies pending review of the performance and financial viability of such Autonomous bodies.

During the workshop for banks on monitoring the Pensioners grievances through "Web Repsonsive Pensioners' Serivce" organised on 3.10.2016 a query was made on requirement of Special Seal Authority for crediting Medical Allowance at the enhanced rate based on Orders issued by DP&PW from time to time. In this context, attention is invited to para 4.5.2 (copy of the extract attached) of Accounting and Operating Procedure for Central Pension Processing Centre of Authorised Banks for Pension Disbursement to Central Government (Civil) Pensioners issued in Feb, 2012 wherein it has been provided that CPPC

should have direct access to the website of the Department of Pensions & Pensioners Welfare and Ministry of Home Affair, so that these are regularly browsed and Orders on Dearness Relief issued by various Departments are acted upon immediately.

CPPCs of all the banks are advised to follow the same instructions for revising the Medical Allowance of the Pensioners already drawing the same as and when the rate of Medical Allowance is enhanced by DP&PW without requiring for any Special Seal Authority from CPAO.

K P&TPA urges CPMG, Karnataka to instruct Post offices to ensure hassle free disbursement of pension on 30-11-2016 & 31-12-2016

Extract of the letter

To The Chief Postmaster General, Karnataka Circle, Palace Road, Bangalore-560001 Respected Madam,

Subject: Disbursement of pension through Post Office Savings Bank to P&T Pensioners on 30-11-2016 & 31-12-2016

Reference: CPMG, Bangalore letter No. CPT/BGW/15 dated 30-3-2015

We wish to invite your kind reference to the letter from CPMG, Karnataka cited above, wherein all Head Post Offices were instructed to open special /additional counters on the last working day of the month for disbursement of pension to P&T Pensioners and that special attention should be given to disburse pension on time.

The above said instructions were issued in response to our request vide our letter dated 23-3-2015, in which we had brought to the notice of the CPMG the difficulties faced by P&T Pensioners in getting their pension on the last working day of the month due to non opening of "special counters" in some post offices for disbursement of pension on the pension disbursement day, which forced them to stand in long queues before the SB counters to get their pension. Pensioners in their advanced age 80+, who could not withstand the strain caused due to waiting in long queues for hours on suffered a lot as they had to jostle with others standing in the general queue.

Some Members of our Association have informed us that despite the above stated instructions, special counters are not opened

on pension disbursement days in some post offices and they are forced to stand in the general queues to get their pension.

We, therefore, urge that the instructions on opening of special/additional counters for disbursement of pension on the last working day of the month may kindly be caused to be reiterated for strict compliance especially in view of the present situation prevailing in almost all the Post Offices in the Circle where long queues of general public are being seen for exchange of demonetised currency notes. It is requested that instructions may also be caused to be issued to all post offices to ensure hassle free disbursement of pension to P&T Pensioners, especially on 30-11-2016 & 31-12-2016 in view of expected heavy rush at the PO Counters on those dates and also to keep adequate stock of lower denominations of currency notes at the pension disbursing counters so as to accommodate the requests of Pensioners.

Extension of time limit for submission of "Life Certificate"

Press Information Bureau Government of India, Ministry of Finance, dated 14th November, 2016

The Prime Minister Shri Narendra Modi reviewed the position regarding the supply and availability of currency notes yesterday late evening and took certain decisions to further activate the dispensary of cash through the networks of Banking Correspondents (BCs), Post Offices, ATMs, Banks and E-payment systems

The Prime Minister Shri Narendra Modi reviewed the supply and avilability of currency notes yesterday late evening 13.11.2016. The meeting went on till past midnight. It was attended among others by the Union Minister of Home. Shri Rajnath Singh, the Union Minister for Finance and Corporate Affairs, Shri Arun Jaitely, Union Development and I&B Minister, Shri M. Venkaiah Naidu, MoS (Independent Charge) for Coal & Power, Shri Piyush Goyal and MoS (Finance). Shri Santosh Kumar Gangwar. It was also attended by the Governor and Deputy Governor of Reserve Bank of India, all Secretaries of the Ministry of Finance and senior officials from the PMO.

The Meeting took stock of the current status of supply of cash and took certain decisions to further activate the dispensing of cash through the networks of Banking Correpsondents, Post Offices, ATMs, Banks and E-payment systems. Following decisions were also taken keeping in view the convenience of the public.

Postal Network:

There are about 1.3 lakh Branch Post Offices in the country. It has been decided to enhance the supply of cash to Branch Post Offices to facilitate cash witdrawals from Postal Accounts

It may be noted that with 1.2 lakh BCs and 1.3 lakh branch Post Offices getting further activated, a total number of 2.5 lakh points in rural areas will be available to disburse cash and facilitate cash withdrawals from Bank Accounts.

Arrangements for publich convenience:

Banks have bee advised to arrange separate queues in their branches for senior citizens and divyang persons customers for transactions against accounts held with the Bank, and exchange of notes. There will, therefore be, three or more separate queues in every branch.

Pensioners are required to submit Annual Life Certificate during the month of November. This time limit has been extended up to 15th January, 2017.

Pensioner ID Card

Issue of Pensioners' Identity Card to pensioners

Gol, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners Welfare, O.M.No. 41/21/2000-P&PW-(D) dated 26th October, 2016.

The undersigned is directed to say that instructions for issue of Identity Card to Pensioners have been issued from time to time. In this Department's OM of even numbers dated 25.7.2013, it was inter alia mentioned that it would not be necessary to have the National Emblem on the Identity Card of Pensioners.

2. The matter has been reconsidered in consultation with the Ministry of Home Affairs keeping in view the provisions of State Emblem of India (Regulation of Use) Rule, 2007, Ministry of Home Affairs have indicated that they have no objection to the issue of Identity Card to retired Government personnel/pensioners with State emblem. The instructions/clarificatins issued by

this Department's OM in this regard stand modified to this extent.

3. All Ministries/Departments are requested to keep the above in view while issuing Identity Cards to Pensioners who retired from the Central Government Civil Service. This provision will not be applicable in respect of the Pensioners retired from the Autonomous Bodies etc. Such autonomous bodies can, however, use their own logo on the Identity Cards, in accordance with the relevant instructions.
