7th CPC -Update

Shri S C Maheswari, Secretary General, Bharat Pensioners Samaj, New Delhi has informed us that the report **submitted to the government** by the Committee constituted to examine the feasibility of implementation of option-1 on revision of pension of pre 2016 pensioners recommended by the 7th CPC, has been accepted with the Finance Ministry's approval and Order from DoP&PW is likely to be issued soon as learnt from a reliable source.

We invite the kind attention of our readers

to the report on the proceedings of the meeting of the Committee with Pensioners' Associations held on 5-10-2016 published in October 2016 issue of our Journal Pensioners' Champion, in which we have given details of the new formula suggested by the Committee for computation of revised pension of pre 2016 pensioners instead of under option -1 recommended by 7th CPC. We had also furnished with the report some examples on revision of pension based on the suggestion of the Committee.

Govt to roll out Rs 5,000 crore package for pensioners

New Delhi:

The government is set to clear a Rs 5,000 crore package for pensioners after Sunday's municipal elections in the National Capital to address their concerns related to the award of the 7th pay commission for Central government employees and seniors.

The revision of pension will be taken up by the Union Cabinet along with threefour issues related to the pay of Central government employees, even as a committee headed by Finance Secretary Ashok Lavasa finalises its recommendations for allowances for government employees, including an increase in the House Rent Allowance (HRA). The panel is expected to submit its recommendations next week but there are indications that the change in allowances may not take place immediately.

"The revised pension scheme has been finalised and the Centre has postponed a decision due to the code of conduct for Delhi municipal elections. The Cabinet may clear it next week," said a source, who did not wish to be identified. The pay panel had recommended an increment linked pension formula along with the option for multiplying the pension based on the six pay commission's recommendations by 2.57. The government opted for the second option as the increment-linked pension model was seen to be difficult to implement. This has created a situation where those who retired by December 31, 2015 are receiving a lower pension compared to someone who retired a month later. For instance, someone who retired as a Secretary before January 2016 is getting a pension of Rs 1.02 lakh compared to Rs 1.12 lakh for someone who retired at the end of the month.

Grant of MACP ignoring promotion earned through Departmental competitive examination

National Federation of Postal Employees (NFPE) requests Department of Posts to extend the Orders of CAT, Madras to similarly placed officials

Sub: - Grant of MACP ignoring promotion earned through Departmental competitive examination.

Ref: - Date. No. 2-19/2015-PCC dated 01.03.20417.

Sir.

Your kind attention is invited towards Directorate letter No. referred above under which instructions were issued to Chief PMG Tamilnadu Circle to grant MACP III to Sri. D. Siva Kumar Retd. SPM, Madras Medical College SO, Chennai ignoring his promotion earned through Departmental competitive examination based on the judgment given by Hon'ble Madras Tribunal in case No.1088/2011 vide order dated 14.03.2013 which was upheld by Supreme Court of India vide order in SLP No. 4848/2016 dated 16.08.2016.

As you are aware, in Department of Post about 50% of employees who come through various departmental competitive examinations do not get the benefit of 3rd MACP as the promotion earned through departmental competitive examination is counted as one MACP.

It is therefore requested to kindly cause issue of suitable instructions according to this verdict of Supreme Court, so that all similarly placed officials may get the benefit of CAT order.

Reimbursement of medical charges without voucher restored

BSNL Corporate Office OM No. BSNL/Asmn.1/15-22/14 dated 11-4-2017

Sub: Reconsideration of extension of without voucher facility to retired employees

Reference: 7-8/2010/EF/Part/1 dated 5-9-2011

Facility of extension of without voucher facility was withdrawn vide guidelines conveyed vide letter No. 7-8/2010/EF/Part/1 dated 5-9-2011, as expenditure control measure. To mitigate the hardship on submission and following up of medical claims by retired employees, the Competent Authority has approved revival of the facility only to retired employees, as per the guidelines issued vide letter No. BSNL/ADMN/1 dated 28-2-2003 under para 2.1.1

The entitlement under this option will be 50% of the admissible amount (annual outdoor ceiling prescribed) and will be paid on four equal instalments at the end of each quarter. The amount payable is taxable as per the applicable Rules

The decision will however be reviewed after 6 months

Grant of Dearness Relief to Central Government pensioners/family pensioners Revised rate effective from 1.1.2017

O.M.No. F.No. 42/15/2016-P&PW(G) Gol, Ministry of Personnel, Public Grievances & Pensions Department of Pension & Pensioners' Welfare dated 7th April, 2017.

The undersigned is directed to refer to this Department's OM No. 42/15/2016-P&PW(G) dated 16th Nov. 2016 on the subject mentioned above and to state that the President is pleased to decide the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 2% to 4% w.e.f. 1.1.2017.

- 2. These orders apply to (i) Civilian Central Government Pensioners/Family Pensioners (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners/Family pensioners (v) Pensioners who are in receipt of provisional pension.
- 3. These orders shall not be applicable on following categories.
- (i) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Pakistan who are Indian Nationals but receiving pension on behalf of Government of Pakistan and are in receipt of adhoc ex-gratia allowance.
- (ii) Central Government Employees who had drawn lump-sum amount on absorption in a PSU/Autonomous Body and are in receipt of 1/3rd resorted commuted portion of pension.
- (iii) CPF beneficiaries, their widows and eligible children who are in receipt of ex-gratia payment in terms of this Department's OM No. 45/52/97-P&PW(E) dated 16.12.1997 and revised vide this Department's OM 1/10/2012-P&PW(E) dated 27.6.2013.

Separate orders will be issued in respect of the above categories.

4. Payment of DR involving a fraction of a rupee shall be rounded off to the next higher rupee.

- 5. Other provisions governing grant of DR in respect of employed family pensioners and reemployed Central Government pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW(G) dated 9th July, 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 6. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 7. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individuals case.
- 8. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-1A, II/34-80-II dated 23.4.1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 9. In their application to the pensioners/family pensioners belonging to Indian Audit and Accounts Department, there orders issue after consultation with the C&AG.
- 10. This issues with the concurrence of Ministry of Finance, Department of Expenditure vide their OM No. 1.3.2017-E II(B) dated 30th March, 2017.
