7th CPC

Increase in 7th CPC Minimum Pay & Fitment Factor not under consideration of the Government – Minister's reply in Rajya Sabha

Since several months the print media has been repeatedly carrying a news item in its publications that the govt may increase the 7th CPC Minimum Pay and Fitment Factor. But the speculation about the hike stands proved incorrect with the government's reply to a question on the subject in the Rajya Sabha given by the MoS, Finance. Q & A extracted hereunder.

INCREASE IN MINIMUM PAY AND FITMENT FACTOR

Government of India Ministry of Finance Rajya Sabha

Shri Neeraj Shekhar: Will the Minister of FINANCE be pleased to state?

- (a) Whether Government is actively contemplating to increase minimum pay from 18,000/- to 21,000/- and fitment factor from 2.57 to 3, in view of resentment among Central Government employees over historically lowest increase in pay by 7th Central Pay Commission (CPC);
- (b) if so, the details thereof and the date from which it would be implemented; and
- (c) if not, the reasons for the callous attitude of Government towards Government Employees?

ANSWER

Minister of State for Finance (Shri P Radhakrishnan)

(a),(b)&(c): The minimum pay of Rs.18,000/- p.m. and fitment factor of 2.57 are based on the specific recommendations of the 7th Central Pay Commission in the light of the relevant factors taken into account by it. Therefore, no change therein is at present under consideration Source: http://rajyasabha.nic.in/

7th CPC – Revised PPOs

Central Pension Accounting Office (CPAO), New Delhi, is transmitting the revised pension payment authorities to the pension disbursing banks on line. Hence hard copies of the RPPOs are not being received by the pensioners. CPAO has developed a mobile responsive facility for use of pensioners for availing of various services. Download Facility of Pension/Revision Orders Sent To Banks: Pensioners can download Pension/Revision Orders sent to Banks.

CGHS Circular

O.M. F. No.19-3/1/2014-Admn/6641 Date: 22/12/2017

The undersigned has been receiving complaints regarding problems faced by CGHS and other Central Government beneficiaries while availing health care facilities from empanelled Health Care Organisations (HCO's). The Central Government Employees Welfare Co-ordination Committee has also raised serious concerns over issues like refusal of admission/beds, refusal of credit, not charging as per CGHS rates, non application of CGHS rates to Central Government beneficiaries covered under other schemes like CSMA, BSNL MRS and other schemes run by central autonomous bodies.

Hence, the provisions as per the terms of agreement with HCO's, are being reiterated in order to streamline availing care from empanelled HCO's.

- The empanelled hospitals shall not refuse beds/admission to any of the central govt beneficiaries and it is agreed that CGHS beneficiaries shall be attended to on priority.
- The hospitals shall provide cashless/ credit facilities to pensioners and other categories of CGHS beneficiaries on referral and in emergency. The cashless facility is also available for serving central govt CGHS beneficiaries during emergency.
- 3. The hospitals shall admit the beneficiary in the ward as per his or her entitlement.
- The hospital shall not collect any money towards any essential treatments which includes medicines, investigations, consumables, consultations, equipments etc., from the credit entitled beneficiaries.
- During emergencies hospitals shall not refuse treatment. If a required facility is not available then hospital shall stabilise the beneficiary before transferring to another CGHS empanelled hospital.
- The hospital has to charge as per the approved CGHS rates for all central

- government beneficiaries including CGHS, CSMA and other autonomous body beneficiaries. The approved rate for a procedure is the "CGHS rate or the actual hospital rate whichever is lower."
- The hospital/diagnostic centres shall charge CGHS rates to Central Government Employees/ Pensioners on production of valid I-Card/ Documentary proof, even though treatment is not sought as CGHS beneficiary.
- Hospitals shall perform annual health examination of the beneficiaries as per the MOA at approved rates.
- All the coded investigations and procedures shall be performed based on prescription slip/ OPD notes issued by CGHS or any other govt specialist. Coded investigations and procedures are those which find a mention in the CGHS rate list and for which CGHS rates are mentioned in the rate list.
- 10. The "CGHS Package Rate" shall mean all inclusive - including lump sum cost of inpatient treatment / day care / diagnostic procedure for which a CGHS beneficiary has been permitted by the competent authority or for treatment under emergency from the time of admission to the time of discharge including (but not limited to) - (i) Registration charges, (ii) Admission charges, (iii) Accommodation charges including patients diet, (iv) Operation charges, (v) Injection charges, (vi) Dressing charges, (vii)Doctor / consultant visit charges, (viii) ICU / ICCU charges, (ix) Monitoring charges, (x) Transfusion charges and Blood processing charges, (xi) Pre Aesthetic check-up and Anaesthesia charges, (xii) Operation theatre charges, (xiii) Procedural charges / surgeon's fee, (xiv) Cost of surgical disposables and all sundries used during hospitalization, (xv) Cost of medicines and consumables, (xvi) Related routine and essential investigations, (xvii) Physiotherapy

- charges etc., (xviii) Nursing care charges etc., The cost of Implants / stents / grafts is reimbursable in addition to package as per the CGHS ceiling rate or the actual rate (as per invoice) whichever is lower.
- All investigations regarding fitness for the surgery will be done prior to the admission for any elective procedure and are part of package.
- The HCO's shall administer the medications/injections issued by CGHS (if any).
- 13. The items like toiletries, sanitary napkins, talcum powders and mouth fresheners are inadmissible for reimbursement.
- 14. The heads of various central government offices /departments are authorised to seek clarification from HCO's on problems being faced by beneficiaries / inspect the hospital premises.
- 15. It shall be the duty and responsibility of the empanelled HCO, at all times, to obtain, maintain and sustain the valid registration, recognition and high quality and standard of its services and healthcare and to have all statutory / mandatory licenses, permits or approvals of the concerned authorities under or as per the existing laws".
- The hospitals are required to display the CGHS rates of following common procedures at prominent places within the hospital premises.
 - * Balloon coronary Angioplasty/PTCA
 * CABG * Total Knee Joint Replacement
 * Total Hip Joint Replacement * Normal
 delivery with or without episiotomy &
 perineal repair * Caesarean section
 *Laparoscopic Cholecystectomy
 *Laparoscopic appendectomy
 *Transurethral Resection of Prostate
 (TURP) * Phaco with foldable IOL.
- 17. Hospital shall display at the reception and at other prominent places within the hospital, regarding:
- availability of cashless facility to CGHS pensioners, Ex-Members of Parliament, Sitting Members of Parliament, Freedom Fighters, Serving CGHS/DGHS / Ministry of H&FW employees and such other

- categories of CGHS cardholders as notified by the Government etc., on referral and in emergency.
- b. Availability of cashless facility to even the CGHS serving beneficiaries during emergency (where obtaining prior permission/referral is not possible).
- 18. The hospitals shall not collect any advance amount from any of the central govt. beneficiaries.
- 19. Hospital shall display the names of 2 Nodal Officers along with their telephone contact numbers at the reception counters and at other prominent places within hospitals. Hospitals shall ensure that the nodal officers are always trained in CGHS procedures to ensure smooth delivery of care to CGHS beneficiaries. Any change in nodal officers shall be immediately informed to CGHS.
- 20. HCO's shall provide electronic platforms for accepting payments through electronic modes and accept digital payments.
- 21. The empanelled HCOs are to sign up as convergence partners by registering themselves on the "consumerhelpline.gov.in" portal. So that the consumer complaints shall also be directly dealt by Consumer help line.
- 22. Violations of the provisions of the MOA by the empanelled HCO's under CGHS like refusal of service, undertaking unnecessary procedures, prescribing unnecessary drugs/tests, over billing, reduction in staff/ infrastructure/ equipment etc. After the hospital has been empanelled, refusal of credit to eligible beneficiaries and direct charging from them, if not recommended by NABH/NABL/ QCI at any stage, discrimination against CGHS beneficiaries vis-a-vis general patients etc, shall be viewed very seriously. The amount of Performance Bank Guarantee will be forfeited and the CGHS shall have the right to de-recognize the health Care Organization as the case may be. Such action could be initiated on the basis of a complaint, medical audit or inspections carried out by CGHS teams at random. The decision of the CGHS will be final.

Senior Citizens of Karnataka aged 60 years and above have been extended 25% concession in ticket fare of KSRTC's City, Suburban, Ordinary, Express, Super Deluxe and Rajahamsa buses.

To avail this concession facility, it has been decided to stop issue of Senior Citizens Identity card by KSRTC.

Senior Citizens of Karnataka can avail the concession by production of any one of the following ID cards.(1) Pass port (2)Voter I D (3) Aadhaar Card with date of birth (4) Driving license (5) ID cards indicating date of birth & residential address issued by various Departments of Government of India/PSU/Govt of Karnataka / PSU/Corporations(6) ID card issued by Physically challenged& Senior Citizens Welfare Directorate and (7) Senior Citizens Card issued by KSRTC

Merger of 33 P&T Dispensaries with CGHS

Dear Comrade,

As you are aware that in 1977 the outdoor medical services from Postal dispensaries were made available to the pensioners of DoPosts/Telcom). We took up with the DoPosts to provide indoor facilities also alike CGHS, but nothing could be done. From August, 2013, through our efforts 19 postal dispensaries of 12 cities were merged with CGHS. For the remaining 33 postal dispensaries at Guntur, Rajmudry, Nellore, Vijawada, Vishakhapatnam(AP), Dibrugarh, Silchar (Assam), Chappra, Darbhanga, Gaya, Muzaffarpur(Bihar), Raipur (Chgarh), Vadodara(Guj),Ambala (Har), Dhanbad (Jhar), Behrampur, Cuttuck(Odisha), Amritsar, Jhallandhar(Pun), Ajmer, Kota, Jodhpur (Raj), Tiruchirapalli Tirunalvelli(TN), Agra, Aligarh, Bareilly, Gorakhpur, Moradabad, Saharanpur, Varanasi(UP) Jalpaiguri and Siliguri (WB), I along with J.P. Sharma of Kota and one pensioner from Jodhpur met the VII CPC members headed by Justice A.K. Mathur at Jodhpur in Dec., 2014 and presented the case of merger of these dispensaries with CGHS, as a result of which the Commission recommended it. Later on we pursued the case with MoH&FW from where we received a reply that the Dte is DILIGENTLY working on the issue and that it is expected to get approval of the competent authority very soon. Office Memorandum

Clarification regarding demarcation of CGHS covered areas under CGHS Wellness Centre

With reference to the above subject the undersigned is directed to state that in some of the CGHS Cities the areas covered under CGHS were not specified resulting in inconvenience to the beneficiaries. The matter has been reviewed and it is now decided that hereinafter the coverage of CGHS shall be limited to the areas within 5 km (approx) radius of the CGHS Wellness Centres, in all CGHS covered Cities where such demarcations were not specified. The Additional Director, CGHS

concerned City shall notify such areas covered under CGHS Wellness Centres.

The serving Central Government employees residing outside the CGHS covered areas shall be covered under CS (MA) Rules. However, in all CGHS covered cities the serving Central Government employees residing within the Muncipal limits of the city, shall be given a onetime choice to opt for CGHS (instead of CS(MA) Rules) from the nearest CGHS Wellness Centre.

Railways Order

Removal of age limit of 25 years of medical facilities for dependent children of serving Railways employees and pensioners.

(Corrigendum)

Guidelines were issued vide letter No. 2000/H/PNM-AIRF dated 5.9.2000 elaborating/amending Para 601 (5) and 601 (6) of IRMM, 2000 defining "Family Members" for the purpose of medical facilities for dependent children of serving Railway Employees and Pensioners. In the instructions, provision pertaining to son read as under:

- (i) Sons under 21 years of age provided they are wholly dependent on the Railway employee; and
- (ii) Sons over 21 years of age without an upper age limit, even if not a student or invalid, provided he is wholly dependent on and resides with the Railway employee
- 2. The above provisions were amended/modified with the issue of corrigendum vide letter under reference as under: "Unmarried sons over 21 years of age without an upper age limit, even if not a student or invalid, provided he is wholly dependent on and resides with the Railway employee". It has, however, come to notice that the corrigendum was issued without obtaining financial concurrence.
- 3. The matter regarding obtaining of financial concurrence was taken up with Finance Directorate of this Ministry and post-facto financial concurrence to the corrigendum issued vide letter of even number dated 16.2.2009 is hereby accorded.

Coffee Board Pensioners are on "DHARNA" demanding extension of 7th CPC benefits

Aggrieved by the inordinate delay in implementation of the orders contained in Department of Pension and Pensioners' Welfare OM dated 6.4.2016 delinking of 33 years of service for fixation of pension in respect of pre-2006 pensioners and extension of 7th Central Pay Commission benefits to pre-2016 pensioners, Coffee Board pensioners, lead by their Association's President Sri A.N.Balaram and Secretary, Sri T.V.Suryaprakash, commenced a"DHARNA" on 23-4-2018 in the premises of Coffee Board building, in Bengaluru, to draw the attention of the Authorities concerned in the Department of Commerce and in the Coffee Board. The Association's President, 93 years old Shri Balaram, would sit on a "HUNGER STRIKE on 1-5-2018, if the demands of Coffee Board pensioners are not met by the government before 29-4-2018, the date on which the present week long "Dharna" would end.

From KP&TPA, S/s K B Krishna Rao, Secretary, B. L. Channappa, V.Murugan & B.S.Ramachandra EC Members participated in the Dharna on 23-4-2018. Krishna Rao addressed the gathering.

Sri S Radhakrishna, Secretary, IA&AD Pensioners' Association, Shri Ashok Kololgi Secretary KCGPA, Shri K U M Rao, Secretary KVS Pensioners' Association and Representatives from other Pensioners' Associations also spoke in support of the demands of the pensioners of Coffee Board.

Karnataka P&T Pensioners Association expressing its solidarity to the CB Pensioners, had written a letter to the Secretary, Coffee Board on 19-4-2018 urging for immediate necessary action to redress the grievances of CB pensioners so as to ensure that the pensioners, most of whom are aged 70 +, are not forced to sit in week long agitation to press for settlement of their demands.

CCCCGPA, Karnataka, IA&AD Pensioners' Association, and KCGPA also addressed similar letters to the Secretary, Coffee Board.

K P&T PA letter dated 19-4-2018 is reproduced below.

Subject: Inordinate delay in implementation of the 7 th Central Pay Commission benefits and provisions of orders contained in Department of Pension and Pensioners' Welfare OM dated 6.4.2016 delinking of 33 years of service for fixation of pension in respect of pensioners of Coffee Board

Coffee Board Pensioners' Association, Bangalore, a sister pensioners association, an affiliate of the Coordination Committee of Central Government Pensioners' Associations. Karnataka of which, Karnataka P&T Pensioners Association is also an affiliate, has informed us that the provisions contained in the office memorandum dated 6-4-2016 of Department of Pension and Pensioners' Welfare under which 33 years of service for fixation of pension at 50 % of the last pay drawn was delinked, has not yet been extended to pre-2006 pensioners of Coffee Board, despite issuance of instructions by the Ministry of Commerce, Department of Commerce, vide its letter dated 2.1.2018 addressed to the Coffee Board. Several representations made to the Coffee Board by Coffee Board Pensioners Association and by CCCGPA, Karnataka were of no avail.

2. Further, we have also been informed that the 7th Central Pay Commission benefits in terms of Gol, Ministry of Public Grievances and

- Pensions, Department of Pension & Pensioners' OMs dated 4.8.2016 and 12.5.2017 have not yet been extended to the pensioners of Coffee Board though those benefits have already been granted to pensioners of Central Government and pensioner of a few Autonomous Bodies like CSIR, ICAR, Central Power Research Institute, Central Silk Board, The Khadhi and Village Industries Commission, Coir Board, Bureau of Indian Standards, Indian Council of Medical Research, etc.
- 3. Department of Expenditure of Ministry of Finance, in response to many representations submitted to it by several pensioners' organisations and service unions, has repeatedly instructed the concerned Administrative Ministries to take appropriate decision regarding extension of 7th CPC benefits to the pensioners of the Autonomous bodies functioning under their administrative control. But, in spite of guidelines issued by the Finance Ministry,7th CPC benefits have not been extended to pre-2016 pensioners of Coffee Board, even after elapse of 20 months from extension the benefits to Central Pensioners.
- 4. Coffee Board Pensioners Association, aggrieved by the apathy shown by all the concerned authorities in extension of 7th CPC benefits to pre -2016 pensioners and implementation of DOPPW OM dated 6-4-2016 to pre-2006 pensioners, left with no other option, has decided to embark upon an agitation to draw the attention of the authorities, in spite of the fact that most of its members are in their advanced age. Members of the association would commence an indefinite day long DHARNA from 23/4/2018 in the premises of Coffee Board Bengaluru if their twin demands are not met by then.
- 5. Karnataka P&T Pensioners' Association, expressing its solidarity to the legitimate demands of Coffee Board Pensioners, urges upon your kind self to take immediate necessary action to redress their grievances so as to ensure that the C B pensioners, most of whom are aged 70 +, are not forced to sit in day long agitation to press for settlement of their demands.

Stoppage of Cash Disbursement to Defence Pensioners.

O/o the Principal Controller of Defence Accounts, Allahabad

Circular No. 198 No. AT/Tech/30-XIX Dated: 30.01.2018 Stoppage of Cash Disbursement to Defence Pensioners.

As per existing provisions, disbursement of defence pension should be made by crediting the amount of pension to bank account of pensioners. However, it is noticed that some PDAs (other than banks) are still making payment of defence pension through cash disbursement.

Cash Disbursement by the Pension Disbursement Authorities has been viewed seriously by the Ministry and it has been strongly recommended that the cash disbursement of pension should be stopped immediately and same should be credited to pensioner's bank account with immediate effect.

In view of the above, all the PDAs are advised to suggest their defence pensioner who are receiving defence pension in cash from them, to open bank account in authorized Banks and payment of defence pension be credited to that account only.

All the Pension Disbursement Authorities are further advised to ensure that no cash disbursement of defence pension is made by them.

Common mistakes by PAOs in processing of Revision of Pension under 7th CPC.

7th CPC Pension Revision cases are to be settled in a time bound manner. This office is receiving more than 3000 pension revision cases on daily basis. However, it has been observed that about 5 to 10 percent cases are returned by this office to PAOS due to various discrepancies. The reasons to return are indicated by this office in each case. To facilitate the PAOs, a list of common mistakes made by PAOs has been prepared and enclosed herewith at Annexure-A.

In view of above all the PAOs are requested to ensure that 7th CPC revision cases are sent correctly to CPAO to speed up the processing of the same in a time bound manner.
