General Budget 2019-20

Changes in Income tax which will come in to effect from 1st April 2019 [Financial year 2019 – 20 Assessment year 2020-21]

The Interim Budget 2019 presented in the Parliament on 1st February 2019 offered a number of steps that could help reduce the tax burden on senior citizens. While the Finance Minister did not announce any changes to the income tax slabs for senior citizens and super senior citizens, he did announce measures that senior citizens could use to reduce their tax liabilities.

Along with the proposed move to remove income tax for those with income below Rs 5 lakh, F M pointed out that deductions of medical expenditure on senior citizens could be used to bring the taxable income below the Rs 5 lakh threshold. Mentioned below are some of the changes proposed to be introduced in Income tax for financial year 2019-20, Assessment year 2020-21.

- Existing rates of income tax to continue
- Income up to Rs. 5 lakh exempted from Income Tax
- Individual taxpayers having taxable annual income up to Rs.5 lakhs will get full tax rebate and therefore will not be required to pay any income tax
 said the Finance Minister in his speech
- Standard deduction increased from Rs 40,000 to Rs 50,000
- TDS threshold on interest earned from bank and post office deposits raised from the present Rs.10,000 to Rs.40,000.
- TDS threshold for income from rent raised from the present Rs 1.8 lakh to Rs 2.4 lakh per annum.

- Tax exempted on notional rent on a second self-occupied house
- Benefit of rollover of capital gains increased from investment in one residential house to two residential houses for capital gains up to Rs. 2 crore.
- The maximum amount of tax rebate under section 87A of the Income Tax Act to increase from the existing Rs.2,500 to Rs. 12,500. This proposed tax rebate will be admissible to
- taxpayers having total income up to Rs 5 lakh instead of current Rs 3.5 lakh
- FM stated that "because of major tax reforms undertaken during last four and half years, both tax collections as well as tax base have shown significant increase, achieving a moderate taxation- high compliance regime. It is, therefore, just and fair that some benefits from the tax reforms must also be passed on to the middle class taxpayers"

Income Tax Slab Rates FY 2019-20 (AY 2020-21)

(Currently for the financial year 2018-19 income up to Rs 2.5 lakh for resident individuals (age below 60 years) is exempt from tax. Similarly, for senior citizens aged 60 years and above but below 80 years, income up to Rs 3 lakh is exempt from tax. Income up to Rs 5 lakh is exempt from tax for super senior citizens (age 80 years and above).

The amount of income-tax as mentioned in points (I) to (III) and as increased by the applicable surcharge shall be further increased by an additional surcharge named "**Health and Education Cess on income-tax**" calculated @ 4% i.e. calculated on Basic tax+Surcharge

DR Order Gol, Ministry of Personnel, Public Grievances & Pensions, Department of Pension and Pensioners' Welfare OM No. 42/04/2019-P&PW(D) Dated the 6th March,2019

Grant of Dearness Relief to Central Government pensioners/

The undersigned is directed to refer to this Department's OM No. 42/0612018-P&PW(G) dated 18.09.2018 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 9% to 12% w.e.f 01.01.2019.

- 2. These rates of DR will be applicable to (i) Civilian Central Government Pensioners/ Family Pensioners including Central Govt. absorbee pensioners in PSU/ Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/ 2002-P&PW(D) Vol.1I dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners/family pensioners (v) Pensioners who are in receipt of provisional pension (vi) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(I3) dated 11.09.2017.
- 3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension/family pension of March, 2019.
- 5. Other provisions governing grant of DR in respect of employed family pensioners and reemployed Central Government Pensioners will be regulated in accordance with the provisions

contained in this Department's OM No. 45173/97-P&PW (G) dated 2.7.1999, as amended vide this Department's OM No. F.No. 38/88/2008-P&PW(G) dated 9 th July, 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.

- 6. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately
- 7. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 8. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, IV34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 9. In their application to the pensioners/family pensioners belonging to Indian Audit and Accounts Department, these orders issue after consultation with the C&AG.
- 10. This issues in accordance with Ministry of Finance, Department of Expenditure's OM No. 11112019-E.II(B) dated 27th Feb, 2019.

Pension Adalat Secretary and Joint Secretary, K P&T PA on invitation attended Pension Adalat at the O/o the Chief Postmaster General Karnataka Circle, Bangalore on 15.3.19 at 11a.m. and brought to the notice of the respected CPMG the following issues.

1. Compendium on Pension, CGHS and Medical facilities for Central Govt and BSNL Pensioners published by K P&T PA.

We requested that the purchase of compendium from our association by Postal Divisions for being presented to the employees on the day of their retirement may be continued as before. CPMG agreed to our request and ordered issuance of instructions to all Heads of Postal divisions to continue to buy the books from us and present it to the employees on the date of their retirement as before.

- 2. Abnormal delay in implementation of the orders issued for counting induction training for financial up gradation under TBOP& BCR schemes – revision of pay and pensionery benefits
- 3. Re-fixation of pay of Postman & Mail guards from 1.1.1996 on notional basis from 1.1.1996 and consequent revision of pensionery benefits.

After discussions CPMG said that necessary instructions will be issued for expediting the matters at 2 & 3 above.

4. Furnishing information to pensioners regarding the deductions made from their pension amount.

Senior Accounts officer from the O/o GM. Postal Accounts and Finance was

requested to invariably inform the Pensioners whenever any amount is recovered from their pension. The Officer informed that the deductions are made by the DDOs and Postal Accounts will not come to know the details unless DDOs furnished all the details. KP&TPA suggested that the details of deductions must also be furnished through SMS along with details of pension amount credited to S B accounts.

5. Change of procedure in crediting pension to SB accounts of pensioners Pension Payment was Centralised at the O/o the General Manager (Postal Accounts and Finance), Bangalore Consequent on introduction of new core system integration software in the Department of Posts. Consequently, wef 1-10-2018 pension payments are centrally uploaded to the POSB accounts of the pensioners through Bangalore GPO by Postal Accounts. It was brought to the notice of the CPMG that wide publicity was not given about the revised procedure and even pensioners associations were not informed of the change. CPMG said that the Accounts Officer concerned will be asked to explain the new system to the representatives of KP&TPA.

Representatives of KP&TPA thanked the CPMG for favourably responding to the requests.

Dearness Relief

For the attention of DoT Pensioners

Inordinate delay in payment of enhanced Dearness Relief (DR) to DoT pensioners by the State Bank of India

Many pensioners retired from the Department of Telecommunications (DoT) who are members of our association have been frequently complaining that there was inordinate delay in crediting the enhanced dearness relief to their accounts by the State bank of India and payment of arrears thereon. While post offices and other banks ensured payment of the revised rates of DR and arrears within a reasonable time frame on every occasion of revision of rate of DR, the State Bank of India, in spite personal representations, never bothered to address the grievance of DoT pensioners.

K P&T PA was constrained to take up the matter with SBI and wrote to Shri Rajnish Kumar, Chairman, State Bank of India Corporate Centre, Mumbai on 26-11-2018 bringing to the Chairman's notice about the inordinate delay that was being caused since a very long period in crediting the enhanced dearness relief and arrears of dearness relief thereon to the accounts of pensioners, especially those who had retired from the Department of Telecommunications.

We brought to the Chairman's notice that Order issued by Department of Pension & PW on 18-9-2018 revising D R from 7 % to 9% from 1st July 2018 was implemented by CPPC, S B I on 28-11-2018 whereas Post offices paid the revised DR on 29-9-2018 and other banks on 5-10-2018 and requested for the Chairman's personal intervention in the matter since the undue delay in payment of DR had almost become a regular feature with the CPPC, SBI since the past few years, though we had quoted the delay of about 72 days that had occurred in the year 2018 only to bring home our grievance more

explicitly.

In response, we received an email from Sanjay Kumar Mohapatra, Chief Manager (GAD), Corporate Centre, CBD Belapur, Navi Mumbai, Informing us that Dearness Relief (DR) was credited on 28/11/2018 to the pension accounts of DoT pensioners on receipt of a mail from CPPC Mumbai on 17.11.2018 for enhancement of Dearness Relief (DR) to pensioners. The email also sought our cooperation by providing a copy of the order issued by DOP&PW for timely implementation of the orders regarding Dearness Relief (DR) released by Govt of India from time to time so as to avoid delay in payment of enhanced D R to pensioners

While the Association, in response to the request by SBI readily agreed to extend its cooperation solicited by the SBI Corporate Office with a view to ensure that all Central Govt Pensioners drawing their pension from SBI do get their enhanced DR without any undue delay in future on a par with other pensioners drawing their pension from other banks and post offices, also suggested that a permanent mechanism must be evolved by SBI to ensure timely crediting of the enhanced pension and DR to the SB accounts of pensioners within a time frame after issuance of the relevant orders by the Departments of Government of India without waiting for being prompted by someone.

Further it was also brought to the notice of CPPC SBI that General Instructions contained in Reserve Bank of India Master Circular No. RBI/2018-19/1 DGBA.GBD. No.-1/31.02.007/2018-19 July 2, 2018, which inter alia, states with regard to disbursement

of DR that banks should act on the orders hosted on the official websites.

As a follow up action, KP&TPA through an e- mail on 6-3-2019 informed the CPPC,SBI about issuance of orders by DOP&PW on 6-3-2019 granting D R at the enhanced rate of 12% (increase from 9% to 12%) from 1-1-2019 payable in April 2019 and requested that the revised DR may please be caused to be paid preferably with the pension for the

month of March 2019 payable on 1-4-2019. CPPC SBI has, in its reply stated that the enhanced DR will be paid in the first week of April 19.

Members of KP&TPA, who are drawing their pension from SBI are requested to intimate the Secretary the date on which the enhanced DR with arrears was credited to their SB accounts.

Invalid Pension

Gol Ministry of Personnel, Public Grievances & Pensions (Department of Pension & Pensioners' Welfare) OM No. 21/01/2016-P&PW(F) dated 12th February, 2019

Grant of Invalid Pension under Rule 38 of the Central Civil Services (Pension) Rules, 1972— Clarification

The undersigned is directed to say that Rule 38 and Rule 49 of the Central Civil Services (Pension) Rules, 1972 have been amended vide Notification No. 21/1/2016-P&PW(F) dated 4th January, 2019 (copy enclosed). The proviso to the amended Rule 38 of the CCS(Pension) Rules provides that a Government servant who retires from service on account of any bodily or mental infirmity which permanently incapacitates him for the service before completing qualifying service of ten years, may also be granted invalid pension in accordance with sub-rule (2) of rule 49, subject to the conditions that the Government servant:

- a) was examined by the appropriate medical authority either before his appointment or after his appointment to the service or post and was declared fit by that authority for Government service, and
- (b) fulfils all other conditions mentioned in this rule for grant of invalid pension.
- 2. In this connection, it is clarified that the condition of qualifying service of ten years for grant of pension under Rule 49(2) of the CCS (Pension) Rules, 1972 shall not be applicable in the case of a Government servant retiring on Invalid Pension on account of any bodily or mental infirmity, under Rule-38. Accordingly, Invalid Pension at the rate of 50% of emoluments or average emoluments, whichever is more beneficial, subject to a minimum of nine thousand rupees per mensem and maximum of one lakh twenty five thousand rupees per mensem, shall be payable to a Government servant who retires under Rule 38 of CCS (Pension) Rules, 1972 even before completing a qualifying service of ten years.
- 3. All Ministries/Departments are requested that the above clarification may be brought to the notice of Heads of Department, Attached and Subordinate Offices, Controllers of Accounts. Pay & Accounts Offices. etc, under them.
