7th CPC benefits to pensioners of Autonomous bodies & Extension of provisions of DoP&PW OM dated 6-4-2016 to Coffee Board Pensioners.

Saga of a relentless struggle by the pensioners of Autonomous/ Statutory bodies

Pensioners of Autonomous /Statutory Boards, to quote a few, Coffee Board, Tea Board, Rubber Board, Spices Board, Silk Board, KVS, NCCM etc., got their 7th CPC benefits after a great struggle lasting for over 2 and half years. Pensioners' associations of Autonomous bodies, on the initiative taken by Sri A N Balaram, President, CBPA and Sri T.V. Suryaprakash, Secretary, CBPA Secretary, Pensioners' Associations of AB/SB and & Joint General Secretary, CCCGPA Karnataka, commenced the struggle in right earnest in the month of August 2016 immediately after issuance of the O M dated 4.8.2016 by the Department of Pension and Pensioners' Welfare extending the benefits of VII CPC to other Central government pensioners.

Central Ministries and the departments under whose administrative control the Autonomous bodies are functioning didn't show any interest to ensure that AB/SB pensioners also automatically got their legitimate dues on a par with their fellow Central government pensioners as extended to them at the time of implementation of the recommendations of the previous six Central Pay Commissions.

When it was realised that the demands of AB Pensioners were falling on deaf ears, several agitations were planned in Coordination with CCCGPA, Karnataka and Pensioners' Associations of Autonomous bodies. Dharna, hunger strike and demonstrations were conducted at public places and before Board Administrative Offices to draw the attention of the govt. Press meet was also held at the

Bangalore Press Club hoping that the issue would receive the attention that it deserved. Suryaprakash was the architect. Sri A N Balaram, President, A B Pensioners' Association, supported by many pensioners, sat on a day long fast before the Coffee Board Office in Bangalore despite his advanced age of 93 years. The Chairman and General Secretary of CCCGPA, Karnataka and others addressed the pensioners participating in the hunger strike. The government remained unmoved. Sri Suryaprakash intensified the agitation by mobilising Pensioners and their associations not only in Bangalore but in other States also. He, along with the Presidents of AB Pensioners' associations led by Sri A N Balaram, met Central Ministers and MPs seeking their support in the cause of AB Pensioners. The Team made several trips to Kerala, Tamilnadu and Delhi to pursue the issue. Advice and support of veteran Trade union leaders viz. Com N.Bhaskaran, Com KKN Kutty, Com M Krishnan and Com S.Radhakrishna added strength to the movement and helped in achieving the desired result. CCCGPA Karnataka, Confederation of Central government Employees & National Co ordination Committee of Pensioners Associations, and Bharat Pensioners Samaj, New Delhi extended their full support. The Confederation included the subject as one of the items in its charter of demands.

Pursuing the issue further with the Central government, an appointment was sought with the Secretary, Department of Commerce and, on his direction,

representatives of Pensioners' Associations of Autonomous bodies under Department of Commerce met the Joint Secretary, MOC under the leadership of K B Krishna Rao, Chairman, CCCGPA, Karnataka in Sept 2017. The delegation was astounded when, at the commencement of the discussions, the official side raised a doubt as to whether CCS(Pension)Rules1972 were applicable to SB /AB Pensioners. When it was realised that the discussions with the JS, Dept of Commerce were not that encouraging, it was brought to the officer's notice that the benefits of the pay commission extended to the employees of commodity boards have to be invariably extended to pensioners also and any discrimination between the employees and pensioners and denial of the CPC benefits to pensioners of Autonomous bodies would definitely be a violation of the judgement of the Hon'ble Supreme court delivered in the famous "NAKRA CASE". It was also brought to his notice that in respect of BSNL pensioners, the Central government has agreed to bear 100 % of the pension expenditure. It was urged that in respect of AB/SB pensioners also the government must meet the entire expenditure on pension without insisting on the Boards to meet the additional expenditure from their annual grants. A copy of the "Nakra judgement" delivered on 17.12.1982 , a note on codification of provisions relating to pension under Civil Service Regulations in the form Statutory Rules promulgated as CCS(Pension) Rules 1972, a copy of the DoT order on pension liability of BSNL were sent to the Joint Secretary, MoC. As a result of an hour long discussion held in the meeting with the JS, the issue relating to extension of 7th CPC benefits to the pensioners of AB /SB gained some momentum and thereafter was seemed to be looked into with all seriousness.

Finally, when the order was issued in May 2018 by the Commerce department for implementation of VII CPC in respect of Commodity Boards Pensioners, there was

another shock. The effective date was 1.1.2018 instead of 1.1.2016. There was utter discrimination on the one hand, between the employees and pensioners of the same Board, and between pensioners of different Boards on the other, regarding the date of implementation of the VII CPC benefits. So, Suryaprakash and others were forced to continue with their perseverance until the issue was resolved to the satisfaction of all AB Pensioners. However, the focus then shifted from the main problem to the limited issue of "the effective date of implementation".

The struggle had to be continued. Several meetings were held. Memoranda submitted. Emails sent to all concerned. While the pensioners associations were planning to start a fresh programme of agitations, an opportunity knocked at the door. Suryaprakash got an invitation from the Commerce Minister to attend a meeting at his office in Delhi. That invite was in response to an appointment sought with the minister many months ago.

AB Pensioners' Associations could clinch the issue in their meeting with the Commerce Minister in Delhi held on 28.11.2018 and an order was issued in December 2018 changing the date of extension of VII CPC benefits from 1.1.2018 to 1.1.2016. Even after issuance of the order the matter had to be pursued to see to it that the order is immediately implemented and arrears paid before 31.3.19.

Happy to learn that finally AB Pensioners got their VII CPC benefits on par with other Central government Pensioners including the benefits that accrued in terms of DoP&PW OM dated 12.5.2017.

Another issue that was daunting the minds of Coffee Board pensioners only was abnormal delay in extension of the provisions of DoP&PW OM dated 6-4-2016 delinking 33 years of service for computation of pension at 50% of the emoluments in respect of Pre 2006 pensioners who were getting pro rata pension. While pensioners of other Autonomous bodies

were given the benefit that accrued in terms of OM dated 6-4-2016, it was only the Coffee Board pensioners who were denied the benefit. Distraught C.B. Pensioners had to again keep on pursuing the matter with the government. Suryaprakash, the Man Friday of CB Pensioners, who was determined to ensure that pre 2006 Coffee Board pensioners also got the benefit of full pension, continued with his mission and did not rest until the issue was resolved. Department of Commerce finally issued an order on 13-5-2019 directing Coffee Board to pay the arrears of pension in terms of DoP&PW OM dated 6-4-2016 utilising the funds available with the Board under pension fund. Consequently, pensioners of all Statutory/ Autonomous bodies have now got the benefits of 6th and 7th CPCs .

I wish to place on record the relentless efforts made by the Pensioners Associations of all Autonomous bodies under the leadership of its former president Sri A N Balaram and present President Sri Umamaheshwara Rao and congratulate both of them for their success in seeing to it that the AB Pensioners are not

denied the pension revision benefits extended to other Central government pensioners. I am extremely happy to note that all the pensioners of ABs/SBs affiliated to CCCGPA, Karnataka got 6th & 7th CPC benefits without any discrimination.

I would like to specially congratulate Suryaprakash for his perseverance and acumen in pursuing the issues involved after collecting all the relevant documents, in seeking support from other associations, federations and Coordination Committees and above all for not 'leaving any stone unturned' in ensuring resolution of the grievance.

Now Pensioners Associations of ABs/ SBs have shifted their focus towards (a) Extension of CGHS or any other medical facility to their pensioners also on par with CG pensioners (b) Treating pensioners of ABs/SBs on a par with CG pensioners in the matter of granting any further pensionary benefits or medical benefits.

CCCGPA, Karnataka assures its continued support to all affiliate associations.

Email received by the Association from Shri M R V Nath, Member of KP&TPA and Vice President, All India Federation of Pensioners' Association, Chennai, lauding the courteous service extended to him by CGHS Doctors when he needed it most, is reproduced.

Wish to share my pleasant experience with CGHS, Bengaluru. On arrival here after my discharge from a hospital in Chennai, an email was sent to Additional Director, CGHS Bengaluru, requesting for the facility of Doctor's visit to home and supply of post hospitalization medicine. Instant response was received to contact CMO, WC4. Then email was sent to CMO WC4. Based on that, Dr. Nandish WC-4 HBR Layout visited my home at 10:35 hrs. on 1st May'19. He issued available medicines,

raised indent for supply of other medicines and also issued referral memo for review at Bengaluru empanelled hospitals. Thus, the Doctor helped me to avoid my return to Chennai for follow-up treatment and review. Also, essential medicines were promptly procured and supplied to me on priority by 2nd May'19. I was surprised & delighted to see the speed at which CGHS team acted. Immediate response that I got from the Addl Director, M O WC-4 and the Pharmacy Staff was in itself a great relief which definitely helped me in speedy recovery.

Appreciation / Thanks giving mails were sent to AD, CMO-WC4 and pharmacy team of WC 4.

DIGITAL LIFE CERTIFICATE

Submission of Digital Life Certificate from the confines of your home – a pensioner friendly initiative by the Department of Pension and Pensioners' Welfare for pensioners

Our members are aware that the Department of Pension and Pensioners Welfare, New Delhi with a view to facilitate the disabled and aged pensioners of Central Government in submission of their Annual Life Certificate in digital mode through Jeevan Praman portal from the comfort of their homes identified Karnataka P&T Pensioners' Associations and supplied two IRIS enabled devices (Samsung-Galaxy Tab Iris) to assist pensioners in submission of DLC.

Executive Committee Members KP&TPA visited the residences of many senior pensioners who had sought the assistance of the association and ensured submission of their DLC in November 2018.

Department of Pension and Pensioners' Welfare, New Delhi with a view to give a further boost to the initiative taken on a pilot basis in Nov 2018 has, vide its letter dated 16th January 2019 asked us to keep the IRIS enabled device with us for its use in the following manner

1) As the registration of Pensioners for DLC is one time requirement, pensioners who have not submitted DLC in the past may be registered on Jeevan Pramaan in advance.

Once they register themselves with Jeevan Pramaan, they will be able to submit Digital Life Certificate in the month of November without any hassle.

2) Occasions such as Annual General Body Meetings or any other function of the association may be made use of for getting the first-time registration of pensioners on Jeevan Pramaan web site

In compliance of the instructions of the Department of Pension and Pensioners Welfare, KP&TPA will make necessary arrangements in the Annual General Body meeting to be held on 13-7-2019 to register pensioners with Jeevan Pramaan web site to facilitate submission of DLC in November 2019.

Therefore, Pensioners (irrespective of their age) who would like to avail this facility are requested to bring with them to the AGB their (1) Mobile phone (2) Aadhaar Card (3) Pension Payment Order (PPO) and (4) The Bank account details to which their pension is credited which are essential for registration of their names with Jeevan Pramaan website.

Update on the issue : It is reliably learned that the Department of Expenditure, Ministry of Finance has approved corrections to tables 24&25 of the 7th CPC Pay Matrix as required by DoP&PW and the revised concordance tables are under issue.

**NATIONAL
COUNCIL - JCM**

The 47th meeting of the National Council was held on 13.4.2019 at Rail Bhawan, New Delhi, under the Chairmanship of Shri P.K.Sinha, Cabinet Secretary. It was held after a lapse of nine years since the last National Council meeting was convened. The meeting commenced at 11.30AM and ended at 2.30 PM. In the introductory remark, the leader and the Secretary Staff Side touched upon the following points.

1. Survival of JCM; revival of Departmental Councils; maintenance of its stipulated frequency.
2. Increasing litigations; Government's disregard to its own National litigation policy making employees and pensioners to incur huge expenditure. Non implementation of even Supreme Court decisions- MACP promotional hierarchy, MACP date of effect, increment on 30th June and 31st December etc
3. NPS and other pension related issue
4. Non honoring of the assurance held out by the GOM to revisit the minimum wage and fitment formula
5. CGHS deficiencies
6. Necessity of holding meetings by the Secretary Dept of pension with the Staff Side

for Central Government Employees May 16, 2019.**

Feedback of NC JCM meeting with Secretary MoH&FW held on 16th May, 2019 regarding issues related to CGHS, Ward Entitlement, Medical Reimbursement etc.

A meeting with the Staff Side of the National Council JCM under the Chairmanship of Secretary, Ministry of Health & FW was held on 16-5-2019 at Nirman Bhawan, New Delhi. The Staff Side was represented by Comrades Shiva Gopal Mishra, Guman Singh, KKN Kutty, C. Srikumar, M.S. Raja and R. Parashar. The following agenda points were taken up for discussion and the decisions taken are given below.

2	Review of ward entitlement for Central Government Employees	It was agreed to reconsider the wage limit for Ward entitlement and also to streamline the same as per the 7th CPC pay matrix.
