Proceedings of the Annual General Body Meeting of Karnataka Posts and Telecommunications Pensioners' Association held on 13.07.2019

The 24th Annual General Body Meeting of Karnataka Posts and Telecommunications Pensioners' Association was held at NGO Hall, Cubbon Park, Bengaluru on 13.7.2019.

Morning Session:

- 2. The Morning Session of the General Body Meeting started at 9.30 a.m. President of the Association Shri G.Babu declared the AGB open and Shri K.B.Krishna Rao, Secretary, welcomed the gathering.
- 3. Shri Krishna Rao presented the minutes of the last AGB held on 9.9.2018, which had been published in the September 2018 issue of *Pensioners' Champion*. The minutes were confirmed by the House.
- 4. He also presented the Annual report for 2018-19 for consideration and adoption by the House. The Annual Report was published in the April 2019 issue of *Pensioners' Champion* and the Audited Accounts in June 2019 issue. The Secretary read out the salient features and explained some of the points mentioned in the report and the report was adopted. Due to paucity of time, the annual accounts could not be presented in the morning session.

Open Session:

- 5. The open session of the General Body started at 10.30 a.m. with the joint Secretary V.Gopal requesting the Chief Guest Shri D.Balasubramanian, General Secretary, All India Federation of Pensioners Associations, Chennai and the Guest of Honour Dr.Kishore Kumar C.S., Additional Director, CGHS to occupy the chairs on dais. He also invited Dr.Prabhakar, Ophthalmologist, OSD, CGHS, Shri N.Bhaskaran, Permanent Advisor and Shri K K Gangadhara, Kannada Writer to the dais. The other two advisors Shri B.Sadashiva Rao and Shri M.Ramiah were not present.
- 6. Shri K.B.Krishna Rao, Secretary welcomed the gathering to the open session and

- introduced Shri D.Balasubramanian, Chief Guest, Dr.C.S.Kishore Kumar, Guest of Honour and Shri.K.K.Gangadhara. Shri Krishna Rao spoke about the Association entering its 25th year, the contributions of the founders of the association, the successful completion of the construction of association's two buildings in 2012 and 2018, the help of Shri Babu, President, the generous and voluntary contribution of members and non-members, including children and grandchildren of ex-members. He said that donation exceeded Rs.65 lakh, but we still need money for the lift and a big hall on the second floor for holding AGB. He appealed for donations.
- 7. Shri D.Balasubramanian then inaugurated the open session. In his speech, he congratulated KP&TPA for constructing its own buildings and saluted all the members for their generous donations. He said that KP&TPA did what the other Associations could not. He said that Shri S.M.Vittal Rao, during his visits to Channai encouraged AIFPA also to construct its own building. He urged the members to donate further so that lift could be provided and meetings can be held on the second floor. He also appreciated the tireless efforts of KP&TPA in SCOVA, particularly that of Shri K.B.Krishna Rao. He said that the next revision of pension need not be after another ten years. Based on the price index, pension must be revised by 2021. Defence pensioners were granted OROP and Civil pensioners should not be discriminated and there should be complete parity in pension between past and present pensioners. Referring to minimum wage recommended by the 7th CPC, he said that while the demand of the staff side was for a need based minimum pay of Rs.26,000, the CPC recommended a minimum pay of Rs.18,000 only deriving the specifications of food requirement of a worker's family from the recommendations of Dr Wallace Aykroyd,

noted nutritionist referred to as "Aykroyd formula'. Shri Subramanian said that the norms set by the 15th ILC in 1957 recommended wage determination for 3 consumption units of a worker's family, assigning 1 unit for the husband .0.8 unit for the wife and 0.6 unit each for 2 children and therefore the minimum wage determination on 3 consumption units is faulty. Wife being an adult should be assigned one unit and the children also a unit higher than 0.6 units and the minimum wage should be increased to Rs.26, 000 and consequently the minimum pension to Rs.13,000. Continuing with his speech he said that there is an urgent need for unity amongst all pensioners' associations and they should come under one umbrella to pursue our demand for revision of pension every 5 years. Regarding revision of pension of BSNL pensioners, he said that there are two viewpoints. One is to maintain status quo with simultaneous wage &pension revision. Another view is to delink pension revision from wage revision and pension revision with 7th CPC fitment formula. He is hopeful that, now that the dust has settled, the Government will take a decision soon. About his federation, he said that AIFPA was started by a retired Postmaster General who had brought all Departments and cadres together. A United organization of all pensioners is the need of the hour, as pensioners are a homogenous category. He was honoured by Shri. Babu, President. He thanked KP&TPA for inviting him to be the Chief Guest and for honouring him.

8. Dr.C.S.Kishore Kumar, AD, CGHS and the Guest of Honour spoke briefly. He said that though he hesitated to accept the invitation as he is not used to speaking publicly, he feels deeply honoured by the invitation and thanked KP&TPA for the same. He expressed deep concern over the assaults on the doctors that are being reported from all over the country. The main reason is that people nowadays are getting impatient, road rages which occur so frequently can be quoted as examples.

Ambulances are not being given way. Patients are brought in very critical condition and doctors, who are human too, are blamed and assaulted. He said that he leaves it to the people to judge how right it is to attack hospital staff, damage the hospital properties. He also said that CGHS doctors are like family physicians, treating the patients for years. Often patients ask if there are any side effects of the medicines prescribed. Doctors take precaution while prescribing medicines. Consumption of junk food & eatables sold by road side and unhygienic habits like spitting and urinating in public, throwing of garbage etc. also contribute largely for ill health and spread of diseases. Dr. Kishore Kumar was honoured by Shri G Babu President.

Dr.Prabhakar, ophthalmologist, OSD, CGHS spoke about the liberal measures introduced by CGHS recently. He was felicitated by the President.

9. Shri K.K.Gangadhara, Kannada writer, the special invitee, was felicitated by the Association in recognition of his contribution to the Kannada literature during the past 4 decades. He was honoured Shri D.Balasubramanian, the Chief Guest. In his brief speech, laced with wit and humour, he spoke about his earlier days. His entry in to literary field was as a reporter for a local weekly in Kodagu. Later, he commenced translation of literary works from Malayam to Kannada. He continued with his literary work even after joining the Department of Posts. He thanked the Association for honouring him saying that he considers it as very special, since it is done by his old friends.

10. Ten meritorious students of Government Higher Primary School, Yelahanka, Bengaluru were awarded with a cash prize of Rs.1000 each for having secured the first three places in 5th, 6th and 7th standards along with one prize for the highest marks scored in Kannada language in 7th Standard. The envelopes containing the cash were given away by the

Chief Guest, Guest of Honour, President & the Vice President.

- 11. Forty Senior members, who are 75 years and older, were felicitated by Shri Balsubramanian, Shri Babu, Shri Bhaskaran and Shri Krishna Rao. Each of them was garlanded and presented with shawl and fruit basket.
- 12. Shri V.Gopal, Joint Secretary proposed vote of thanks. The Open Session ended at 1.00 p.m.

Afternoon Session:

- 13. As soon as the members reassembled after lunch, Shri Krishna Rao welcomed the members to the afternoon session at 2.30 PM. the Treasurer Sri K R Anantha Ramu presented the audited Annual Accounts for 2018-19. It was published in June 2019 issue of Pensioners' Champion. Sri Sadananda LM 1233 sought some clarifications on the corpus fund indicated in the balance sheet and about registration of the association as a wholly charitable trust under the IT Act. President gave a detailed reply and said that the accounts have been audited by a reputed company of chartered accountants. However, if any further details are required we can always seek them from the auditors. After furnishing the information sought for by some other members, the General Body adopted the annual accounts unanimously.
- 14. The President Shri G.Babu announced the names of the newly elected Executive Committee Members for the period from 2019-22. Shri Krishna Rao said that 4 members of the EC viz. Shri B.L.Channappa. Shri V.Muthukumar, Shri M.Nanjunde Gowda and Shri D.Venkatesalu did not file their nominations for personal reasons, though they were requested to continue. They were felicitated in the meeting by the President. He then introduced the 4 newly elected EC Members, Shri M.Muniyappa, Shri C.Ramakrishna Reddy,

- Smt.N.Nagalakshmi and Shri B.Nagaraju. Group photo was taken with all old and new Executive Committee Members present.
- 15. Shri S.M.Vittal Rao was reelected as the Internal Auditor for 2019-22. M/s GRSM & Associates, chartered accounts were also re appointed as Auditors for 2019-20.
- 16. President read out the agenda and invited Shri K.B.Krishna Rao to start the discussions on the agenda items. Shri Krishna Rao said that most of the PAOs including Autonomous bodies have implemented 7th CPC and there was inordinate delay in implementing 7th CPC in respect of Railways, Defence Civilian pensioners and Pensioners of Autonomous bodies. But BSNL pensioners have not been extended 7th CPC benefits. DoT has informed pensioners' associations that revision of pension can be examined only after revision of pay of BSNL employees. AIBSNLPWA, however, wants pension revision to be delinked from pay revision. Hopefully, it will be resolved without any further delay. DoP has issued orders for implementation of revised Grade Pay of Rs.4600 to pre-2006 pensioners. KP&TPA has collected particulars from eligible members and they are being forwarded to concerned authorities for necessary action. However, the issue of revision of pension of pre 2006 pensioners at 50% of the last pay or average emoluments on a par with post 2006 pensioners is not yet resolved. He also explained the case of notional increment for those who retire on 30th June and 31st December and why it is necessary to modify the increment rule itself. He said that we will pursue it with the departments concerned and the subject has been sent to DoP&PW for inclusion in the agenda for the 31st meeting of SCOVA likely to be held shortly
- 17. Shri D V Padubidri, President, Udupi Dist P&T Pensioners Association, quoting examples spoke about the implication of the recommends of both 6th and 7th CPCs.

- 18. Shri Sadananda LM 1233 wanted the association to pursue with the government several pending demands such as re-fixation of pension of pre- 2006 pensioners at 50 % of the LPD, restoration of commuted part of pension, grant of age-related additional pension. Secretary replied that all the issues raised by the member will be discussed with advisors on accounts matters and pursued with DoP&PW.
- 19. Shri MR Sehacahar, ALM 2347 speaking on the revised pension admissible to pre 2006 grade S-12 retirees consequent upon grant of grade pay of Rs.4600, pointed out that there is some difference between the figures indicated in the table published by the association in Pensioners' Champion June 2019 issue and those found in the table that he had accessed from internet. Secretary informed the member that KP&TPA had published the tables prepared by it in January and June even before DoE and DoP&PW had published the revised tables and the tables published by KP&TPA exactly match with tables posted on the official website of Department of Pension which apparently proves that the one accessed by the member is inaccurate.
- 20. Shri I V Patil, LM 2315 raised the issue of counting induction training period for the purpose of TBOP, and BCR in Postal Department, which is pending for a long period. Shri Rao said that it was brought to the notice of CPMG in March19 and that it has been implemented in some Divisions.
- 21. Regarding CGHS, Shri Krishna Rao explained some of the pensioner friendly orders implemented by CGHS recently. He explained the procedure in obtaining the OPD treatment at the empanelled private hospitals and answered queries raised by the members in the audience. Answering Shri S.Rajagopalan LM 1047, the Secretary said that now on line registration for appointment with the doctors of Wellness Centers is also available.

- 22. Shri G.Babu, in his concluding remarks, thanked not only EC members, but all, who have volunteered towards making the AGB a grand success.
- 23. More than 400 members attended this year's AGB, some of them with their family members. 17 applications for new membership were received. 117 members renewed their subscription for Pensioners' Champion.24 members paid donation for the building fund amounting to Rs.71,802. The Executive Committee conveys its sincere thanks to all the members, well wishers and their family members and many volunters helping the Association who made the AGB a successful event.
- 24. **Digital Life Certificate:** In compliance of the instructions of the Department of Pension and Pensioners Welfare, KP&TPA had made necessary arrangements in the Annual General Body meeting to register pensioners with Jeevan Pramaan web site to facilitate submission of DLC in November 2019. About 40 pensioners utilized the facility.
- 25. After vote of thanks, the session concluded at 4.30 PM with National Anthem.

Shri P.Gangadhara Rao, General Secretary, All India BSNL Pensioners Welfare Association lead a delegation of BSNL Pensioners from Bihar and met with Shri Ravishankar Prasad, the Hon'ble Minister for Communications at his residence in Patna and submitted a memorandum on revision of pension of BSNL pensioners.

BSNL IDA Gol, Ministry of Heavy Industries & Public Enterprises, Department of Public Enterprises OM No. W-02/0002/2014-DPE (WC)-GL / XIV /19 dated 4th July, 2019

Board level and below Board level posts including non-unionised supervisors in Central Public Sector Enterprises (CPSEs)- Revision of scales of pay w.e.f. 01.01.2007 - Payment of IDA at revised rates.

In modification of this Department's OM of even No. dated 02-4-2019, the rate of DA payable to the executives and non-unionised supervisors of CPSEs (2007 pay revision) is as follows

- a) Date from which payable: 01.07.2019
- b) Average AICPI (2001=100) for the quarter March, 2019 May, 2019
 March, 2019 = 309, April, 2019 = 312, May, 2019 = 314, Average of the quarter = 311.67
- c) Link Point: 126.33 (as on 01.01.2007)
- d) Increase over link point: 185.34 (311.67 minus 126.33)
- e) DA Rate w.e.f. 01.07.2019: 146.7 % [(185.34/126.33) x 100]
- 2. The above rate of DA i.e. 146.7s% would be applicable in the case of IDA employees who have been allowed revised pay scales (2007) as per DPE O.Ms. Dated 26.11.2008, 09.02.2009 and 02.04.2009.
- 3. All administrative Ministries/ Departments of the Government at India are requested to bring the fore goings to the notice of the CPSEs under their administrative control for necessary action at their end.

Submission of Life Certificate by Pensioners of 80 years and above

Submission of Life Certificate.

It has been the experience of this Department that the Senior Pensioners i.e. the pensioners 80 years and above, are facing a lot of difficulties, standing in queues while giving the Life Certificates in November. It has been under the consideration of the Government to provide some relief to such pensioners.

It has, therefore, been decided by the Government, that Senior Pensioners aged 80 years and above be allowed to give their Life Certificate w.e.f 1 st October every year instead

of November, which would be valid till 30th of November of the subsequent year.

The remaining pensioners below the age of 80 years may continue to give their Life Certificate in November as per existing provisions of CPAO Scheme booklet.

This has the approval of competent authority.

Office Memorandum

Revision of Pension w.e.f. 1.1.2006 of Pre-2006 pensioners who retired from the 5th CPC scale of Rs. 6500-10500/- or equivalent pay scale in the earlier Pay Commission periods.

Instructions have been issued vide this Department's OM of even number dated 4.1.2019 that for the purpose of revision of pension/family pension w.e.f. 1.1.2006 under para 4.2 of the OM dated 1.9.2008, the Grade Pay of Rs. 4600/- may be considered as the corresponding Grade Pay in the case of pre-2006 pensioners who retired/died in the 5th CPC scale of Rs. 6500-10500/- or equivalent pay scale in the earlier Pay Commission periods. It was also provided that the revised pension w.e.f. 1.1.2006 in terms of para 4.2 of OM dated 1.9.208, for the pre-2006 pensioners who retired from the pay scale of Rs. 6500-10500/- in the 5th CPC or equivalent pay scales in the earlier Pay Commissions would be Rs. 8345/-. The entries at serial number 13 in the annexure of this Department's OM No. 38/37/08-P&PW(A) dated 28.1.2013 were also revised accordingly.

2. This Department has issued concordance tables for revision of pension, w.e.f. 1.1.2016, of pre-2016 pensioners by notional fixation of pay in the 7th CPC vide this Department's OM dated 6.7.2017. Tables No. 24 & 25 in these concordance tables indicated the revised pension/family pension based on the corresponding 6th CPC grade pay of Rs. 4200 in respect of pre-2006 pensioners/family pensioners who retired/died in the 5th CPC scale of Rs. 6500-10500 or equivalent pay scale in the earlier Pay Commission periods. Consequent on the decision to consider the Grade Pay of Rs. 4600/- as the corresponding Grade Pay in the case of pre-2006 pensioners, who retired/died in the 5th CPC scale of Rs. 6500-10500 or equivalent pay scale in the earlier Pay Commission periods and based on the fitment tables provided by Ministry of Finance (Department of Expenditure), tables No. 24 & 25 have been revised. Accordingly, revised concordance Tables No. 24 & 25 are enclosed here with.

- 3. All the Ministries/Departments are requested to revise pension/family pension w.e.f. 1.1.2016 in respect of pre-2006 pensioners/family pensioners who retired/died in the 5th CPC scale of Rs. 6500-10500/- or equivalent pay scale in the earlier Pay Commission periods using the concordance tables enclosed herewith. The other provisions/instructions for revision of pension of pre-2016 pensioners, as contained in this Department's OM of even number dated 12.5.2017 and 6.7.2017 will remain unchanged.
- 4. This issues with the approval of Ministry of Finance (Department of Expenditure) vide their OM No. 30-1/33(c)2016-IC/E.III.A dated 28.6.2019.
