**Report on the 29th Meeting of the Standing Committee of  
Voluntary Agencies (SCOVA) held on 12th January 2017**

The 29th Meeting of the Standing Committee of Voluntary Agencies (SCOVA) organized by Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare, was held on 12<sup>th</sup> January, 2017 in Committee Room –A, Vigyan Bhavan Annexe, New Delhi. The meeting was attended by almost all of the Official Representatives and the Non-official Members of SCOVA. Dr. Jitendra Singh, Hon'ble Minister of State, (Personnel, Public Grievances & Pensions) Chairman, SCOVA, presided.

2. Sri C.Viswanath, Secretary, DoP & PW in his opening remarks stated that SCOVA setup in 1986 has been a good forum for interaction with Pensioners' Associations and has been making every endeavour to resolve the issues raised by Pensioners. He said 85 % of the grievances of Pensioners have been disposed

of and about 15 lakh Pensioners have got Digital Life Certificates. About 7<sup>th</sup> CPC recommendations the Secretary said that pension revision by multiplication of the pre-revised pension by 2.57 has been made as per option -2 and on revision of pension as per option-1 recommended by the Pay Commission, the Committee setup to examine the feasibility of implementation of Option-1 has since submitted its report and the Cabinet has to take a decision in the matter. On New Pension System, he said that a separate meeting of the Pensioners' Associations under SCOVA will be called shortly to ascertain their views.

3. Smt. Vandana Sharma, Additional Secretary, Pension, welcoming all those attending the meeting in a cold morning in Delhi, gave details of the pending Revised PPOs and stated that since we are in 7<sup>th</sup> CPC regime, all the 6<sup>th</sup> CPC pending cases should be settled expeditiously.

The Official Representative of CPAO said that about 3200 cases are pending mainly because of want of relevant records and CPAO is concerned with the genuineness of the pending cases and therefore have sought the assistance of the Banks to check the genuineness with reference to KYC and DGL. On pending DoT Pensioners' cases, it was informed by DoT that all the subordinate offices have been asked to speed up action to ensure issue of revised PPOs in the remaining cases.

#### **4. Health Insurance Scheme for Pensioners including those residing in Non-CGHS areas**

Ministry of Health and Family Welfare informed that EFC memo has been finalised. The Additional Secretary, DoP&PW wanted to know as to when the issue will go to the Cabinet for approval. The Hon'ble Minister remarked that the issue should be finalised before the next SCOVA. MoH&FW explaining the reasons for the delay said that opinion of all the Departments had to be taken before finalisation of the Memo. Sri K B Krishna Rao, Secretary, KP&TPA intervening in the discussions, said that the Association would like to reiterate its earlier request that the Health Insurance Scheme ie.CGEPHIS must be optional for the existing CGHS beneficiaries, especially the Pensioners, since CGHS is the best medicare available for Pensioners. The Official representative, MoH&FW responded by saying that the Health Insurance Scheme will be optional.

**5. Extension of CGHS facilities to P&T Pensioners:** It was informed that decision of the Government on 7<sup>th</sup> CPC report to which this issue has been linked is still awaited. Pay Commission had recommended merger of all the remaining postal Dispensaries with CGHS and extension of CGHS to all P&T Pensioners. A report has been sent to the Committee on Allowances. The issue generated a good deal of discussion in which Pensioners' Associations, Secretary & Additional Secretary DoP&PW participated. Secretary DoP&PW

opined that there was no need to refer this issue to the Allowances Committee and the matter should be reviewed.

#### **6. Anomaly in fixation of pay of BSNL employees who retired between 1-10-2000 and 31-7-2001 ie. Within 10 months of formation of BSNL**

DoT informed that BSNL has furnished details of financial implications if pension revision is made as per the 2 methods suggested by DoP&PW and IFD(DoT). IFD, DoT has sought some more details to assess the correct financial implication and the number of beneficiaries. BSNL has been requested to furnish the required details and a reply is awaited.

At this stage, K.B. Krishna Rao, Secretary, KP&TPA, mentioned about the judgment dated 16-12-2016 of CAT Principal Bench, Delhi which has allowed the Application of All India BSNL Pensioners' Welfare Association & Others and requested that the Order may be implemented and the Govt must not file a writ petition in the High Court of Delhi since the demand for correction of the anomaly has been pending unresolved for more than 16 years. He also requested that the CAT Order must be made applicable generally to all DoT/BSNL Pensioners who retired within 10 months of formation of BSNL.

Continuing with his submission Sri Rao, drew the attention of DoT to the National Litigation Policy and said that since the numbers of Pensioners that will benefit is only around 4000 + and the expenditure also may not be quite huge, the Order may be implemented without appealing against it in the High Court. The Secretary DoP&PW and the Additional Secretary responded by asking DoT to examine the request and take a decision in the matter.

#### **7. Merger of 78.2% of IDA with basic pension of BSNL Pensioners**

DoT informed that the issue has been settled with the issue of the OM dated

18-7-2016. Sri K B Krishna Rao, Secretary, KP&TPA brought it to the notice of DoT that much progress has not been seen in payment of arrears and as per the information available with the Association revision of pension has reportedly been done only in about 15-20 percent of the cases and the time frame of 31-12-2016 fixed for revision has already ended. The Additional Secretary asked the DoT to look into this to ensure expeditious revision.

**8. Grade Pay of Rs. 4,600/- instead of Rs. 4,200/- to be taken into consideration for the purpose of computing revised pension of pre-2006 Pensioners who retired in the Pay Scale of Rs. 6,500- 200–10,500 in terms of para- 4.2 of OM dated 1-9-2008 of DoP & PW**

Department of Expenditure was of the view that since the grade pay of Rs.4600 was given subsequently outside the recommendation of 6<sup>th</sup> CPC; the same is not applicable to those who retired from the pay scale of Rs.6500-200-10500 before 1-1-2006 since the up gradation of the post is post 6<sup>th</sup> CPC.

DoT informed that the grade pay of Rs.4600 has not so far been given to any pre-2006 pensioner retired from the pay scale of 6500-10500 and the matter is still sub-judice since a contempt petition is pending before CAT Bengaluru.

Pensioners' Associations, including KP&TPA, earnestly requested that, since the Order of CAT, Bengaluru was upheld by the High Court of Karnataka also, grant of grade pay of Rs.4600 to all pre-2006 retirees of grade S-12 must be favourably considered. DoT, in response said that the matter will be considered after disposal of the contempt petition.

**9. Stoppage of recovery of wrongful / excess payments from Railway Pensioners**

Representative of the Ministry of railways informed that they are ready to agree to the demand and necessary orders will be

issued after getting the approval of Railway Board

**10. Delay in commencement of family pension to the spouse on death of Pensioners**

CPAO informed that instructions have been reiterated on 2nd June, 2016 to Heads of CPPCs and Government Business Divisions of all Authorised Banks to commence payment of family pension to the spouse within a month of submission of death certificate of the pensioner, after obtaining proof of his/her age/ date of birth and undertaking of recovery of excess payment. The matter was also reviewed in the meeting held with banks on 22nd Aug, 2016 and Banks were urged to take necessary steps in this regard to ensure timely payment of family pension in the event of death of pensioners.

Pensioners Associations pointed out that despite repeated instructions in the matter, several complaints of inordinate delay in commencement of family pension have been reported. The Hon'ble Minister advised the Associations to bring specific cases of delay to his notice for speedy settlement of the cases.

**Fresh Items of the Agenda**

**1. Item wise details of payment made to be shown in Pass Books**

One of the Pensioners' Association had pointed out that 'breakup' of the amount credited to the SB account of Pensioners is not being indicated in the Pass Books by Banks which makes it difficult for the Pensioners to know the amount of basic pension, DR, additional pension, arrears, FMA etc credited to their account. Even the amount of recovery made towards wrong/over payment is not indicated separately.

CPAO informed that CPPC Guidelines provide for display of the details of calculation of pension & breakup on the computer screen.

A new facility has been recently introduced, wherefrom the Pensioners can obtain the details of their monthly pension, DR, FMA, DR arrears etc from the "Web Responsive Pensioners Services".

## 2. Life Certificate

It was informed that Digital Life Certificate is an additional facility provided to the Pensioners and they now have three options for submission of Life Certificate. (i) by presenting himself/herself before the Pension Disbursing Authority to record the Life Certificate (ii) by producing the Life Certificate in the prescribed form and (iii) through Aadhaar based Biometric Authentication System. The Secretary DoP&PW observed that since the Country is moving towards digitalisation, Pensioners should opt for Digital Life Certificate.

## 7<sup>th</sup> CPC – implementation of Option-1

At the end of discussions on fresh items of the Agenda, Sri K.B.Krishna Rao, Secretary, KP&TPA, requested the Secretary, DoPPW, who was also the Chairman of the Committee constituted to examine the feasibility of implementation of option-1 recommended by the 7<sup>th</sup> CPC, to apprise the Associations whether option-1 as recommended by the 7<sup>th</sup> CPC would be implemented. The Secretary said that the Committee has submitted its report to the Govt and the Cabinet has to take decision in the matter. When the Associations sought to know about the nature of the "REPORT" the Secretary remarked that it is "Positive". Pressed further, he said "it is as per your suggestion". From this response of the secretary, it is apparent that the report is about granting of parity in pension as recommended by the 5<sup>th</sup> CPC extended up to 7<sup>th</sup> CPC, since in the special meeting convened by the Secretary on 5-10-2016 of SCOVA Members to elicit their views on implementation of option 1, all Pensioners Associations (except K P&T PA) had agreed to the methodology of fixation of pension suggested by of DoP&PW

in place of option-1 recommended by the 7<sup>th</sup> CPC.[*Pensioners' Champion*" Oct 2016 issue carried a write-up on the issue with examples on revision of pension as per the methodology suggested by the Dept. of Pension]

Dr. Jithendra Singh, Hon'ble Minister, in his concluding remarks said that he was glad that most of the Pensioner-Members of SCOVA participated in the discussions which were meaningful and informative. He said that he was glad that the Department of Pension, despite being dependent on several other Central Departments to ensure resolution of grievances of Pensioners, has been doing good work in that direction and has always been sympathetic towards Pensioners. Observing that most of the issues discussed related to Health, the Minister said that the Secretary will hold a separate meeting to resolve those issues. On seeding of Aadhaar number with PPOs and Bank accounts, he said that 88% of the accounts have been linked to Aadhaar. He said that though seeding of Aadhaar is not mandatory Pensioners should make use of that as a facility.

Referring to the improvement in life expectancy over the years, the Minister said that Pensioners' expertise and experience should be made use of in Nation building process by involving them in programmes of the Govt. like "Swatch Bharat Abhiyan", "Sankalp" etc.

The meeting ended after vote of thanks by Smt. Sujasha Choudhury, Director (P) & HOD

Contribution**

**Revision of rates of subscription under Central Government Health Scheme due to revision of pay and allowances of Central Government employees and revision of pension/ family pension on account of implementation of recommendations of the Seventh Central Pay Commission.**

Gov, Ministry of Health and Family Welfare, EHS Section No. S.11011/11/2016  
CGHS (P)/EHS Dated the 9th January, 2017

The undersigned is directed to refer to this Ministry's OM No. S.11011/2/2008-CGHS(P) dated 20th May, 2009 vide which orders were issued revising the rates of monthly subscription for availing CGHS facility, as also the entitlement for free diet, entitlement of accommodation in private empanelled hospitals under CGHS, etc.

2. Consequent upon revision of pay on the basis of the implementation of the recommendations of the 7th Central Pay Commission, **it has been decided to revise the rates of subscriptions, to be made by employee's/ pensioners, for availing benefits under the CGHS, with effect from 1st January, 2017.** It has also been decided to revise the monetary ceiling limits for various entitlements of the beneficiaries for availing CGHS facilities.

3. In supersession of all earlier instructions, the following revisions are being made, in so far as it relates to the facilities mentioned below:

**Revision of CGHS Contribution as per 7th CPC will be effective from 01.02.2017**

**(A) Monthly Contributions for availing CGHS facility:**

1.	Level: 1 to 5	250

**Revision of Income limit for dependency for the purpose of providing Central Government Health Scheme (CGHS) coverage to family members of the CGHS covered employees subsequent to implementation of recommendation of the Seventh Central Pay Commission**

*Gol, Ministry of Health and Family Welfare, (CGHS-P Section)  
O M No. No. S-11012/2/2016-CGHS-P dated the 8th November, 2016*

The undersigned is directed to say that subsequent to the implementation of the recommendations of the 6th CPC, the income limit for dependency for the purpose of extending CGHS coverage to "family" members of the CGHS covered Central Government employees was enhanced to Rs. 3500/- per month plus the amount of dearness relief on the basic pension of Rs. 3500/- as on the date of consideration.

2. With the implementation of the recommendations of the 7th Central Pay Commission, the issue of revision of income limit for dependency for the purpose of providing CGHS coverage to family members of the CGHS covered Central Government employees and pensioner CGHS Beneficiaries was under consideration keeping in view the amount of minimum pension/family pension fixed by the 7th Central Pay Commission.

3. On the basis of the recommendations of the 7th CPC, the Department of Pension and Pensioners' Welfare under Para 5.2 of their OM No. 38/37/2016-P&PW (A)(i) dated 4/8/2016 has fixed the amount of minimum pension at Rs. 9,000/- per month and under para 7.1 of this OM the amount of family pension has been fixed as 30% of the basic pay In revised Pay Structure and shall be subject to a minimum of Rs. 9,000/- per month and maximum of 30% of the highest pay in the Government. Vide Para 7.3 of the aforesaid O.M, It has been mentioned that there will be no other change in the provisions regulating family pension.

4. It has been decided, In consultation with the Department of Expenditure, to revise the income limit for the purpose of providing CGHS coverage to the family members of the CGHS covered Central Government employees to Rs. 9,000/- plus the amount of dearness relief on basic pension of Rs. 9,000/- as on the date of consideration.

5. As such, all the orders related to the CGHS Rules stand amended to the extent that the Income limit for Rs. 3500/- per month from all sources including pension/and family pension stands amended to an income of Rs. 9000/- plus amount of the dearness relief on the basic pension of Rs. 9000/- as on the date of consideration. The amount of dearness relief, as indicated in the income limit stands for the amount of dearness relief drawn by a pensioner/ family pensioner on the date of consideration and not the amount of dearness relief due on the date of consideration.

6. The Income limit for dependency of "Rs.9000 plus amount of the dearness relief on the basic pension of Rs. 9000/- as on the date of consideration", shall also be applicable for the cases covered under CS(MA) Rules, 1944 for the purpose of examining eligibility of family members of the Central Government employee for medical facilities under the Rules.

7. The order shall be effective from the date of Issue of Instructions of this O.M.

8. This issues with the concurrence of Department of Expenditure vide their I.D. No.204/E-V/2016 dated 19/10/2016.
