### A Creditable achievement \* The significant contribution of our Association

This refers to the DoP & PW Order dated 4th January 2019 published in the current issue of our journal on granting Grade Pay of Rs. 4600 to all posts in the pre-revised scale of Rs. 6500-200-10500 (Grade S-12) instead of Rs. 4200. On getting favourable court judgement in this connection, Sri K.B.Krishna Rao, the Secretary of our Association as also the Secretaries of some Pensioners' Associations from different parts of the country addressed DoP & PW requesting grant of Grade Pay of Rs. 4600 in place of Rs. 4200 to all those who retired from the pre-revised scale of Rs.6500-200-10500(Grade S-12). No favourable response could be received from DoP & PW. Sri K.B. Krishna Rao, the Secretary of our Association representing our Association in SCOVA, notified the issue for discussion in the 23rd meeting of SCOVA held

on 20-9-2013. Though the brief provided followed by effective arguments by him in the meeting of the SCOVA were convincing, the representative of Department of Expenditure did not agree with the views of the association and said that the demand cannot be accepted and the issue be treated as closed. Thanks to the intervention of the then Minister of State for Personnel, Public Grievances and Pensions, Sri V. Narayanasamy, the Chairman, SCOVA, who felt that the points raised by our Association required detailed examination, keeping in view the court judgement, and stated that the subject should be kept open. The issue was kept open till the 30th meeting of the SCOVA in

March 2018. Relentless efforts in the matter were continued by the Secretary of our Association as also Secretaries of other Associations and some individual pensioners and after a gap of nearly six years, the DoP & PW has issued a favourable order.

CCCGPA, Karnataka had an opportunity to present a Memorandum to 7th CPC on 24-8-2014 when it paid a visit to Bangalore. Sri K.B. Krishna Rao was one of the sevenmember delegation being Secretary of K P&T PA. Each member of the delegation was assigned the task of explaining one/two subjects included in the Memorandum. Sri KBK Rao, keeping in view the above issue, ably argued about parity in pension between pre-2016 and post 2016 pensioners and requested the Pay Commission to recommend grant of "one post one pension" for civil servants.

A few other achievements of KBK Rao through the forum of SCOVA are also worth mentioning. Among several issues taken up in the forum of SCOVA by the Association, the most outstanding and innovative is grant of airfare for attending meeting of the SCOVA, irrespective of the post held by the member at the time of his retirement from service, on condition that the journey to be made extends beyond 24 hours and the distance travelled is above 1000 Kms. The other issues are dispensing with submission of application in Form 14 for sanction of family pension which involved cumbersome procedure for the family pensioner, modification to the format of the Life Certificate by making provision for issue of acknowledgement and withdrawal of order dated 1-8-1996 of Ministry of Health & Family Welfare denving CGHS facility after retirement for P&T pensioners who were not getting CGHS facility immediately before retirement.

The credit for mobilizing required funds for constructing annexe to Pensioners' Bhavan and getting it completed in a record period of ten months, should go to the team of office bearers led by Sri KBK Rao. In this connection, he had the all-round support of President of our Association Sri G.Babu as I had also received during my tenure while completing our earlier project.

Our Association's journal, Pensioners' Champion, being well-edited at present by Sri KBK Rao, has functioned as an effective media for conveying topics on pension matters, on medical facilities including CGHS for pensioners and on requirements of senior citizens. This has, to a great extent, contributed to increase in our membership. Release by Sri KBK Rao of a Supplement to 8th Edition of COMPENDIUM ON PENSION. CGHS AND MEDICAL FACILITIES FOR CENTRAL GOVT. AND BSNL PENSIONERS containing orders of DoP & PW on 7th CPC and a ready reckoner for fixation of notional pay in 7th CPC pay matrix for revision of pension in terms of the OM dated 12-5-2017, has been of immense help to pensioners and the publication was well-appreciated. It is worth placing on record the assistance rendered to him by his wife in this herculean task apart from other activities connected with the Association. Incidentally, it may be mentioned that between the ready reckoner published by our Association and that by the DoP & PW subsequently, there was hardly any difference. His expertise in accounts especially on pension matters was of great help for those who contacted him for knowing their revised pension and arrears due to them. His active role as Chairman of CCCGPA, Karnataka has, to a great extent, attracted more pensioners' associations to become affiliates of CCCGPA.

Our Association continued to have cordial relationship with DoP&PW and the Pension Department, which had identified our association in National e-Governance Plan under Pensioners Portal, identified us in programmes like "Swachh Bharat Abhiyan" and "Digital Life Certificate". Our representations on several other issues submitted to the

Pension Department got the required consideration by DoP&PW.

At the time of getting relieved from the post of Secretary, I made a statement in the General Body meeting that Sri KBK Rao on taking charge as Secretary with his team of office bearers will take the Association to greater heights. This has really happened. Inspite of his achivements mentioned above Sri KBK Rao continues to remain unassuming - a nature in rarity among the present day leadership. My congratulations to Sri KBK Rao and also to the entire team.



DoP&PW Order on revision of pension

### A Long Pending Demand of Pensioners Accepted

Pensioners who had retired from the V CPC pay scale of Rs. 6,500 -200-10,500 or from the corresponding pay scales in previous pay commissions to get a minimum revised pension of Rs.8345/- from 1-1-2006. Pension to be revised after taking in to account the Grade Pay of Rs. 4,600/- instead of Rs. 4,200

Gol. Ministry of Personnel, PG & Pensions, Department of Pension & Pensioners' Welfare

OM No. 38/33112-P&PW (A) Dated the 4th January, 2019

Revision of pension w.e.f. 1.1.2006 of Pre-2006 pensioners who retired from the 5th CPC scale of Rs. 6500-10500

The undersigned is directed to say that as per Para 4.2 of this Department's OM of even number dated 01.09.2008 relating to revision of pension of pre-2006 pensioners w.e.f. 1.1.2006, the revised pension w.e.f. 1.1.2006, in no case, shall be lower than 50% of the sum of the minimum of pay in the pay band and the grade pay thereon corresponding to the pre revised pay scale from which the pensioner had retired.

2 .Instructions were issued vide this Department's OM of even number dated 28.1.2013 for stepping up of pension of pre-2006 pensioners w.e.f. 24.9.2012 to 50% of the sum of the minimum of pay in the pay band and the grade pay thereon corresponding to the pre-revised pay scale from which the pensioner had retired, as arrived at with reference to the fitment tables annexed to Ministry of Finance, Department of Expenditure's OM No. 1.1.2008-IC dated 30th August, 2008. A concordance table indicating the revised pension/family pension of pre-2006 pensioners in terms of instructions contained in para 4.2 of OM dated 1.9.2008 read with the OM dated 28.1.2013 was also annexed to the OM dated 28.1.2013. Subsequently, orders were issued vide this Department's OM of even number dated 30.7.2015 that the pension/ family pension of all pre-2006 pensioners/family pensioners may be revised in accordance with this Department's OM No. 38/37/08-P&PW(A) dated 28.1.2013 with effect from 1.1.2006 instead of 24.9.2012.

- 3. In the aforesaid OM dated 28.1.2013 of Department of Pension & Pensioners' Welfare, the grade pay corresponding to the pre-revised pay scale of Rs. 6500-10500 was shown as Rs. 4200/- and the minimum pension in terms of para 4.2 of the OM dated 1.9.2008 was shown as Rs. 8145/- (50% of minimum pay of Rs. 16,290/- as per fitment table for the pre-revised scale of pay of Rs. 6500-10500, annexed to Ministry of Finance, Department of Expenditure's OM No. 1/1/2008-1C dated 30th August, 2008).
- 4. Order were issued vide Ministry of Finance, Department of Expenditure's OM No. 1/1/2008-1C dated 13.11.2009 that the posts which were in the pre-revised scale of Rs. 6500-10500 as on 1.1.2006 and which were granted the normal replacement pay structure of grade pay of Rs. 4200/- in the pay band PB-2, will be granted grade pay of Rs. 4600/- in the pay band PB-2 corresponding to the pre-revised scale of Rs, 7450-11,500 w.e.f. 1.1.2006.
- 5. Representations have been received in this Department for extending the benefit of grade pay of Rs. 4600/- for revision of pension/family pension, w.e.f. 1.1.2006, in respect of Pre-2006 pensioners who retired/died in the 5th CPC scale of Rs. 6500-10500/- or equivalent pay scale in the earlier Pay Commission periods. The matter regarding the amount of minimum pension/family pension in terms of para 4.2 of the O.M. dated 1.9.2008 in their

case has been re-examined in the light of the orders issued by Ministry of Finance (Department of Expenditure) vide their OM No. I/I/08-IC dated 13.11.2009 and decisions of courts in certain cases. It has been observed that pay of all serving employees in the prerevised pay scale of Rs. 6500-10500/- has been fixed w.e.f. 1.1.2006 in the grade pay of Rs. 4600/-. Therefore, the grade pay of Rs, 4600/- can be considered as the grade pay corresponding to the pre-revised pay scale of Rs. 6500-10500/-.

6. Accordingly, it has been decided that, for the purpose of revision of pension/family pension w.e.f. 1.1.2006 under para 4.2 of the O.M. dated 1.9.2008, the Grade Pay of Rs. 4600/- may be considered as the corresponding Grade pay in the case of pre-2006 pensioners who retired/died in the 5th CPC scale of Rs. 6500-10500/- or equivalent pay scale in the earlier Pay Commission periods,

7. In accordance with the provisions of Rule 7 of the CCS (Revised Pay) Rules, 2008, the pay corresponding to the pay of Rs. 6500/- in the pre-revised pay scale of Rs. 6500-10500/ - would be Rs. 12090/- in the PB-2. After adding the grade pay of Rs. 4600/-, the pay in the Pay Band + Grade Pay corresponding to the pay of Rs. 6500/- in the pre-revised pay scale of Rs. 6500-10500 would be Rs. 16690/ - (12090+4600). Accordingly, the revised pension w.e.f. 1.1.2006 in terms of para 4.2 of OM dated 1.9.2008, for the pre-2006 pensioners who retired from the pay scale of Rs. 6500-10500/- in the 5th CPC or equivalent pay scales in the earlier Pay Commissions would be Rs. 8345/-. Accordingly, the entries at serial number 13 in the annexure of this Department's OM No. 38/37/08-P&PW(A) dated 28.1.2013 may be substituted by the entries shown in the/statement annexed to this O.M. (Annexure in page - 6).

8. As provided in this Department's OM dated 28.1.2013, in case the consolidated Pension

/family pension calculated as per para 4.1 of this Department's OM No. 38/37/08- P& PW(A) dated 1.9.2008 is higher than the pension/ family pension calculated in the manner indicated above, the same (higher consolidated pension/family pension) will continue to be treated as basic pension/family pension.

9. In their application to the persons belonging to the India Audit and Accounts Department, these orders are issued in consultation with the comptroller and Auditor General of India.

10. All the Ministries/Departments are requested to bring the contents of these orders to the notice of Controller of Accounts/Pay and Accounts Officers and Attached and subordinate Offices under them. They are also requested to revise the pension of the affected pre-2006 pensioners in accordance with the instructions contained in this O.M. on a top priority basis.

- 1) Pension as revised under 6th CPC in terms of the above order dated 4-1-2019 needs to be revised further under 7th CPC in terms of the provisions of DoP&PW OM dated 12-5-2017 at 50 % of the notional pay as on 1-1-2016. Hence, the concordance tables No 24 and 25 annexed to DoP&PW O M - F. No. 38/37/2016-P&PW(A) Dated 5th July, 2017 wherein the tables were prepared taking in to account the grade pay of Rs.4200 in level -6 of 7th CPC require to be revised now with the grade pay component of Rs.4600 in level-7. Therefore, KP&TPA in its letter dt. 14-1-2019 to the. Secretary, DoP&PW (reproduced in this Journal)has requested for issuance of corrections to tables 24 and 25 of the concordance tables to clear doubts, if any, that may arise in implementation of the OM dated 4-1-2019 by the PAOs concerned.
- 2) K P&T PA has prepared a table with grade pay of Rs.4600 with particulars of revised pension/family pension admissible wef 1-1-2016 in level -7 under 7th CPC pay matrix for pre-2016 grade S-12 pensioners which appears in this issue (page 9).

# 7th Pay Commission - NO change in pay fitment factor from 2.57 to 2.81

Minister of State in the Ministry of Finance Shri P. Radhakrishnan in reply to question No. 78 asked by Shri Ravi Prakash Verma has answered in the RAJYA SABHA on 11.12.2018 that the fitment factor for the purpose of fixation of pay in the revised pay structure based on the categories of employees. As the same is based on the specific and considered recommendations of the recommendations of the 7th Central Pay Commission is 2.57 which is uniformly applicable to all 'th Central Pay Commission, no change therein is envisaged

Subject:- Revision of pension w.e.f. 1.1.2006 of Pre-2006 pensioners who retired from the 5<sup>th</sup> CPC scale of Rs. 6500-200-10500 - corrections to Tables Nos 24 and 25 of the Concordance tables -7<sup>th</sup> CPC pay matrix levels-annexed to the O M - F. No. 38/37/2016-P&PW(A) Dated 6th July, 2017

The Executive Committee of Karnataka Posts and Telecommunications Pensioners' Association, Bangalore wishes to convey on behalf of the members of the association and on its own behalf profound gratitude to the Department of Pension and Pensioners Welfare for favourably considering the request of pre-2006 pensioners who had retired from grade S-12 for revision of their pension under 6th CPC in terms of para 4.2 of OM dated 1-9-2008, after taking into account grade pay of Rs.4,600 instead of Rs.4200.

2. We would like to recall that our association had requested DoP&PW to include this issue as an item in the 'agenda items' for discussion in the 23rd meeting of SCOVA held on 23-9-2013 , when we were in the rotating group of the pensioners' associations nominated to SCOVA, which was accepted by DOP&PW and the issue was discussed in the 23rd meeting of SCOVA and in subsequent meetings thereafter. We are extremely pleased

to state that the Department of Pension &PW not only allowed meaningful discussions on the issue in all the meetings that our association had participated in as a member of the SCOVA, but also took the issue forward in right earnest to its finality by pursuing the issue with DoE which has resulted in issuance of the OM dated 4-1-2019 referred to above.

- 3. We feel that some more action is called for in this matter since vide para 7 of the OM only corrections to the revised pension admissible under 6<sup>th</sup> CPC vide serial number 13 in the annexure of DoP&PW OM No. 38/37/08-P&PW(A) dated 28.1.2013 have been issued and the figures of Rs.8145 have been substituted by Rs.8345 consequent to the change of grade pay from Rs,.4200 to Rs 4600. A table with revised grade pay and minimum pension & family pension has also been appended to the OM dated 4-1-2019 to facilitate quick revision of pension under 6<sup>th</sup> CPC.
- 4. The 6<sup>th</sup> CPC pension as revised in terms of OM dated 4-1-2019 with reference to the modified concordance table annexed to OM dated 28-1-2013 needs to be revised further under 7<sup>th</sup> CPC in terms of the provisions of DoP&PW OM dated 12-5-2017 at 50 % of the notional pay as on 1-1-2016. Hence, the concordance tables No 24 and 25 annexed to DoP&PW O M - F. No. 38/37/2016-P&PW(A) Dated 6th July, 2017 wherein the tables for the 4th CPC pay sales of Rs.2000-3200 & Rs.2000-3500 and 5th CPC pay scale of Rs.6500-10500 were prepared taking in to account the grade pay of Rs.4200 in level -6 of 7th CPC require to be revised now with the grade pay component of Rs.4600 in level-7.

5. It is, therefore, requested that necessary early action may please be caused to be taken to revise tables 24 &25 in LEVEL -6 annexed to OM dated 6-7-2017, which were earlier prepared with the grade pay of Rs.4200 by substituting the **grade pay with Rs.4600** in LEVEL -7 of the 7th CPC pay matrix which

will help to clear doubts, if any, that may arise in implementation of the OM dated 4-1-2019 by the PAOs concerned.

- 2. The above rate of DA i.e. 138.8% would be applicable in the case of IDA employees who have been allowed revised pay scales (2007) as per DPE O.Ms. Dated 26.11.2008. 09.02.2009 & 02.04.2009.
- 3. All administrative Ministries/ Departments of the Government at India are requested to bring the fore goings to the notice of the CPSEs under their administrative control for necessary action at their end.

### Merger of 33 Postal Dispensaries with CGHS

No. S.11011/01/2016/CGHS-III/EHS, Gol, Ministry of Health & Family Welfare, Department of Health & Family Welfare, dated 21st December, 2018.

In pursuance of the decision taken by the Government on recommendation of the 7th Cemtral Pay Commission, the following 33 (Thirty Three) postal dispensaries presently functioning in 33 Cities i.e. Agra, Ajmer, Aligarh, Ambala, Amritsar, Bareilly, Behrampur, Chhapra, Cuttack, Darbhanga, Dhanbad, Dibrugarh, Gaya, Gorakhpur, Guntur, Jalandar, Jalpaiguri, Jodhpur, Kota, Moradabad, Muzaffarpur, Nellore, Raipur, Rajahmundry, Saharanpur, Silchar, Siliguri, Tirunelveli, Tiruchirappalli, Vadodra, Varanasi, Vijayawada and Visakhapatnam are hereby merged with the CGHS.

- 2. All serving employees and pensioners of Department of Post (DoP) and Department of Telecom (DoT), who are residing/settled in above 33 Cities and are beneficiaries of the 33 Postal Dispensaries, shall now be covered under CGHS and the Postal Dispensaries shall be rechristened as CGHS Wellness Centres.
- 3. In so far as the existing facilities and manpower in position in these 33 Dispensaries are concerned, the merger shall be effective as per the following terms and conditions:-
- a) All Serving employees and pensioners of Department of Post (DoP) and Department of Telecom (DoT) shall have to abide by the CGHS rules and guidelines to become a member of the Scheme. They shall have to pay the requisite contribution as per the prevailing rates prescribed by the Ministry of Health and Family Welfare/CGHS. DoP & DoT will take necessary action to inform their employees and pensioners in this regard.
- b) All existing facilities and infrastructure like buildings, furniture and fixtures, equipment's etc. will be taken over by CGHS on 'as is where is' basis. The Department of Post shall handover the possession of the

Postal Dispensaries acommodation to the Department of Health and Family Welfare/CGHS at a token rent of Re.1/- per annum. In case of rented accommodations, CGHS will pay the rent from the date of taking over of the Dispensaries.

- c) All doctors of GDMO sub-cadre of CHS working in the above 33 Dispensaries will be taken on roll of CGHS and they shall be placed under the administrative control of Department of Health and Family Welfare/CGHS for all purposes.
- d) All employees (technical/non-technical staff) along with the work allocated and posts they are currenlty holding in these 33 Dispensaries shall be taken over by CGHS. Their seniority and other condition of service in CGHS shall be governed by the relevant instructions and guidelines issued by DoPT from time to time.
- e) All expenditure relating to these Dispensaries including medicines, hospitalization and other reimbursable expenses (of pensioners), salaries and other allowances to the Postal Dispensary employees as a result of merger of these dispensaries shall be borne by CGHS from its own resources.
- f) Local Committees shall be constituted in the respective cities with representatives from both CGHS and Postal Dispensaries to resolve all staffing and other local issues arising on account of the merger in consultation with nodal Ministries.
- 4. These orders shall be effective from 1st January, 2019. Additional Director of concerned CGHS City shall initiate action for taking over of Postal Dispensaries in consultation with the concerned Postal Authorities.

5) This issues with the concurrence of Ministry of Finance, Department of Expenditure's ID No.18(4) / E.V./2017, dated 26.11.2018.

### **Editors Note:**

This demand was included in the common memorandum submitted to the 7th CPC. Agreeing to the demand, the Pay Commission vide Para9.5.18 (ii) of its report recommended merger of remaining 33 postal dispensaries with CGHS. This issue was pursued in SCOVA meetings also. In this regard a special mention must be made about the relentless efforts made by Sri Sathyaprakash Gupta, IPS(Retd),

Secretary, Posts & Telecom Pensioners' Association, Rajasthan, Jaipur in taking up the issue in right earnest with all the concerned authorities and also with the 7th CPC. Sri Gupta met the Chairman 7th CPC Justice A K Mathur in Jodhpur on 12.12.2014 in a special meeting granted to him by the Pay Commission and explained to the satisfaction of the Chairman, the need for merger of the Postal Dispensaries with CGHS. Even after issuance of the order on merger, Sri Gupta has not rested but continues to pursue the issue with CGHS,MOH&FW and DO Posts to see that the order is implemented since the merger is yet to take place.
