### Proceedings of the 27th Annual General Body Meeting of Karnataka Posts and Telecommunications Pensioners' Association held on 20-08-2022 at Kondajji Basappa Auditorium, Bharath Scouts and Guides, No. 39, Palace Road, Bengaluru 560001

After a gap of nearly 3 years, the Annual General Body Meeting of the Association was held physically at the above venue on 20.08.2022 at 10.00 am in which a good number of Pensioners participated. We are pleased to report that the festivities associated with our annual meetings returned this year due to the gradual decline in the number of Covid-19 infections. Felicitations of senior members who are 75 years old and presentation of cash awards to School children were the other events which we could hold this time with fervour. But, the only unhappy occurrence and, a rare one to occur, was that the meeting had to be held in the absence of the President, Vice- President and the Secretary.

#### **Morning Session**

Joint Secretary Sri. V. Murugan welcomed all the members and requested the senior most E.C. member Sri C.S. Karanth, Sri M. Ramiah and Sri H.S Manjunatha advisors, the presidium members to the Dais. Sri C.S. Karanth requested Sri H.S. Manjunatha to conduct the proceedings. Sri H.S. Manjunatha informed the house that sufficient members have signed the attendance register and the required quorum for AGB is there and declared that the house is composed.

The meetings commenced at 10-15 a.m. The Chief Guest Shri L.K. Dash, IPoS, Postmaster General, Bengaluru Head Quarters Region, Bengaluru 560001 was ahead of time and was present in the House. Sri V. Murugan informed the house that Sri S. Rajendra Kumar IPoS, Chief Post Master General, Karnataka Circle is holding additional charge of Tamil Nadu Circle and had to go to Tamil Nadu on an official work and that he is not attending this AGB. He read the messages of the President Sri. G. Babu and the Secretary Sri K. B. Krishna Rao expressing their inability to attend the conference. Thereafter, He welcomed Shri L.K. Dash, IPoS, Postmaster General, Bengaluru Head Quarters Region and requested him to be the Chief Guest and inaugurate the open session.

Sri. H.S. Manjunatha explained the circumstances in which the meeting is being held in the absence of President, Vice President and the Secretary. Further he informed the house that it is the strength of

the association comprising members who were Posts and Telegraph employees who carry the legacy of rising to the occasion. He further said that even during the past, when an emergency arose like aggression by external countries, internal disturbances or during Curfew period and more so during the Covid-19 pandemic period, they did not leave their offices or Telephone exchanges. All the officers right from the Director General to the Postmen and Linemen had maintained the communication services.

#### **Proceedings:**

Sri H.S. Manjunatha on behalf of the presidium placed the agenda for approval and the same was adopted. He also informed the house that minutes of the last year i.e, 26th AGB (Virtual) meeting have been published in the journal for the month of November 2021, appearing at pages 2-7 and sought for the approval by the house and the same was adopted. Chair requested the Joint Secretary to introduce the Chief Guest. Joint Secretary, in his speech, welcomed the Chief Guest, Shri L.K. Dash, IPoS, Postmaster General, Bengaluru Head Quarters Region and gave a brief introduction about his services in the

Department. Sri L.K.Dash IPoS has joined the Department in the year 2001 and has worked in various posts in the Department. Joint Secretary recalled his meeting with him, when he went to his office to invite him to AGB and said that Sri L.K. #### Discussion on Agenda Item

On the following subjects, a detailed note prepared by Sri K.B. Krishna Rao was read out by the Joint Secretary, Sri V. Murugan.

- 1. The Payment of arrears of DR for the period 01.01.2020 to 30.06.2021
- 2. Grant of notional increment for retirement benefits to those who have retired on 30th June 31st December
- 3. Revision of pension of BSNL pensioners from 01.01.2017.

### CGHS, CS(MA) rules and FMA matters.

The latest development is that opening of Wellness Centre at Mysuru is almost finalized and only opening date is to be fixed by CGHS, Delhi. In this regard, Sri Muthu Kumar conveyed his thanks on behalf of Pensioners of Mysuru for the efforts made by the Association.

## Any other subject with the permission of the Chair.

Sri. Sonnappa LM No. 2676 Informed that he has completed 75 years and his name was left out in the felicitation programme in the opening session. He was felicitated by Sri C.S. Karanth.

Sri Sadananda LM No 1233 informed that in many post offices pension is not credited at zero hours and will be credited only after 10 am and hence many pensioners are put to hardship since they have to wait for hours to get there pension. Issue may be taken to credit the pension automatically after zero hours on the pension payable date. Further, he said in banks pension is credited four to five days in advance and the same may be followed in Postal Department also.

Smt Nagalakshmi, ECM explained the entire process involved in drawing and crediting pension and told that delay is due to some technical problems in Finacle software. However this will be discussed in next EC meeting.

Sri Sadananda also requested to take up the issue of revising the age related pension and also increase the minimum pension from 50% to 60%. He also suggested to take up the issue of extension of Ayushman scheme for pensioners also and to extend the DRF scheme as in Tamil Nadu Government. He also requested to take up the issue of not drawing the arrears of pay fixation for 10 years. Sri Sadananda also suggested changing the spelling of Bangalore to Bengaluru. President assured him that his suggestions will be discussed in the ECM.

Sri D. Venkateshalu LM.No 2137, former EC Member, informed that in Nagashettyhalli PO, there is always cash shortage for disbursement and many pensioners have to wait for hours together causing hardship to the aged pensioner. Requested Association to take up this issue with administration to resolve the issue. (Contd. on page 13)

We are extremely glad to record that a grievance registered by us with CPENGRAMS of the Department of Pension and Pensioners' Welfare, regarding short payment of 7th CPC arrears of pension to one of our members, was resolved by the bank within 4 days and the bank concerned has informed that the difference in the amounts of arrears of pension, gratuity and commutation amounting to about Rs.1,13,000 will be paid before 10<sup>th</sup> of the month.

We had, in our brief, pointed out that there were mistakes in calculation of arrears of pension by the bank and in fixation of pay by the Pay and Accounts office (PAO) of the office concerned. The PAO agreed and issued a revised PPO resulting in payment of arrears to the Pensioner.
