RESPECTFUL HOMAGE

Sri B Sadashiva Rao, IPoS (Retd.) founder President of Karnataka Posts and Telecommunications Pensioners' Association and founder Chairman of the Coordination Committee of Central Government Pensioners' Associations, Karnataka and Advisor to both, passed away on 19th February, 2022 at the age of 90 years.

2. Born on 21-10-1931 in Puttur, Dakshina Kannada Dist, he was

the 3rd among 5 brothers, all employees of the Department Posts and Telecommunications. Recruited as Sorting Assistant, in the RMS wing of the Department of Posts, he rose to the level of an Officer of Indian Postal Services Group-A(IPoS) and retired as the Senior



Superintendent RMS, Bengaluru Sorting Division.

3. Before his retirement, he held several important positions in the Department of Posts viz. Superintendent of Post Offices, Pithorghar (UP) and Tumakuru in Karnataka, Assistant Director, and Assistant Postmaster General in the O/o. the Chief Postmaster General, Karnataka.

While in service, he was well known for his efficiency and proved

to be an adept officer who commanded respect of his higher-ups in the Department and colleagues in the office. Hundreds of his former colleagues, who had worked with him, including the writer of this piece, revered him as their "GURU".

- 4. Earlier in his career, he had involved himself in Employees' Unions also in that he had held the post of the Secretary, AIRMS & MMSE U Group-C, Mangaluru Branch, Secretary, IRMs & ASRMs Association, Karnataka. He had forayed into the Co-operative sector also and headed the P&T Employees Housing Co-operative Society as its Secretary.
- 5. Sri Sadashiva Rao, founded "RMS Pensioners' Association Karnataka" in 1994 along with the Veteran P&T Trade Union Leaders viz. Sri Ν Bhaskaran. N Muthusubramanian, M.M. Belliappa and many other leaders and headed it as its first President. The Association was rechristened "Karnataka Posts and Telecommunications Pensioners' Association in 1996. He steered the association to greater heights as its President for 2 decades and stepped aside in November 2013 after turning 80. His contributions in establishing a credible Association are many. To mention a
 - a. He played an important role with Sri N. Bhaskaran in establishing the Coordination Committee of Central Government Pensioners' Associations, Karnataka (CCCGPA) in 1998. Number of affiliates now has reached 30.
 - b. He single-handedly, drafted the Memorandum of Association and Rules and Regulations for the Apex body of Pensioners' Associations named" Bharat Central Pensioners' Association" (BCPC) which was considered in the meeting of Pensioners' Leaders held in New Delhi on 27-4-2008 and Sri Rao was elected as Vice- Chairman (South) and entrusted with the responsibility of preparing the final draft of MOA & RR.
 - c. Another important assignment given to him by the CCCGPA was to draft the "Common Memorandum of Pensioners" submitted to the VI Central Pay Commission.
 - During his term as President of the Association, he offered his advice to many P&T Pensioners who sought his help in

- settlement of their grievances regarding pension and CGHS matters.
- e. As an Advisor to the Association, he guided it in its effective functioning by tendering his advice on crucial issues. His another contribution worth recording was his resolve and perseverance to ensure acceptance of the Income Tax returns of the Association for the years of 2013-14 & 2014-15 which were initially, not accepted by Income Tax Dept. for technical reasons. But for his timely advice and pursuance of the matter, the association would have been forced to pay income tax of about 4 lakh rupees for non-filing of some reports on due dates.
- f. Sri Sadashiva Rao's commitment to ensure acceptance of the Income Tax return was so strong that, he, in spite of his severe illness, pursued it till 17th February 2022, just 2 days before his death on 19th and the most satisfying aspect is that the order accepting the IT Returns for 2014-15 reached him before his admission to the hospital and he had shared his joy with the Secretary.

He was honoured by the Association and CCCGPA at his residence on 21-10-2021 on his attaining 90 years. He attended the last Executive Committee meeting on 12-2-2022, participated in the discussions and gave his advice on issues raised.

Sri Sadashiva Rao's death is a colossal loss not only to the organisations that he had established and headed earlier but also to the Pensioner Community, in consideration of the fact that he was instrumental in drafting the MOA &RR of many pensioners associations and Common Memorandum submitted to 6th CPC. He has left a void that is hard to fill.

The Executive Committee KPTPA expresses its heartfelt condolences and dips its banner in the memory of the departed illustrious leader.

BSR had a reputation of being an excellent workaholic althrough his career while in service and, after retirement, befittingly formed a group along with Sri N. Bhaskaran, who himself was dynamic union leader while in service and founded the Pensioners' Assn. under the banner of Karnataka P&T Pensoners' Association, which has, now, risen to the pinnacle of glory as the years passed by. BSR successfully mooted & encompassed all other Central Pensioners Associations in our state, under one umbrella. He also played a stellar role in unifying all Pensioners' Associations of our country and ecxcellently drafted 'A Common Memoranda' for submission to the 6th Pay Commission constituted by the Govt. of India. He also Spearheaded the meetings periodically held with the CGHS for bettering the medical facilities to the central pensioners. "BSR's role in innumerable other issues in the recent past, with founder-members stepping down, had his hall-mark". Incidentally, BSR's demise is in a way personal loss to me as he had played an important role in detection of mind-boggling fraudulent cases that took place in Mysore RMS, way-back in 1969, when I had a stint as IRM there. Narration of the cases have been scripted in a book, being shorty released for supplementing KPTPA's building fund.

What makes the incident unique is that it was narrated by the driver of MMS van himself. The driver refused to park the van at the backside of the building to facilitate easy loading of mail bags. The issue was escalated to Head of the office and the argument continued. The driver's plea was that it was impossible to take two 90 degree turns within 60 feet to reach the backside of the office building.

This issue was put to rest once and for all, when Sri Sadashiva Rao, the then Sr. Superintendent RMS, visited the office. He asked the driver to get down from the van. The driver did get down wondering what SSRM was up to. Sri Sadashiva Rao got in to thevan and drove the vanto the backside of the building. The driver and the staff were left speechless. After that never in the history of the RMS office drivers refused to drive the MMS van to the backside of the building.

Gol, Ministry of Health and Family Welfare, Department of health and family welfare LOK SABHA, Unstarred Question NO: 639, Answered on 04th February, 2022

"Cashless facilities to CGHS Beneficiaries" 639:Shri Shanmuga Sundaram K. Shri Velusamy P.

Will the Minister of Health and Family Welfare be pleased to state:-

- (a) Whether the Government is aware of the fact that several private hospitals empanelled under the Central Government Health Scheme (CGHS) decided to suspend cashless services to the beneficiaries of the healthcare programme;
- (b) If so, the details thereof and the pending amount to be paid to the hospitals both private and Government category;
- (c) Whether the cashless services to Ex-Servicemen Contributory Health Scheme is also suspended by the hospitals in private sector; and
- (d) The steps taken by the Government to ensure un-interrupted cashless services to the beneficiaries?

ANSWER

The Minister of State in the Ministry of Health and Family Welfare (Dr.Bharati Pravin Pawar)

(a) to (d): Under the Central Government Health Scheme(CGHS), empanelled Health Care Organizations (HCOs) are required to provide cashless facilities to the eligible CGHS beneficiaries. However, there have been reports that some hospitals are not providing cashless facilities. Suitable action is taken against them whenever such cases come to notice. AMRI Hospital, Bhubneshwar, M/s. Charnock Hospitals Pvt. Ltd., Kolkata, Rabindranth Tagore International Institute of Cardiac Sciences, Kolkata and Utkal Hospital, Bhubaneshwar, Fortis Healthcare Limited, Shalimar Bagh, New Delhi and Amar Eye Centre, Naveen Shahdara Delhi have submitted notice to opt out of CGHS.

Under CGHS, during the current Financial Year, HCOs' bills worth Rs. 1200 crore (approx.) have been paid and bills amounting to Rs. 1100 crore (approx.) are received for payment.

Regarding Ex-Servicemen Contributory Health Scheme (ECHS), as per the information provided by the Ministry of Defence, 174 Health Care Organizations (HCOs) have stopped giving cashless services to ECHS beneficiaries.

CGHS is the first contact point health care service- Direct consultation with Specialists in CGHS empanelled Private Hospitals now available to beneficiaries aged 75+ cannot be extended to all beneficiaries. Health Minister's letter dated 24-01-2022 reproduced below.

Dear Shri Ram Niwas Goel Ji,

Please refer to your letter No. F.1(1)/ SVS/2021/1198 dated 15 December, 2021, forwarding therewith a representation received from Shri Samrul Hassan, General Secretary, Retired Government Officials Welfare Society, Delhi regarding extension of facility for all retired employees to visit directly the empanelled hospitals of CGHS without any referral on the pattern of facility given to retired employees of age 75 years and above.

2. I would like to state that Central Government Health Scheme (CGHS) is primarily the first point contact healthcare service, based on the principle of Primary Health Care. The referral service is a part and parcel of the Primary Healthcare. Ideally, the patient has to approach the first contact point which is the CGHS Wellness Centre. Further, the patient may not be able to know the medical aspects of his/her problem. In other words, the single medical/health problem of a patient may fall in the domain of so many medical specialities. Therefore, this option of direct consultation should not be generalized. Otherwise, this may amount to scrapping the primary healthcare system, which is the backbone of healthcare all over the world.

3. However, in emergency, the patient irrespective of his/her age can consult doctors of any hospital (public or private) without referral from CGHS Wellness Centre.

BSNL vide letter under reference (1) above, has extended the CGHS facilities to retired BSNL employees who are in receipt of Central Civil Pension in recognition of their services rendered in DOT/BSNL. Subsequently, vide letter under reference (2), BSNL Management has approved reimbursement of one time payment of CGHS subscription paid by eligible retired BSNL Employees on surrendering their BSNLMRS facility. Vide letter under reference (3) above, CGHS facility has been enumerated as one of medical facility option to eligible retired BSNL Employees. Vide letter under reference (4) above, it was

clarified that there shall be no cut off date for switching over to CGHS i.e. retired employee may opt for CGHS facility at any time.

In this regard, BSNL Management has decided that those Retirees/VRS Optees who have not opted CGHS facility so far, if they switch over to CGHS by 31st March, 2022, reimbursement of one time payment of their CGHS subscription will be paid within one month of submission of their claim in BSNL.

'Samanvaya Kavi' Dr. Chennaveera Kanavi passes away

A prominent figure in modern Kannada literature, often referred to as 'Samanvaya Kavi' (Poet of Reconciliation) passed away in Dharwad on Wednesday the 16th February, 2022 at the age of 93.

Born on June 18, 1928 at Hombal village in Gadag district, Sri Kanavi bloomed into a poet at Karnatak College under the guidance of then principal V.K. Gokak, a Jnanapitha Award winner. He joined the publication wing of Karnataka University as Secretary. He served the university for 31 years and retired as Director of the publication wing in 1983.

Dr. Kanavi's poetic journey began with the publication of 'Kavyakshi' in 1949. Subsequently, he added 25 more collections of poems. Although recognised more as a poet, Mr.Kanavi is also credited with 28 books in other genres.



Dr. Kanavi was bestowed with several prestigious awards at the State and national level, including the Sahitya Academy award, Karnataka Sahitya Academy award, Karnataka Rajyotsava award, and Pampa award.

An introduction on the poet brought out by the Sahitya Academy states: "His poems sing the joys and sorrows, loves and hates, good and evil, which are the stuff of normal human fate. The poems indicate Kanavi's great craftsmanship, linguistic mastery and imaginative insight. Kanavi's poetry is a unique blend of romantic imagination and classical discipline. He is a poet who has lived intensely and passionately recording with rare poetic skill of his life, including mundane events. His sonnets articulate the philosophy of life that accepts life but also questions it critically."

The Kannada literary world has suffered a huge loss in Dr. Kanavi's death. Karnataka Posts and Telecommunications Pensioners' Association pays its respectful homage to the departed "Samanvaya Kavi"

Central Government Holiday in MARCH 2022 Maha Shivarathri : 1st March Tuesday

Legendary singer, Lata Mangeshkar, hailed as the "Nightingale of India" passed away in Mumbai on 6th February, 2022 at the age of 92 years

Lata Mangeshkar was born in Indore and raised in Kolhapur in a musical family.

Her father, Dinanath Mangeshkar, was a towering personality in Marathi theatre. He acted, produced and sang songs in plays that would change the face of Marathi theatre. He was one of the foremost exponents of Natya Sangeet and an accomplished Hindustani classical singer from the Gwalior gharana. He was Lata Mangeshkar's first Guru.

The classically-trained musician rose to fame in India's film industry as a "playback singer", providing the singing voice to Bollywood's movie stars over the course of a career which spanned more than half a century. For decades, the "Nightingale of Bollywood" was the country's most sought-after singer. Audio cassettes with her songs spanning numerous genres were sold in tens of thousands.

The Melody Queen started singing in movies by the age of 13 in 1942. Between 1950 and 2000 she lent her voice to scores of actors in not only Hindi and Marathi movies, but in languages as diverse as Bangla, Assamese, Gujarati, Tamil, Kannada, Telugu and Bhojpuri, among at least 25 others. Over a career spanning many decades, as per an accepted data, she sang close to 30,000 songs.

Lata Mangeshkar received several accolades and honors throughout her career. In 1989 the Dadasaheb Phalke Award was

bestowed on her by the Government of India. In 2001, in recognition of her contributions to the nation, she was awarded the Bharat Ratna, India's highest civilian honour; she is only the second female singer,



after

M.S. Subbulakshmi, to receive this honour.

With the passing away of Lata Mangeshkar, India not only lost one of its most prolific singers, but a musician who transformed the craft of film singing and became a benchmark for successive generations to emulate.

In passing away of Lata Mangeshkar, the country has lost not only one of its most prolific singers but a legendary playback singer, and a towering personality in the world of Indian music and film industry. Her passing away marks the end of an era and has created a void in the world of music.

Age-related Additional Pension

Parliamentary Standing Committee on Personnel, Public Grievances, Law & Justice in its report presented in the Rajya Sabha on 10.12.2021 had recommended that the Govt. should sympathetically consider the demand of Pensioners Associations for payment of 5% additional quantum of pension on attaining the age of 65 years, 10% on 70 years, 15% on 75 years and 20% on 80 years to the pensioners. (Report was published in January 2022 issue of this journal)

As a follow-up, Department of Pension and Pensioners' Welfare vide its letter dated

20-01-2022, addressed to the Department of Telecommunications, Department of Posts, Controller General of Accounts, Ministry of Finance, Controller General of Defence Accounts and the Financial Advisor & CAO, Ministry of Railways has called for information regarding the number of pensioners belonging to the different age groups and the amount of pension paid for December 2021 to work out the financial implications.

We hope that a decision favourable to pensioners will be taken by the government after assessment of financial implications.

Family Pension

Gol, Department of Pension and Pensioners' Welfare letter No.1/4/2021- dated 19th January, 2022 addressed to CMDs of All Pensions Disbursing Banks (Through E-mail)

Payment of family pension in respect of a child suffering from a disorder or disability of mind through the person nominated by the Government servant/pensioner/family pensioner

I am directed to say that in accordance with the Central Civil Services (Pension) Rules, family pension is payable for life, subject to certain conditions, to a child of a deceased Government servant/pensioner, who is suffering from any disorder or disability of mind or is physically disabled so as to render him or her unable to earn a living even after attaining the age of twenty-five years,

- 2. As per Rule 50(9)(h)(iv) of the Central Civil Services (Pension) Rules, 2021 (earlier clause (iii) of second proviso to Rule 54(6) of the Central Civil Services (Pension) Rules, 1972), family pension shall be paid to a son or daughter, who is suffering from any disorder or disability of mind including the mentally retarded, through the guardian as if he or she were a minor.
- 3. Rule 50(9)(h)(vii) of the CCS (Pension) Rules, 2021 (earlier clause (vi) of second proviso to Rule 54(6) of the CCS (Pension) Rules, 1972), however, provides that in the case of a mentally retarded son or daughter, the family pension can be paid to a person nominated by the Government servant or the pensioner, as the case may be, and in case no such nomination has been furnished to the Head of Office by such Government servant or pensioner during his lifetime, to the person nominated by the spouse of such Government servant or family pensioner, as the case may be, later on. The Guardianship Certificate issued under section 14 of the National Trust Act, 1999 (44 of 1999), by a local level Committee, shall also be accepted for nomination or appointment of guardian for grant of family pension in respect of the person suffering from Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities as indicated in the said Act.
- 4. It has been brought to the notice of this Department that in some cases, the Pension

- Disbursing Banks are not allowing family pension in respect of a mentally retarded child through the person nominated by the pensioner or his/her spouse in accordance with Rule 50(9)(h)(vii) of the CCS (Pension) Rules, 2021 (earlier clause (vi) of second proviso to Rule 54(6) of the CCS (Pension) Rules, 1972) in spite of the fact that such nomination has been duly incorporated in the Pension Payment Order issued to the mentally retarded child. These banks insist for payment of family pension through a person having a guardianship certificate issued by a court of law.
- 5. Clause (vii) in the Rule 54(9)(h) of the CCS (Pension) Rules, 2021 is intended to avoid any hassles to the child suffering from a mental disability in obtaining the guardianship certificate from the court and in claiming family pension after the death of his/her parents. As per this rule, a Government servant/pensioner or his/her spouse can nominate a person to receive family pension payable to a mentally retarded child. In cases where such nomination is submitted by a Government servant/pensioner/family pensioner, a guardianship certificate issued by a court of law is not necessary.
- 6. Accordingly, in cases where a nomination made by the Government servant/pensioner/ family pensioner has been incorporated in the Pension Payment Order issued to child suffering from a mental disability, it is incumbent on the Pension Disbursing Banks to disburse the family pension in respect such child through the person so nominated. Insisting for a guardianship certificate by the Banks in such cases would defeat the very purpose of such nomination and would also amount to violation of the statutory provisions of the CCS (Pension) Rules, 2021.
- 7. It is requested that suitable instructions

may be issued to the CPPCs/Pension Paying Branches of your Bank for payment of family pension in respect of a mentally retarded child through the person nominated by the Government servant/pensioner/family pensioner in accordance with the statutory provisions of CCS (Pension) Rules and not to insist for a guardianship certificate issued by a court of law in such cases. All Pension disbursing branches also be asked to acknowledge receipt of these instructions.

8. This issues with the approval of Competent Authority.
