Employees' Association, Cubbon Park, Bengaluru 560001. This report covers some of the events of April 2024 & onwards also.

2. Condolence:

There may be some more deaths during the year, about which the association has no information. The Members of the Executive Committee express their heartfelt condolences to all the bereaved families.

The EC also pays its respectful homage to all Political Leaders, Trade Union Leaders and eminent personalities, who passed away during the year.

2.1 The Scourge called Covid-19: The country went through an awful period during the years 2019, 2020, 2021 and 2022. The scourge called Corona Virus, Covid-19, which killed nearly a million people during the last 4 years, started to see a downward trend during 2023 and almost vanished by the end of the year thereby bringing the life and economic activities throughout the world to normal. The UN World Health Organization (WHO) also declared an end to COVID-19 as a public health emergency.

3. Activities

3.1 Annual General Body meeting 2023:

The 28th Annual General Body Meeting was held on 12.8.2023 at NGO Hall, Cubbon Park, Bengaluru 560001. For the first time in the history of the Association, the General Body was inaugurated by a legal luminary viz. Hon'ble Mr. Justice (Retd) H N Nagamohan Das, the Chief Guest. The AGB was a grand success with a record number of members and guests i.e. about 430. A good number of members from other places in Karnataka and even outside the state were present. On invitation, representatives of pensioners associations, affiliated with CCCGPA also attended.

As usual, the meeting was held in three sessions, morning session, open session and afternoon session.

MORNING SESSION:

The morning session started at 09.45 am under the chairmanship of Shri G Babu, President. At the start, one minute silence was observed in memory of the members, who expired between 1.4.2022 and 31.3.2023. The Secretary specially mentioned Com. K K N Kutty, former Secretary General, NCCPA, who expired on 8.12.2022.

The minutes of the AGB held on 20.8.2022 were confirmed and the Annual Report and Audited Annual Accounts for 2022-2023 were also adopted by general consent.

OPEN SESSION:

The Chief Guest, Mr Justice (Retd.) H N Nagamohan Das, Former Judge of High Court of Karnataka was given a warm welcome by the President, Vice-President, Secretary and others at the Entrance. A standing ovation was given when he entered the auditorium. Shri K B Krishna Rao, Secretary introduced him to the audience. A brief bio-data of the Chief Guest was given. The Hon'ble Judge has delivered a record number of 40,000 judgments; authored many books in Kannada and English; delivered thousands of lectures, among other achievements. The Chief Guest inaugurated the open session and gave a mesmerizing speech, full of information, humour, wit and excellent advice to the elderly. A detailed version of his speech is given in the minutes, published in *Pensioners' Champion*, August 2023. His speech was widely appreciated by the audience.

Mr Justice (Retd.) H N Nagamohan Das was honoured by the President, Vice President, Secretary and other EC members present on the Dais

15 meritorious students of Government Higher Primary School, Yelahanaka and Srimapura, Bengaluru were given cash award by the Chief Guest, who lauded the gesture. 56 pensioners aged 75 years and above were honoured. Shri P Peraiah, the Guest of Honour, Divisional Secretary, All India Postal and RMS Pensioners Association, Prakasham Division, Ongole, A P was honoured.

Shri V Shashidhara, Retd Postmaster, Bhadravati HO was felicitated for his efforts in enrolling a good number of members from Shimoga District. The open session ended with Lunch.

AFTERNOON SESSION:

The afternoon session started at 3.00 pm under the presidentship of Shri G Babu. The Agenda items were taken up.

1) M/S GRSM & Associates was approved as Auditors for 2023-24. (2) Constitution of 8th Central Pay Commission. (3) Payment of arrears of DR for the period from 1.1.2000 to 31.3.2021. (4) Grant of notional increment benefits to those have retired on 30th June/31st December. (5) Restoration of Commutation after 12 years instead of 15 years. (6) Revision of pension of BSNL pensioners from 1.1.2017. (7) CGHS and FMA matters and other issues.

The Secretary gave briefs on all the above with present position and action taken by the Association and also by CCGPA. He also answered various queries from members. The Afternoon session ended at 4.30 pm.

The General Body Meeting 2023 was a great success. The detailed minutes of the meeting was published in *Pensioners' Champion* of August 2023 with many interesting colour photos.

3.2 Revision of pension of BSNL pensioners from 1-1-2017:

It is regretted to report that the demand of BSNL pensioners for revision of their pension with 15 % fitment benefit, after delinking pension revision with pay revision, has not yet been accepted by the government in spite of the relentless pursuit by many BSNL Pensioners' Associations in the country since 7 years. Taking recourse to judicial intervention, All India BSNL Pensioners' Welfare Association filed an application before the Principal Bench of the Central Administration Tribunal, New Delhi on 16-9-2020 vide OA No.100/1329/2020. Sri P Gangadhara Rao, Former General Secretary, AIBSNLPWA & Vice President, CCCGPA, Karnataka is the signatory to the application.

CAT PB Delhi allowed the Application and passed an order on 20.09.2023 directing the Competent Authority to revise the pension and family pension of BSNL pensioners in accordance with the relevant Rules. The order also stated that benefits of revision of pension and family pension as notified by the Central Government on the recommendations of the Pay Commission shall be extended. But DOT has filed a Writ petition before Hon Delhi HC on 21-03-2024 challenging the decision of PB CAT Delhi. However, AIBSNLPWA has filed a contempt petition before the CAT PB on the pension Revision Case which is likely to be heard on 12.07.2024.

4. Charitable works

4.1 Charitable function held on 06.02.2024 at Government Higher Primary School, New Town Yelahanka

This event is held every year at Govt. Higher Primary School, New Town, Yelahanka coinciding with the birthday of Ms. Anisha, grand daughter of Sri S.M.Vittala Rao, former Treasurer and Internal Auditor of K P&T Pensioners' Association. Sri S.M.Vittal Rao, in spite of his advanced age and health condition, evinced interest in arranging the function on a grand scale under the banner of KPTPA. About 120 students of all grades assembled and presented group songs and dances with enthusiasm. A big cake was cut and distributed to students along with pencils, notebooks.

- **4.2** Free lunch was served to the cancer patients at Kidwai Memorial Institute of Oncology, Bengaluru on 17.12.2023 from the donation made by the Association to the Institute.
- **4.3** The Association also donated a sum of Rs.10,000 as financial assistance to Shri J Gopal, Auto Driver who assists the association in dispatch of the journal Pensioners' Champion every month and also in other matters, whenever occasion arises. Shri Gopal has health problems and needs regular treatment.
- **4.4.** Every year, 10 meritorious students of Govt Higher Primary School, Yelahanka are given cash award of Rs.1000/- each. From 2023, the award is extended to a Government school in Srirampura also. A few members have donated money specifically for this purpose. Shri H V Ramanatha, Shri H S Prabhakara, H R Sathyanarayana Rao, Shri H S Manjunatha, Shri V. Gopal Smt. SK Shylaja.

5. Other activities

5.1 Executive Committee Meetings

The Executive Committee of the Association used to meet usually on 2nd Saturday of every month in Pensioners' Bhavan, the Association's own building in Telecom Lay out, off Bengaluru International Airport Road. During the pandemic Covid-19, it was not possible to hold physical meetings during the year 2020. However, as the number of Corona virus infections reduced during 2022, it was decided to hold EC meetings alternatively at Pensioners Bhavan, in the party hall of Shanthisagar hotel in Basaveshwaranagar and also online. Thanks are due to Shri Rangegowda, EC Member for arranging the venue in Basaveshwaranagar free of charges and Shri T V Suryaprakash, Joint General Secretary, CCCGPA and Secretary, Coffee Board Pensioners Association and Shri Viswanatha Rao EC Member for helping the association in conducting the meetings virtually.

In the Executive Meeting held on 11.3.2024, Shri M Ramiah, Ex-Vice President was honoured on his 90th birthday. Shri Ramiah's services to the Association were recalled by Shri G Babu, President and Shri K B Krishna Rao, Secretary. He has donated more than Rs.2 lakh to the building fund. He has written a book, based on his service remembrances and has contributed the whole proceeds from the sale of books to the Association.

5.2 Demonstrations by Pensioners

NCCPA chalked out a four stage programme of action in April 2023, commencing with Dharna at all District Headquarters on 21.4.2023 and culminating with a March to Parliament on 21.7.2023 with a charter of 15 demands. The draft letter, to be submitted to the Hon'ble Prime Minister of India on 21.7.2023, was also published in the journal of April 2023. Accordingly, three members of our Association viz., Shri K R Anatharamu, Treasurer, Shri B Nagarju EC Member and Shri K Anand, member participated in the 'March to Parliament' on 21.7.2023. The report is available in July2023 issue of Pensioners Champion.

As desired by the DoPPW, KPTPA conducted a 'cleanliness drive' near the pensioners' Bhavan, Srirampura, Bengaluru 560064 on 1.10.2023. A 'Swatchatha pledge' sent by the Department was taken by the members present. Some of the residents of the Telecom Layout Residents Welfare Association also joined hands.

A demonstration by CCCGPA was held on 16.2.2024 before Bangalore City RMS office in

response to the call given by Central Trade Unions, New Delhi and NCCPA to support the working class.

5.3 Celebration of Pensioners Day and successful completion of Digital Life Certificate Camps

Pensioners' Day' was observed by the association in collaboration with the Coordination Committee of Central Government Pensioners' Associations, Karnataka (CCCGPA) and its affiliate Pensioners' Associations, on 17th December, 2023 at Udayabhanu Kalasangha, Ramakrishna Ashrama Layout Bangaluru 560019.

Dr.N Jayasankaran, former Vice Chancellor, Kanchi University and Director General, Bharatidasan Institute of Management, was the Chief Guest of the function. He wears many hats. He commenced his speech addressing pensioners as 'young friends', which was appreciated by the audience. Throughout his speech, he held his audience spellbound. A report with his speech can be seen in the December 2023 issue of journal Pensioners' Champion. He was honoured by the President with a shawl and a memento.

An event to celebrate the successful completion of Digital Life Certificate Camps organised by the affiliate associations was also held at the venue. The volunteers involved in the work were introduced. They and many others, who provided support in conducting DLC camps, were also thanked.

6. Our members-their laurels

Shri P. Damodara Bhat, Retd. SSRM, Bangalore Sorting Division and our member, was the recipient of "Anubhav" award 2023 conferred on him by the Department of Pension and Pensioners' Welfare in recognition of his valuable services in the Department of Posts. His write-up about his experience in service, selected for the award, is one of the four out of 1901 entries. The award was presented to Sri Bhat by the Hon'ble Union Minister for Personnel, Public Grievances and Pensions Dr. Jitendra Singh on 23-10-2023 in a glittering "Anubhav Award presentation ceremony" held at Vigyan Bhavan, New Delhi. Shri Bhat is the second recipient of this award among the members of KPTPA. It was previously won in 2020 by Smt.N.Nagalakshmi, Retd., ACAO, O/o the General Manager, Postal Accounts and Finance, Karnataka Circle and Vice President of our Association. The EC is proud of both these members.

Shri Prabhakara, IRS, ALM 2569, brought out the English version of his monograph called "Companimane Shilpigalu", published in 2019. The new English version is titled "Sculptors of Companimane". It was released by Shri Chiranjeevi Slngh, Retd. Additional Chief Secretary to the Government of Karnataka on 9.6.2023. Shri Prabhakara retired as Principal Scientist, National bureau of Soil Survey and Land Use Planning, ICAR, Bengaluru. He hails from a long line of traditional sculptors from Nagamangala.

Shri K K Gangadharan, our member, was awarded with 'Kendra Sahitya Academy prize' in May 2024 for his contribution in translation work. Shri Gangadharan has translated many books and stories from Malayalam to Kannada. The book titled "ಮಲೆಯಾಳಂ ಕಥೆಗಳು" (Malayalam Kathegalu), a translation of selected Malayalam Short Stories of Various Malayalam writers to Kannada by Sri KKG was selected for the prize by a jury of 3 members headed by Dr M S Ashadevi. He also writes columns for Kannada magazines regularly.

6.1 Visit of Trade union leaders to Pensioners Bhavan

- (a) Com K Raghavendran, Secretary General, NCCPA and former Secretary General NFPE, on our invitation, visited Pensioners Bhavan on 01-08-2023. He was extended a warm welcome by the President and EC members of KPTPA. Com S Radhakrisdhna, G S, CCCGPA Karnataka, Joint GS Com T V Suryaprakash and Com Juliana Vincent and a host of other former Union leaders and pensioners were present. Com K R addressed the gathering and spoke on many issues concerning pensioners.
- (b) Com N Bhaskaran, Vetern P&T Trade Union leader, and founder of KPTPA & CCCGPA Karnataka, who built the first building of Pensioners Bhavan, visited Pensioners Bhavan on 30-01-2024 after a gap of nearly 3 years. He was warmly welcomed by the President Sri G Babu, EC Members, former EC members and many pensioners who had assembled to receive him. Com Bhaskaran was honoured by the Circle Union of All India RMS & MMS Employees Union, Karnataka Circle at the venue. Com H S Manjunatha, Advisor KPTPA spoke about Com Bhaskaran's 7 decades long service to Central Govt employees and pensioners.

7. SCOVA:

It is with great pleasure that we announce the inclusion of KPTPA in the Standing Committee of Voluntary Agencies (SCOVA) for the term 2023-2025, which is likely to be extended for another 2 years. This is the third time that DoPPW has given us the chance. Previously, we were in SCOVA in 2005, 2006, 2007, 2008 (first term) and again in 2013, 2014, 2015, 2016 and 2017 (second term). We thank the Department of Pension and PW for this opportunity to represent the Pensioners Associations of Karnataka on the national level. We believe that it is due to the reputation meticulously built over the years by our founders Shri N Bhaskaran and Shri B Sadashiva Rao and also the efforts of subsequent office bearers who resolutely carried forward the legacy of the founders of the association.

After the reconstitution of SCOVA this time, the 33rd meeting was held in New Delhi on 22.2.2024. As always, KPTPA had suggested 12 agenda items for discussion in the meeting. They are (1) Simultaneous issuance of orders on release of both DA and DR; (2) CPENGRAMS: (3) Emoluments for computation of pension in respect of a Government servant, who is on deputation to a higher grade/level; (4) FMA-stoppage by Banks to pensioners of IA&AD, Income tax and Excise and Customs etc. (5) Re-fixation of pension of Pre-2006 pensioners at 50% of the emoluments (last pay drawn) instead of average emoluments and payment of arrears for the period from 1.1.2006 to 31.12.2015; (6) Restoration of Commuted portion of pension after 11 years; (7) Grant of increment to the retiring officials on the date of their retirement if the date falls on the next date of retirement - Amendment to the Rules governing grant of increment and extension of the benefit to pensioners as a one-time measure; (8) Fixation of notional pay with reference to pay level of the post from which the pensioner had retired; (9) Revision of pay scales of Inspector and Superintendents of Central Board of Indirect Tax and Customs, Department of Revenue; (10) SAMPANN- Non indication of DR paid on age-related additional pension in SMS on pension credit to DoT pensioners -SAMPANN; (11) CGHS-One time option to CGHS beneficiaries to choose their ward entitlement based on their NOTIONAL PAY in 7th CPC Pay Matrix. (12). CGHS Issues which call for immediate attention and remedial actions. Three most daunting issues being faced by the CGHS beneficiaries (1) Shortage of Doctors, Specialists and Para-Medical Staff; (2) Not opening of new CGHS Wellness Centres despite justification; (3) Non Revision of CGHS rates since a decade. Details are given in the December 2023 issue of the journal Pensioners Champion.

Smt. N.Nagalakshmi, Vice President of the Association attended the SCOVA meeting held on 22.2.204, representing KPTPA. We are grateful to the DoP&PW for including 5 fresh items suggested by KPTPA among the 10 fresh items taken up for discussion in the SCOVA meeting. They are (1) Grant of increment to the retiring officials on the date of their retirement if the date of increment falls on the next date of retirement- Amendment to the Rules governing grant of increment and extension of the benefit to pensioners as a one-time measure; (2) One time option to CGHS beneficiaries to choose their ward entitlement based on their NOTIONAL PAY in 7th CPC Pay Matrix; (3) Non-revision of CGHS rates; (4) Provision in CPENGRAMS for entering address of grievance registering Pensioners' Associations and (5) Non-indication of DR in SMS sent to DoT pensioners in SAMPANN. Smt.Nagalakshmi put forth arguments on the issues. Assurance was given by the concerned Departments to consider the demands raised by KPTPA. She also met officers and discussed issues not relating to SCOVA. It is hoped that more problems will be discussed and solved in the coming meetings.

8. Pensioners' Welfare Activities

- **8.1** The Government ordered in April 2023 that a Committee to review the National Pension System (NPS) is formed.
- **8.2** In response to a letter to the Secretary, Department of Posts in September 2023, it is ordered that DR arrears will be credited to the pensioners of Postal Department, drawing pension from Post Offices, before month end i.e 'Off Cycle Payment'.
- **8.3** A new mobile phone is purchased by the Association exclusively for financial transactions of the Association. A QR code has been created to facilitate easy transfer of money to the Association's bank account by members through Google Pay /Phone Pay.
- **8.4** A meeting of all pensioners of Railway Mail Service and Mail Motor Service, called 'Madhura Milana' was held on 7th January 2024. This has been going on since 2 decades on first Sunday of January. This is being organized by a separate body consisting of senior pensioners headed by Shri H V Ramanatha, Shri C S Parthasarathy and Shri K K Gangadhara. The pensioners aged 75 and 80 years were felicitated. Shri K B Krishna Rao, Secretary, KP&TPA, presided over the function and gave a speech, which was informative and answered questions from pensioners. Many pensioners enrolled themselves as members of KPTPA.

9. Assistance to pensioners for submission of their life certificate in October/November, 2023-Yeomen service by the members of the assn.

KPT&PA and Coffee Board Pensioners Association headed by Shri T V Suryaprakash as its Secretary jointly organized 33 camps in November 2023 to assist pensioners in submitting Digital Life Certificate. 25 volunteers Viz. S/s. T .V. Suryaprakash, K.R.Anantha Ramu, V. Murugan, B. Nagaraju , R.S.N.Murthy, D. Venkatesalu, N.M. Hegde, V. Gopal , Vishwanatha Rao, K. Nagesh, S. Kasirajan, A. Prakash, N. R. Anantha, S.N.Hiremani, K. Anand, H. S. Ramesh Babu , B. A. Suryaprakash, M. B. Shivalingaiah, K. B. Krishna Rao, S. Radhakrishna, H. R. Shamasundara, S.Rajasekhara, H. S. Rajendra, Chandrasekhara, and N. Prakash generated 3467 DLCs up to 31-03-2024. They were in 33 camps in Bengaluru, Mysuru, Tumakuru, Hasana, Chikkamagaluru and Shivamogga. They also made 1200 visits to the pensioners' homes, old age homes and hospitals in Bengaluru and other places like Nanjanagudu, Channapatna etc. Both the Associations have been rendering this service for the past three years and are conducting DLC camps in which

a good number of pensioners attend to submit their DLC. Year by year, the number of volunteers is increasing and, consequently, the number of DLCs generated also. No other Pensioner Association has made such huge efforts. This service is totally voluntary and not confined to members. The volunteers bear the cost of conveyance to camps and homes on their own wherever they are called, often till late hours. The face recognition App introduced in 2022 with Android mobile phones, has made the task easy. In fact, anybody can generate DLC with this App. However, the help given by us is highly appreciated by all pensioners.

On 4.11.2023, DoPPW as a part of its Digital Life Certificate Campaign in the country had called for a meeting of pensioners at State Bank of India, Avenue Road, Bengaluru. Shri V Srinivas, IAS, Secretary DoPPW, along with three officers, attended the meeting. The Digital Life Certificate campaign progress was reviewed. Shri G Babu, President, Shri K B Krishna Rao, Secretary, KPTPA, along with some members, attended the meeting. Shri Rao, in his speech, highlighted the remarkable results of DLC camps and home visits by KPTPA and CBPA. Shri V Srinivas, Secretary, DoP appreciated our efforts. A DLC Camp was also organized at the venue.

As mentioned above, all the volunteers were felicitated by CCCGPA also at its Silver Jubilee Celebration on 2.8.2023 and also thanked at the 'Pensioners Day' function on 17.12.2023. Out of conveyance amount sanctioned by DoPPW for DLC assistance, travel expenses borne by Coffee Board Pensioners Association for the camps outside Bengaluru, was partly reimbursed through Shri T.V.Suryapraksh, Secretary, CBPA. Though the CBPA did not want to accept it, saying that it was a voluntary service, it was insisted upon, as the expenses ran to thousands. Like all previous years, all volunteers of KPTPA donated the whole amount to the Association.

10. Long pending demands

The following demands are being pursued by the association with the government in coordination with NCCPA and CCCGPA.

- (a) Release of DA/ DR frozen for 18 months from 1-1-2020 to 30-6-2021
- (b) Restoration of Commutation after 12 years
- (c) Enhancement of Fixed Medical Allowance from Rs.1000 to Rs.3000
- (d) Grant of notional increment for retirement benefits to pensioners who retire on 30th June/31st December, a day before their date of increment
- (e) Commencement of age-related additional pension at the age of 65 years instead of 80 years as recommended by the Parliamentary Standing Committee
- (f) MACP from 1-1-2006 instead of from 1-9-2008
- (g) Constitution of 8th Central Pay Commission to be given effect to from 1.1.2026, though in February 2024, the Government, in reply to question in Parliament, has stated that there is no proposal to form 8th CPC.

11. Grievances of Pensioners

Grievances of some of our members were taken up with the authorities concerned and were mostly settled to the satisfaction of the pensioners/ family pensioners. We are happy to note that members always appreciate our efforts and some of them have even donated to the building fund voluntarily as a token of their gratitude. During the year, apart from grievances on pension, we pursued matters relating to non grant of financial upgradation under MACP Scheme and erroneous recovery of SLF (Rent).

12. Affiliations

The Association is affiliated to National Coordination Committee of Pensioners Associations (NCCPA), Bharath Pensioners Samaj, New Delhi (BPS), All India Federation of Pensioners Associations, Chennai (AIFPA) and Co-ordination Committee of Central Government Pensioners' Associations, Karnataka (CCCGPA).

12.1 NCCPA: National Executive Committee of NCCPA was held at New Delhi on 26.6.2023. Shri V Murugan, Joint Secretary represented the Association in the meeting. The pending demands were discussed.

All India Conference of NCCPA was held at Chennai on 13/14.12.2023. Smt. N Nagalakshmi, Vice President, Shri M B Shivalingaiah and Shri V S Naik, members attended on behalf of the Association. Smt. Nagalakshmi gave a speech. In the election to the Executive Committee for the period 2024-2026, the following from Karnataka were unanimously elected. 1) Shri K B Krishna Rao, Secretary KP&TPA as Vice President; 2) Shri S Radhakrishna, Secretary, IA&ADPA as Assistant Secretary general and 3) Shri T V Suryaprakash, Secretary, Coffee Board Pen Assn as Ex-Officio in EC. All the three are office bearers of CCCGPA also.

- **12.2** All India Federation of Pensioners Associations, Chennai: The Annual General Body of AIFPA was held Chennai on 22.7.23. Shri V Murugan, Joint Secretary attended it on behalf of the Association.
- 12.3 The Asian Continent Regional Conference of Trade Union International (TUI) (Pensioners and Retirees) held at Tiruvanantha puruam on 1-10-2023

Shri C Ramakrishna Reddy, EC Member and Shri K Ananda, Member represented the Association in the conference

12.4 Coordination Committee of Central Government Pensioners Associations, Karnataka: This year, CCCGPA celebrated its Silver Jubilee on 2.8.2023 at Kaveri Hall, Central Revenue Building, Queens Road, Bengaluru. Com. K Raghavendran, Secretary General, NCCPA was the Chief Guest. The founders and ex-office bearers were felicitated. The members of KP&TPA and CBPA, who worked as volunteers in assisting pensioners to generating DLC were also honoured. A booklet about CCCGPA was released by the Chief Guest. Election to the Management Committee was held for the next two years 2024-2026. Shri K B Krishna Rao was re-elected as President.

As per the new by-law, 3 members of KPTPA are to be in the Management Committee of CCCGPA. Besides Shri K B Krishna Rao, Secretary, KPTPA, who is the President of CCCGPA, Shri V.Murugan, Joint Secretary and Shri K R AnanthaRamu, Treasurer were nominated.

13. CGHS matters

Dr. Vijayalakshmi Mohan has assumed charge as Additional Director, CGHS on 21.7.2023.

- **13.1 CGHS WC at Mysuru**: A CGHS wellness centre has already been opened in Mysuru in 2022.
- 13.2 CGHS WC Extension Counter at Hubballi: CGHS Bangalore has received instructions from CGHS Directorate, New Delhi to open extension counters in Hubballi .On request by the Additional Director CGHS Bengaluru, CCCGPA Karnataka has formed a Committee of 6 pensioners in Hubballi to coordinate with CGHS in finding a suitable building for the Wellness Centre. Hubballi

- -Dhrawad Corporation has offered to accommodate the WC in its new building under construction. It is understood that the building construction is nearing completion and the WC opened shortly.
- 13.3 CGHS WC s at Mangaluru, Udupi & Shivamogga: The Government has agreed in principle to open CGHS WCs in 20 cities across the country including Mangaluru, Udupi and Shivamogga in Karnataka. It advised AD, CGHS, Karnataka to visit the 3 cities. As per request by CGHS, KPTPA furnished the details of Central Government Employees and Pensioners residing in the 3 cities and also nearby places. A team led by Dr.Vijalakshmi Mohan, AD visited Mangaluru and Udupi on 19.1.2024 and Shivamogga on 24.1.2024. CCCGPA requested their affiliate Pensioners' Associations in these 3 cities to assist the CGHS team, showing likely buildings to house the WC. AD, CGHS appreciated the help given by them. All the information collected has been furnished to CGHS Directorate and further directions are awaited.
- **13.4 CGHS WC Extension counter at Sahakaranagara**: An extension counter of CGHS has been opened in Sahakaranagara, Bengaluru on 15-4-2024. KP&TPA has written to the CGHS to open a full-fledged wellness centre there instead of an extension counter. CCGPA has also written to AD, CGHS regarding the need for more wellness centres in Bengaluru city, furnishing statistics.
- 13.5 CGHS Package Rates: Through the demand for revision of CGHS package rates is pending for long and assurance was also given about revision without delay in February 2023, there is no action. But, Directorate General of CGHS vide its order dated the 12th April, 2023 revised rates only in respect of the following: (a) Consultation fee OPD Consultation Rs. 350/- IPD Consultation Rs. 350/- (b) ICU Charges Rs. 5400/- for all categories of ward entitlement and (c) Room Rent General ward Rs.1500/- Semi-private ward Rs.3000/- Private ward Rs. 4500/-. Subsequently, rates of some tests & procedures were also revised.
- 14. Our role in connection with "Pensioners' Portal" and relationship with Dept of Pension and Pensioners' Welfare.

KP&TPA is one of the 5 associations in Karnataka identified by DoPPW under National e-Governance Plan (NeGP). The association gets an annual grant of Rs.75,000/-.

We have been maintaining a cordial relationship with the Department of Pension and Pensioners' Welfare. Pension Department has been holding virtual meetings at regular intervals with the pensioners associations and has been enlightening the associations with the provisions of rules on pension and family pension and the latest amendments to Pension Rules.

15. Our Website

The Association has its own website www.kptpa.org. It has been maintained for the last 12 years now. The journal *Pensioners' Champion* and other important orders are being uploaded every month. From September 2020, the website is being maintained by the Association itself. List of donations for the building fund received up to 31-3-2024 has been uploaded. We request our members to visit the site regularly and suggest improvements.

15.1 Whats App Groups: Three WhatsApp groups viz. kptpa, KP&T Pen Asssn-Gp 1 and Gp2, have been created to which the monthly journal and other orders are being regularly posted. Information on pensioners' welfare is also often posted in the groups. At present, there are *1000* members in these 3 groups. We are making efforts to include the mobile phone numbers of the entire 1500 members whose phone numbers are now available with us. We request other members

also to join the group by sending a WhatsApp message to our EC member Sri K Nagesh:9448705268 or to Sri Viswanatha Rao:9343518849 giving their name, membership no. & WhatsApp ph no.

16. Our Publication- Pensioners' Champion:

The Association's monthly journal titled *Pensioners' Champion* is highly popular. Matters relating to central government pensioners find a place there, like the government orders on pension, D R orders, report on SCOVA / JCM meetings, court orders on pension, report on the activities of sister pensioners' associations etc. Besides, information about Autonomous body pensioners, BSNL, CGHS, Obituaries and the feedback from readers in the column 'Our Readers Write', list of holidays and Consumer Price Index are some of the regular features. A new column "Question Corner" has been introduced from January 2023 to provide a facility to our readers to write to us on issues regarding pension, family pension and other pensioner related issues on which they need some information/clarification.

Names of the new members, lists of renewal of subscription and donation received for the building funds are integral parts of the journal. About <u>1800</u> copies are mailed, which includes about <u>180</u> non-member subscribers. Many Pensioners from other states have also been subscribing for the journal regularly for years. The individual achievements of the members in areas like literature, art, social service are also reflected in the journal from time to time. There may be more such pensioners. We request members to report such things to the Association for publishing.

16.1 Subscription for the journal and its renewal

Annual subscription for the journal (July to June) is Rs.180/- in respect of members and Rs.240/-in respect of subscribers to the journal. Though there has been a good response to our appeal for renewal of subscription every June, we find that many of our members have not renewed their subscription for many years. Still, we continue to send them the journal. We are spending a huge amount monthly on printing and posting of the journal especially due to the revision of printing charges in 2022-23. While we thank all those who have renewed their subscription, we request others who have not yet renewed their subscription to renew it now.

17. Membership and Finance

17.1. Membership

It is a matter of pride that our membership is increasing every month with the addition of at least 8-10 new members every month. During 203-24 a record number of 189 members were enrolled. This feat was possible only because of the initiative taken by the EC Members Viz. S/s C Ramakrishna Reddy, M B Shivalingaiah and other Members Viz. S/s K Anand, M Ramakrishna, A. Deepak, V Shashidhara and Narasimha Aithal of Shivamogga, S Rajashekhar of Mysuru ,who held meetings with their former colleagues and prevailed upon them to get membership of KP&TPA. Smt. Nagalakshmi, Vice President is also taking special interest in

enrolling members. We are happy to announce that the membership crossed 3500 this year. We request all the members to persuade their pensioner friends, retiring from Central Government to join the Association. Pensioners of Central Government Autonomous bodies like Kendriya Vidyalay, NIT, IIT etc, are also eligible for membership. The membership form can be downloaded from our website and the filled up form emailed to us with the membership fee transferred online. However, a confirmation copy also has to be sent by post.

17.2 Finance

We are receiving a good amount of donations from the members and well-wishers regularly. 1st floor of the old building of 'Pensioners' Bhavan' and both the floors of the new building are let out. The rents from it, the interest from the fixed deposits and liberal donations from members have enabled the Association to manage its financial position. We are glad to say that members are continuing to donate for the building fund. It is heartening to note that 14 of our members have donated Rs.1,00,000/- and above to the building fund. Donations made by Shri M. Ramiah, former Vice President and Permanent Advisor to the Association, increased to Rs.2, 02,020/-(Rs.Two Lakh, Two thousand and Twenty) in April,2023. Shri M. Ramiah is the first member of the association to donate more than Rs.2,00,000. Another member, Shri Mahadevappa M Hanji, LM 1286, has also donated in total Rs. 2,50,000 (Two lakh fifty thousand). Our heartfelt thanks to them and all the donors.

17.3 Donations for Educational purposes: Some of our members Viz. S/s H V Ramanatha, H S Manjunatha, H R Sathyanarayana, Smt. Shylaja H S Krishnamurthy Rao, K G Kulkarni, M Ramaiah and V Gopal have donated liberally to the Education fund, which facilitates the association in giving away cash awards to the meritorious students of Govt Schools every year. We sincerely thank all these individuals. We have kept these amounts in a separate fixed deposit and propose to utilize the interest earned only for charitable purposes.

The Association is considering construction of 2nd floor in Pensioner Bhavan. The details and finance etc., are to be worked out. We are thankful for any donation made by you.
