#### INDEPENDENT AUDITOR'S REPORT

#### **Opinion**

#### **Basis for Opinion**

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

## Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation of the financial statements in

accordance with The Karnataka Societies Registration Act, 1960 and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the entity's financial reporting process.

### Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Identify and assess the risks of material misstatement of the financial statements. whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

\* Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the entity to cease to continue as a going concern.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

#### CGHS

Shri R.N. Parashar, Secretary General, Confederation of Central Government Employees and Workers, New Delhi and Shri K.K.N. Kutty, Secretary General, National Coordination Committee of Pensioners Association(NCCPA) met Shri Alok Saxena, Additional Secretary, Ministry of Health & FW on 21.06.2022 and discussed with him the following issues

- Delay in payment due to empanelled hospitals, consequent upon which the hospitals have withdrawn from the CGHS.
- (2) The need to revise CGHS package rates, which were fixed in 2014
- (3) Non-availability of reputed hospitals in many towns in the list of CGHS empanelled hospitals
- 4) The need to decide expeditiously over the health insurance scheme, especially for the pensioners who stay in non-CGHS areas
- (5) Extension of CCS (MA) Rules to pensioners who are not covered by CGHS.
- (6) Need to increase FMA.
- (7) Delay in reimbursement of expenses incurred by the pensioners for medical treatment in private hospitals in emergency
- (8) Holding meeting of the National Council, JCM on health related demands.

The Additional Secretary said that the delay in payment to empanelled hospitals had been due to a hitch in the system that has come about on account of the change in the vendors. The issue is being addressed and the same would be sorted out in a month's time. He also said that instructions have been issued to the CGHS authorities, to settle the claim of the beneficiaries who have availed treatment in empanelled private hospitals in emergency, restricting the entitlement to CGHS rates. Regarding the complaints of beneficiaries on restricting their reimbursement claims, he explained that some of the rates charged by the Private Hospitals are exorbitant and would be difficult to accept. Regarding revision of rates, the technical committee of Health Ministry had been periodically reviewing these rates and wherever they had suggested for revisions, the same had been done. In respect of other issues discussed, he assured the delegation that on receipt of the request from the Secretary Staff Side the meeting of the committee would be convened as quickly as possible.
