## **Agenda items for the 34th meeting of SCOVA schedule to be held on 11.03.2025**

Reference: Your email/letter dated 20-2-2025

Karnataka Posts and Tele-communications Pensioners' Association, Bengaluru, a member of the SCOVA, would like to propose the following items/issues for inclusion in the Agenda for discussion in the 34<sup>th</sup> meeting of SCOVA being held on 11-03-2025. We request that the items suggested by us may please be included in the Agenda.

**1) Issuance of a revised OM regarding grant of notional increment to pensioners who had retired on 30th June or 31st December for its strict implementation by all concerned Departments consequent upon dismissal of both the pending petitions by the Hon'ble Supreme Court.**

The Hon'ble Supreme Court on 20-2-2025 DISMISSED the Miscellaneous Application MA 000347/2025/ Dairy No.2400/2024- filed on 16-01-2024 - Union of India Vs M.Siddaraj

The Hon'ble Supreme Court in its

interim order dated 6-9-2024 passed in MA Dairy No.2400/202 (SLP No. (C) 4722/2021) had stated that "the interim order will continue till further orders of this Court".

The Department of Personnel & Training in its OM No. 19/116/2024-Pers.Pol.(Pay) (Pt) dated 14-10-2024, issued in implementation of the Interim Order of the Supreme Court, had stated that "It may also be noted that these instructions are being issued in compliance of the Interim Orders dated 06.09.2024 of the Hon'ble Supreme Court in MA Dy.No. 2400/2024 without prejudice to the legal stand of the Union of India in the matter and without prejudice to any change of law in this regard. Further, the action taken shall be subject to the final outcome of the Review Petition (Dy.No.36418/2024) pending before the Hon'ble Supreme Court"

Since DOPT OM dated 14.10.2024 was issued with a rider as stated above, it is given to understand that the OM has not yet been implemented by many Pension Sanctioning Authorities (PSAs) / Pay & Accounts Offices (PAOs) and some of them have sought clarifications from their Administrative Departments.

It is pertinent to mention here that the Hon'ble Supreme Court while hearing the Miscellaneous Application Dairy No.2400/2024 - Union of India Vs M.Siddaraj, which came up for hearing on 13-12-2024, while adjourning the

case to the week commencing from 10-02-2025, has observed as follows *“However, we observe that the applicant Union of India must comply with the interim order passed by this court. In case we find non-compliance with the said order in letter and spirit, **cost as well as interest may be imposed.***

**Legal position as it stands now is that:**

(1) Review Petition(C) Dairy No. 36418/2024 filed by the Director, KPTCL Vs C.P. Mundinamani was **DISMISSED** by the Hon'ble Supreme Court on 18-12-2024

(2) Diary.No.2400/2024, MA000347/2025, Union of India Vs M.Siddarj was also **DISMISSED** by the Hon'ble Supreme Court on 20-2-2025

In view of the Orders made by the Hon'ble Supreme Court passed on 18-12-2024 and 20-2-2025 **DISMISSING** both the petitions pending before it, detailed above, the decks are now cleared to allow the increment **without any conditions**, on 1st July/ 1st January to the Central Government employees who retired/ are retiring a day before it became due i.e. on 30th June/31st December and have rendered the requisite qualifying service as on the date of their superannuation as per DOPT OM dated 14.10.2024.

Therefore, It is, strongly urged that another OM with **CLEAR INSTRUCTIONS**, in continuation of the OM dated 14.10.2024, may please be caused to be issued immediately to all the Departments to grant notional increment for pensionary benefits to all eligible pensioners without seeking any more clarifications in the matter as the issue has attained legal finality after dismissal of the pending petitions by the Appex Court.

**2) Grant of notional increment for pensionary benefits to pensioners who had retired on 30th June, 2006, after implementation of 6<sup>th</sup> CPC report.**

A uniform date of increment 1<sup>st</sup> July was introduced from 2006 in accordance with the recommendations of the 6<sup>th</sup> CPC- vide Rule 10

of CCS(RP)Rules 2008. The first increment after fixation of Pay on 1-1-2006 in the revised pay structure was granted from 1-7-2006 for those employees for whom the DNI was between 1-7-2006 and 1-1-2007.

Subsequently, vide MOF, DOE OM No.10/02/2011-E-III/A dated 19-03-2012, in relaxation of the stipulations under Rule 10, those employees who were due to get their annual increment between February and June during 2006, were granted one increment on 1-1-2006 in the Pre-revised Pay Scale and the next increment in the revised pay structure was granted on 1-7-2006 on a par with those employees whose increment in the pre-revised pay scale was on 1-1-2006 .

Consequently, those employees who retired on 30-6-2006, who would have drawn their next increment on 1-7-2006, if they had not retired on 30-6-2006, are also eligible for grant of notional increment in accordance with Para 7 of DOPT OM No. 19/116/2024-Pers.Pol.(Pay) (Pt) dated 14-10-2024 reproduced below as they satisfy the condition for drawal of their next increment :

**Extract of Para 7 of DOPT OM 14-10-2024**

*“The matter has been examined in consultation with D/o Expenditure and D/o Legal Affairs. It is advised that in pursuance of the Order dated 06.09.2024 of the Hon'ble Supreme Court referred above, action may be taken to allow the increment on 1st July/ 1st January to the Central Government employees **who retired/are retiring a day before it became due i.e. on 30th June/31st December and have rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct for calculating the pension admissible to them.** .....*”

In accordance with the above instructions, those employees who retired on 30-6-2006 are entitled for grant of notional increment for pensionary benefits as they retired a day before it became due on 30th

June 2006 and have rendered the requisite qualifying service for grant of next increment on 1-7-2006 but for their superannuation

Therefore, It is, strongly urged that a new OM with instructions to grant notional increment to employees who retired on 30-6-2006, as they too had the requisite qualifying service for grant of their next increment, may please be caused to be issued immediately to all the Departments so as to clear any doubts that the Departments might have in this regard.

### **3) Upgrading BHAVISHYA PORTAL to allow grant of notional increment and revision of pension**

It is understood that in case of pensioners of Civil Departments in whose cases the Pension Payment Order (PPO)/ Special Authority (SSA) are authorised by the Central Pension Accounting Office (CPAO) the OM dated 14-10-2024 of DOPT is not being implemented because of software issues. In case of pensioners of Civil Departments, all pension cases including revision cases have to be processed through BHAVISHYA portal. The problem that is being reportedly faced by the Departments concerned for including the notional increment for calculation of pensionary benefits is that the software BHAVISHYA is not allowing inclusion of notional increment for the calculation of pensionary benefits. Further, BHAVISHYA was introduced in the year 2020. The data of pension cases prior to the year 2020 is not uploaded to the BHAVISHYA portal.

As a result, the provisions of DOPT OM dated 14-10-2024 are not implemented in Civil Departments. It is, therefore, requested that the following action may please be taken in this regard by DOPT, Department of Pensions, CGA and CPAO:

- 1) Those who retired prior to 2020; Manually
- 2) "BHAVISHYA" may be upgraded for including the calculation of pensionary benefits by including notional increment.

### **4) Introduction of a SOP for family pension in respect of members of the extended family and issue of a general instruction on processing of such family pension cases.**

It is understood that at present a common procedure is not being followed by the Pension Sanctioning Authorities in processing of the family pension cases of members of the extended family of an employee/pensioner, Viz. Unmarried Dependent son below 25 years of age, Disabled Children, Unmarried, Divorced and Widowed Daughters, Dependent Parents, and Disabled Siblings etc. and they either demand documents not listed in from 10 or reject documents submitted with the application form for family pension. Income certificate issued by the Revenue Authorities for establishing the applicant's Dependency criterion is also being rejected which is causing not only great inconvenience to the applicants but also results in delay in sanction of family pension to such family members.

It is, therefore, requested that a SOP / questionnaire commonly applicable to all Pension Sanctioning Authorities of all Departments to be strictly followed by them may please be issued at the earliest

### **5) Opening of more number of CGHS Wellness Centres in Bengaluru City**

There is every justification for opening at least 5 more CGHS WCs in Bengaluru City.

We submit the following information about the justifications for opening of wellness CGHS centres in Bengaluru based on the data obtained from CGHS website.

1) CGHS cards registered in Bengaluru is now around 64,500 and the number of beneficiaries 1,65,000 and the city is the sixth largest in the number of card holders and beneficiaries in the country after Delhi, Mumbai, Kolkata, Hyderabad & Chennai .

2) The number of CGHS beneficiaries in Bengaluru city has almost doubled. During the year 2013 it was 96,000 now increased to 1,65,000 beneficiaries as on Feb 2025 with

about 8% increase annually, whereas the number of CGHS wellness centres which was 10 in the City in the year 2013 has remained the same even though the increase in number of CGHS beneficiaries in the last decade is manifold.

3) Bengaluru city has the highest number of card holders attached to a wellness centre in the country. In Bengaluru many wellness centres are having more than 7000 cards per wellness centre. The average number of cards per wellness centre in Bengaluru is 5000 whereas in other cities of the country it is in the range of 2000 to 5000.

4) Such large number of beneficiaries attached to each WC has resulted in deficiency of medical services provided to the beneficiaries and therefore there is an urgent need to open 5 more number of wellness centres in Bengaluru city and one Polyclinic

It is suggested that new wellness centres may be opened in the following areas of Bengaluru city.

- 1) Yelahanka or Sahakaranagar in the North.
- 2) RR Nagar on Mysore Road or Tumkuru Road in the west
- 3) Ramamurthy Nagar / Whitefield in the East.
- 4) HSR layout / Hosur Road in South- east
- 5) Kanakapura Road in the south

#### **6) Opening of CGHS WCs in Mangalore, Udupi, and Shivamogga cities of the state of Karnataka**

Health Ministry / CGHS Directorate have agreed in principle to open CGHS WCs in Mangaluru, Udupi, and Shivamogga. Statistics collected by COC-K and CCCGPA have already been submitted as per which there is justification for opening of WCs in these 3 cities. It is requested that the issue may please be strongly pursued further.

#### **7) Opening of full-fledged CGHS WC at Shakaranagara, Bengaluru instead of the existing extension counter.**

Due to shortage of Doctors and Pharmacists, the extension counter is **not**

**functioning** on all the 6 days of the week. Most of the days it is closed. Even when a doctor is available for consultation, in the absence of a pharmacist, beneficiaries are forced to collect the medicines from the Pharmacy at WC 9 Gangenahalli which is at about 5 km. from the extension counter, thereby defeating the very purpose of opening a CGHS WC Extn counter at Sahakaranagar. Hence, it is strongly urged that a full-fledged CGHS WC be opened at Shakaranagara, Bengaluru instead of the existing extension counter.

#### **8) Opening of a full-fledged CGHS WC at Hubballi instead of an extension counter.**

The CGHS extension counter to Hubballi sanctioned more than a year ago has not yet been opened. As opening of an extension counter is sure to create staff management problems (as it is now happening at Sahakaranagar, Blore), it is strongly urged that a full-fledged CGHS WC may be opened at Hubballi instead of an extension counter.

#### **9) Revision of Family pension after allowing notional increment for pension in accordance with DOPT OM dated 14-10-2024**

The Department of Personnel & Training, vide Para 7 of its OM dated 14-10-2024 on the subject of grant of notional increment on 1st July /1st January to the employees who retired from Central Govt. service on 30th June/ 31st December respectively, has stated that :

“the notional increment on 1st January/ 1st July shall be reckoned only for the purpose of calculating the pension admissible and not for the purpose of calculation of other pensionary benefits”

Since the family pension is calculated at 30% of the last pay, the family pension must also be revised with reference to the last pay which is revised after granting the notional increment for pension. Family pension cannot be looked in isolation, as it is also calculated like pension on the last pay but at a different percentage.

It is, therefore, earnestly requested that necessary O M in this regard may kindly be caused to be issued at the earliest.

**10) Revision of Commutation after allowing notional increment for pension in accordance with DOPT OM dated 14-10-2024**

Since commutation value payable is calculated at 40% of the pension, commutation

also requires to be revised with reference to the pension revised after granting the notional increment for pension.

It is, therefore, earnestly requested that necessary instructions to all PAOs may kindly be caused to be issued by DOPT in this regard at the earliest

## **Grant of increment for pensionary benefits to those pensioners who had retired on 30th June/31st December**

We are extremely glad to inform our members that the Respected CPMG, Karnataka Circle, has favourably considered our request made in our memorandum submitted to him by our Vice- President Smt. N.Nagalakshmi and EC Members S/S C Ramakrishna Reddy and K Nagesh on 30-12-2024, [published in pages 8&9 of our journal Pensioners Champion- January 2025 issue] wherein we had sought his personal intervention to advise all Pension Sanctioning Authorities in Karnataka Circle to initiate immediate action for grant of increment for pensionary benefits to those pensioners who had retired on 30th June/31st December after rendering the requisite qualifying service for earning their Next increment on 1st July/1st January but retired a day earlier than their DNI.

CPMG, vide letter No.AP/MISC/Dlg/2024/Grant of Notional Increment dated 24-02-2025 addressed to our association, (Reproduced in page 12) has instructed all the Heads of Regions, viz. BG HQ region, South Karnataka Region and North Karnataka Region to advise all Heads of Divisions in the circle viz. SSRM, SRM, SSPOs & SPOs to process the cases of all eligible pensioners and forward the same to Postal Accounts for further action. The letter also states that O/o the G M Postal Accounts & Finance is initiating necessary action in this regard.

Circle Office has also asked us to intimate the pensioners to contact the Divisional Office from which they had retired and to request

the DO that their case may be processed and forwarded to the G M Postal Accounts & Finance Karnataka Circle for further action.

We had posted in our WhatsApp groups, draft of a request letter to be submitted by the eligible pensioner to their Pension Sanctioning Authority ie. the Head of the Division from which they had retired.

We are extremely grateful to the Respected, CPMG, all the Officers and Staff of the CO for agreeing to our request, which will go a long way in helping such pensioners to get higher pension after grant of an increment and revision of their pension.

**PS : We are glad to note that many Divisions have sent the revised pension calculations to the GM(PAF), Karnataka Circle and in some cases revised PPOs have also been issued by the O/o the GM(Postal Accounts). Our grateful thanks to the Heads of Divisions and the Officers of the O/o GM(PAF).**
