# CGHS Wellness Centre for Mysuru Saga of a relentless struggle

In 1961, when USA President John F. Kennedy was embarrassed by the failed attempt to invade Cuba, he is believed to have made a famous comment "victory has a hundred fathers and defeat is an orphan." The adage attributed to Kennedy is also referred to as "Success has many fathers and

defeat is an orphan". The proverb "Success has many fathers" also means that many people have contributed to a successful endeavour, not just the person who is either given or claims the credit for it. Without pun or sarcasm intended, this proverb can very well be quoted while writing about the saga of the relentless

struggles waged by different Pensioners Associations and individuals in turning to reality the 2 decade old dream of getting a CGHS Wellness Centre to the Cultural city of Karnataka 'Mysuru'.

Yes, the success, in achieving this justified demand is, as the proverb goes, has 'many fathers' and is undoubtedly attributable to the joint efforts of individuals and organisations who, over the past several years, left no stone unturned in seeing to it that the Central Government employees, more so the Central government Pensioners in the City of Mysuru and the towns and cities around, are able to have access to the Medicare provided under the Central Government Health Scheme (CGHS)

The background, the organisations and the individuals who strived hard over the past 20 years or more to make the dream a reality.

- 1. It was the Karnataka Posts and Telecommunications Pensioners Association. then a member of the Standing Committee of Voluntary Agencies (SCOVA) and headed by the late B.Sadashiva Rao IPS (Retd.) as its President and the Veteran P&T Trade Union leader Com N.Bhaskaran as its Secretary. both of whom also headed the Coordination Committee of Central Government Pensioners' Associations Karnataka (CCCGPA) as its Chairman and General Secretary respectively, responding to the consistent demand from the Central Government Pensioners Association. Mysuru, also an affiliate of CCCGPA, notified a subject for inclusion in the Agenda items for discussions in the meeting of SCOVA in January 2006 regarding opening of CGHS Wellness Centre in Mysuru city.
- 2. All India Central Confederation of Pensioners' Association, New Delhi headed by the late S.S. Ramachandran as its General Secretary, had written a letter on 19-8-2002 to the Ministry of Health and FW, furnishing the required statistical data requesting for opening of CGHS

Dispensary in Mysuru stating that there was full justification. (Source: page 8 of Pensioners' Champion January 2006 issue)

- 3. As told to this writer in June 2021 by the late B. Sadashiva Rao, former President of KP&TPA, during the discussions on CGHS Mysuru, it was Dr. T.S. Sathyanarayana Rao, President of Central Government Pensioners' Association, Mysuru, a strong votary for establishment of CGHS WC in the city, who had moved heaven and earth, made many trips to New Delhi, met the concerned authorities in the Ministry of Health and Family Welfare and had strongly pleaded with all concerned to open a Wellness Centre in Mysuru. Dr. Rao, who used to attend the meetings of the CCCGPA, had never forgotten to invariably remind the Management Committee, CCCGPA to pursue the matter with the government.
- 4. In the 'Pensioners Day' observed on 3-1-2010 in Mysuru in which Sri Vijayashankar Ex-Member of Parliament, Lok Sabha was the Chief Guest, Dr. Sathyanarayana Rao, President CGPA, Mysuru was honoured in recognition of his service in the cause of pensioners. Efforts made during the last 2 decades by CGPA Mysore in getting CGHS facility to the City were traced in the meeting. (Source: Journal Pensioners Champion January 2010 issue)
- 5. The 7th Central Pay Commission had accepted the request for oral hearing made by the Coordination Committee of Central Government Pensioners Associations Karnataka (CCCGPA) and their representatives met the Pay Commission in Bengaluru on 24-8-2014. The demand for opening CGHS Wellness Centre in Mysuru was also one of the many other issues like grant of Interim relief, merger of DR with pension, complete parity in pension, reduction in age for grant of additional pension, increase in the quantum of pension and family pension, extension of 7th CPC benefits to Pensioners of Statutory/

Autonomous bodies of Central Government. BSNL pensioners etc., placed before the Pay Commission by the President/ Secretaries of the affiliates of CCCGPA who attended the meeting. S/s. S. Radhakrishna, Chairman, CCCGPA, N. Bhaskaran, General Secretary CCCGPA, S.S. Ramanatha Rao, President and Ashok Kololgi Secretary of Karnataka Central Govt. Pensioners' Association, A.N. Balaram, President and TV Survaprakash Secretary of Coffee Board Pensioners' Association, Dr. Sathyanarayana Rao President and M S Mohan, Treasurer, CGPA, Mysuru, P. Gangadhara Rao, President, All India BSNL Pensioners' Welfare Association and B Murthy, Asst. Circle Secretary, AIBSNLPWA, Karnataka and K.B. Krishna Rao, Secretary, Karnataka P&T Pensioners' Association, presented the demands on which they had been asked to speak by CCCGPA. Dr. Sathyanarayana Rao brought to the notice of the Pay Commission the long pending demand regarding CGHS facility to Mysuru stating that though the issue had been taken up by Members of Parliament and raised by them in Lok Sabha and Rajva Sabha, CGHS to Mysuru City was yet to become a reality. (Source: Page -2-5 of the Journal Pensioners' Champion August, 2014)

6. Karnataka Posts and Telecommunication Pensioners' Association (KP&TPA) had been pursuing this issue since 2018 and had notified a subject for inclusion in the Agenda items for discussions in the 30th meeting of the Standing Committee of Voluntary Agencies (SCOVA) held on 23-3-2018 requesting for opening of CGHS WCs in Mysuru, Mangaluru and Hubballi/Dharwad. (page 9 of Pensioners' Champion February 2018 issue). This item was again included in the issues/items proposed by KP&TPA for the 31st meeting of SCOVA held on 5-9-2019. (Source: page 4 of Pensioners' Champion February 2019 issue). But the item was not included in the Agenda by DoP&PW. This issue was discussed in the Annual General Body meeting of CCCGPA held on 3-8-19 and it was decided to submit memoranda to Members of Parliament of the respective Constituencies named above.

- 7. Pursuing the matter further, CCCGPA Karnataka submitted memorandum to Sri Prahlad Joshi, the Hon'ble Union Minister of Parliamentary Affairs on 31-8-2019 in Hubballi. (Source: Pages - 8&9 of Pensioners'Champion September 2019). Sri S. Radhakrishna, GS, CCCGPA and Sri T.V. Survaprakash, Joint, General Secretary. CCCGPA met Sri D.V. Sadananda Gowda the Hon'ble Union Minister of Chemicals and Fertilisers in Bengaluru on 19-2-2021 and submitted a memorandum to him regarding (1) Opening of Allopathic Central Government Health Scheme (CGHS) Dispensaries/ Wellness Centres in Mysuru, Mangaluru and Hubballi (2) Empanelment of at least one Private Hospital in each District Headquarter of the state under CGHS and (3) Health care facilities to the Pensioners of Autonomous/ Statutory Bodies of Central Government (Source: Pages-10 &11 of Pensioners' Champion February 2021), Sri P.M. Parameshwaraiah, Secretary, Central Government Pensioners' Association Mysuru submitted a memorandum to Sri Pratap Simha, Member of Parliament, Lok Sabha, Mysuru on 1-10-2019 requesting him to take up the issue with the Health Ministry.
- 8. CGHS Directorate vide letter dated 8-8-2019 had called for information about the likely number of Central Government employees and pensioners that would be the beneficiaries to examine the request for opening of a CGHS Wellness Centre at Mysuru. Additional Director, CGHS Bengaluru had asked KP&TPA to give the inputs needed in this regard.
- 9. In response to the request by the Additional Director, CGHS Bengaluru, Karnataka P&T Pensioners' Association furnished the number of employees and pensioners of the Department of Posts, Dept. of Telecom and BSNL residing in Mysuru city and towns near the city, which

could be ascertained through its efforts. Since the pensioners are eligible for CGHS benefits irrespective of their place of residence, the number of pensioners residing in the cities/towns which are very near to the city of Mysore Viz: Srirangapatna at a distance of 18 KMs; Nanjanagudu at 23 KMs; and Mandya at 46 KMs were also included in the statistical data as there was every possibility of the pensioners of those towns also opting for CGHS benefits.

10. CCCGPA, Karnataka in coordination with the Confederation of Central Government

Employees and Workers Karnataka State, furnished the number of employees and pensioners in respect of other Central Govt. Departments residing in Mysuru City and other places mentioned above.

11. Number of Central Employees and Pensioners in Mysuru, Mandya, Nanjanagudu & Srirangapatna as per the details collected by KP&TPA and COC, Karnataka and furnished to the Additional Director, CGHS Bangalore by CCCGPA in August, 2019 is as follows: (source: Page-4 of the Journal Pensioners' Champion August, 2019).

- 12. As told to the writer of this article by Sri P.M. Parameshwaraiah, Secretary, CGPA, Mysuru, Sri Pratap Simha, Member of Parliament, Lok Sabha, Mysuru along with Sri Tejasvi Surya, Member of Parliament, Bengaluru South Lok Sabha, met Dr. Harsh Vardhan, the Hon'ble Union Minister for Health & Family Welfare in December 2019, handed over the memorandum and requested the Minister to establish a CGHS WC in Mysuru.
- 13. Subsequently, Dr. Harsh Vardhan, the Hon'ble Union Minister of Health and Family Welfare, wrote a personal letter on 11-2-2021 to the Hon'ble the Union Minister of Finance requesting that the proposal for opening of CGHS WCs in 16 cities (List of 16 included Mysuru also) in the country may be positively

considered. Further on 12-3-2021, Sri Ashwini Kumar Choubey, the Hon'ble Union Minister of State, Ministry of Health & FW, in reply to a question by Sri Prajwal Revanna, Member of Parliament, Hassan Lok Sabha Constituency replied in the Parliament that "there is a proposal for opening of CGHS Wellness Centre in Mysuru and the likely number of beneficiaries would be around 20,000."

14. And finally, the Ministry of Health & FW vide its order dated 10-6-2021, (reproduced in Pensioners' Champion June 2021) not only approved establishment of CGHS Wellness Centres in the 16 cities mentioned therein including Mysuru, but also simultaneously, sanctioned the posts of Medical Officers, Para Medical Staff and others which paved the way

for early opening of the WCs and make them functional as quickly as possible.

15. Thus, with the issuance of the OM dated 10-6-2021, the dream of the Central Govt. pensioners residing in Mysuru and other cities nearer, to get the medical facilities available under the CGHS at last, became a reality after nearly 2 decades.

16. On the advice of Dr. M. Revathi, Additional Director, CGHS Bangalore, CCCGPA, Karnataka formed a 4 member committee to coordinate with CGHS authorities in finding a suitable building for housing the Wellness Centre in Mysuru. The committee consisted of S/s P M Parameshwaraiah Secretary, CGPA Mysuru, S Devapala, Member, Karnataka P&T Pensioners Association, Rajasekhara, District Secretary, AIBSNL PWA and Janakinath. member, Income Tax Department Pensioners Association, Sri Parameshwaraiah, evinced keen interest, coordinated well with all the stake holders & other members of the Committee and was able to identify a suitable building in which the Wellness Centre was opened on 7-8-2022.

17. The Coordination Committee of Central Government Pensioners' Associations Karnataka and its affiliates Karnataka P&T Pensioners' Association, Bengaluru, IA & AD Pensioners Association, Bengaluru and Central Govt. Pensioners' Association, Mysuru are glad that their efforts have now borne fruit. 18. In conclusion, the proverbial quote "success has many fathers" has come into play at least with regard to establishment of the CGHS WC in Mysuru which, undoubtedly, is an achievement as a result of the joint efforts of the Pensioners' Organisations and some individuals well supported by the Central Ministers, Hon'ble Members of Parliament, Officers of the Health Ministry, Officers at the CGHS Directorate and of course the Additional Directors past and present in CGHS Bangalore.

19. The support extended by Dr. Harsh Vardhan, the Hon'ble Union Minister for Health & Family Welfare, Sri D.V. Sadananda Gowda, the Hon'ble Union Minister of Chemicals and Fertilisers, Sri Pratap Simha, Member of Parliament, Lok Sabha, Mysuru, Sri Prajwal Revanna, Member of Parliament, Lok Sabha, Hassan, Sri Tejasvi Surya, Member of Parliament, Bengaluru South, Dr.Kishore Kumar C.S, former Additional Director CGHS, Bengaluru, Dr. M. Revathy, Additional Director CGHS, Dr. Ravindra Y. Asangi, CPIO - HQ. Dr. Satish Chandra, Sr. CMO, General Administration & Dr. Vijayalakshmi Mohan, Sr. CMO (SAG) CMS I/C, Hospital Cell shall always be remembered and greatly appreciated.

The CGHS Wellness Centre which was to be virtually inaugurated by Dr. Mansukh Mandaviya, the Hon'ble Union Minister for Health and family Welfare and Chemicals & Fertilisers, Govt. of India, on 7-9-2022, was cancelled due to the sudden demise of Sri Umesh Katti, the Hon'ble Minister of Food and Civil supplies, Government of Karnataka.

Sri S. Radhakrishna Gen. Secretary and Sri T.V. Suryaprakash, Jt. Gen. Secretary, who were representing CCCGPA Karnataka in the opening ceremony, on being informed about the cancellation of the inauguration of the WC, requested the AD, CGHS to make the WC functional from 8-9-2022. Sri Radhakrishna, spoke to the Additional Director general, CGHS Directorate, New Delhi requesting the WC may be made functional from 8-9-22 to cater to the health care needs of beneficiaries especially the seniors. The request was accepted and acted upon by CGHS and the WC started functioning from 8-9-2022.

# Continuous Empanelment Scheme 2022 for empanelment of private Health care Organizations (HCOs) under CGHS.

With reference to the above subject, attention is drawn to Office Memorandum No S 110045/36/ 2012 dated the 26th December, 2017 vide which orders for continuous empanelment scheme were issued. In this regard the undersigned is directed to state that the Ministry has reviewed the Application form along with the Draft for Memorandum of Agreement(MoA) and revised the same.

The revised Application Form for continuous Empanelment scheme 2022 along with revised MoA are enclosed. CGHS package rates as prevalent and as revised from time to time shall be applicable. Private Health Care Organisations (HCOs) seeking empanelment under CGHS Cities can apply

to the Additional Director CGHS of concerned City in this regard. The empanelment shall be for a period of two years.

The HCOs already on CGHS panel shall submit their Letter of acceptance for the revised MoA within 15 days of issue of this OM to the Additional Director of concerned city for continuation on CGHS panel for another two years i.e.till 30th September 2024, failing which it shall be deemed that they are not interested in continuation under CGHS and shall be removed from CGHS panel. They shall sign new-revised MoA and submit Valid Performance Guarantee (for 30 months) within 3 months of issue of this OM.

### **Digital Life Certificate**

Submission of Life Certificate by Pensioners in October/November 2022

All Pensioners are required to submit their Life Certificate to the Pension Disbursing Authority every year in November before 20th of the month. Pensioners aged 80+ can submit their life certificate either in October or November

Last year, in response to a call from the Department of Pension and Pensioners' Welfare, the Association had nominated 11 volunteers to work as DLC operators to assist pensioners and family pensioners to submit their life certificate in October/November 2021. In coordination with Coffee Board Pensioners' Association, Bengaluru, the association had organized 15 camps, not only in Bangalore, but also in Hassan, Mysore, Chikamgaluru in which hundreds of pensioners/family pensioners of Central Government, Statutory & Autonomous Bodies of Central Government/ State Government/EPF/ BSNL/Banks participated. Life certificates were generated by making use of the devices like Iris Scanner/ Face Recognition Access supplied by the Department of Pension & Pensioners Welfare. New Delhi to the nominees registered with DOPPW. Besides this, the volunteers visited the residences of those pensioners/ family pensioners, who could not move out of their residences due to their old age or health problems and helped them in submission of their life certificate from the comforts of their homes. They also visited many old age homes and hospitals.

During 2021 we generated more than 1650 life certificates and topped the list of pensioners associations identified by DOP&PW for DLC work.

Similarly during this year - 2022, we will conduct DLC camps and our volunteers will visit residences of aged pensioners

# Report on the proceedings of the Annual General Body & Conference of All India Federation of Pensioners Association, Chennai (AIFPA) held on 23-7-2022

The 43rd AGB & Conference of AIFPA, Chennai was held on 23-7-2022 at Sri Balaji Kalyana Mandapam, T. Nagar, Chennai. The AGB commenced at 9.30 a.m. with Sri Venkatachari, President, AIFPA, in the chair. Proceedings commenced after paying homage to eminent persons, members and all others who passed away during the year.

Sri S.C. Maheswari, Secretary General, Bharat Pensioner Samaj, New Delhi, the Chief Guest, in his inaugural address applauded the services of AIFPA, BPS & NFRP, Palakkad and other Affiliates of BPS for their combined efforts in the cause of welfare of pensioners numbering about 20 lakhs. He referred to the 110th and 113th report of the Standing Committee of Parliament and demanded that the recommendations of the Committee must be favourably considered by the government.

### MACP is applicable from 1-9-2008

Hon'ble Supreme Court in its order dated 22-08-2022 while disposing Special Leave Petition (Civil) No. 16442 of 2021 and another 168 Special Leave Petitions, has stated that the Modified Assured Progression Scheme (MACP) is applicable only from 1-9-2008 and not from 1-1-2006 and the entitlement is to financial upgradation equivalent to the immediate next grade pay in the hierarchy of the pay bands and not to financial upgradation equivalent to the next promotional post.

### Par 12 of the order reproduced below.

12. In view of the aforesaid discussion, the appeals filed by the Union of India are partly allowed and impugned judgments, to the extent they hold that the MACP Scheme applies with effect from 1.1.2006 and that under the MACP Scheme the employees are entitled to financial upgradation equivalent to the next promotional post, are set aside.

MACP Scheme is applicable with effect from 1.9.2008. W.P. (c) No. 5278 of 2013 decided on 12th August 2014, Civil Appeal @ SLP (C) No. 16442 of 2021 & Ors. Page 28 of 28 and as per the MACP Scheme, the entitlement is to financial upgradation equivalent to the immediate next grade pay in the hierarchy of the pay bands as stated in Section 1. Part A of the First Schedule to the Central Civil Services (Revised Pay) Rules, 2008. The third issue, which relates to the fulfilment of pre-promotional norms for grant of financial upgradation, is decided against the appellant-Union of India to the extent that this would not be insisted in the case of the Central Armed Forces personnel where, for administrative or other reasons, they could not be sent or undergo the pre-promotional course. All pending applications are disposed of.

### Reimbursement of medical claims to pensioners under CS(MA) Rules, 1944 as directed by various courts / CATs

The under signed is directed to say that as per Note-2 below Rule-2 of CCS(MA)Rules,1944, retired government officials are not covered there under. However, as per extant CGHS guidelines, Central Government Pensioners residing in non-CGHS areas have the following options

- They can avail Fixed Medical Allowance(FMA)in lieu of OPD facilities under CGHS
- The can also avail benefits of CGHS (OPD&IPD) by registering themselves in the nearby CGHS covered city after making the required subscription
- iii. They also have the option to avail FMA, for OPD treatment and CGHS for IPD treatments after making the required subscription as per CGHS guide lines,

- 2. All Ministries / Departments of Government of India are requested to bring the contents of this OM to the notice of Organization(s) under their administrative control for guidance and compliance thereof. Also, retiring Central Government Employees may be made aware of the above rule position.
- 3. Court /CAT cases filed by pensioners may be defended by Ministries / Departments in the light of the above rule position. No reference in this regard needs to be made to, Ministry of Health & family Welfare, for comments/ clarifications etc. thereon
- 4. This issues with the approval of the competent authority.

# Financial Upgradation under MACP Scheme to Promotees in Dept of Posts - Hon'ble High Court of Madras dismisses the writ petitions filed by 25 Postal Assistants

Hon'ble High Court of Madras vide order dated 6-6-2022 in WP No.16818 of 2017 and another 23 Writ Petitions of 2018 and one of 2016 dismisses all the writ petitions and rules that "the writ petitioners having availed the promotion to the post of Postal Assistant from the lower post of Postman and group D post, are not entitled to the grant of MACP III and they are also not entitled to the consequential benefits thereof"

Note: For space constraints only a few paragraphs of the order are reproduced below

- 2. As the outcome of the batch of writ petitions would be a direct sequitur of the controversy whether the post of Postal Assistant is the Promotional post of Postal Assistant or whether the selection to the post of Postal Assistant on the basis of departmental test is direct recruitment, hence all the Writ petitions are taken up together and a common order is passed.
- 5. All the petitioners participated in the Departmental Test and were selected to the post of Postal Assistant on the dates tabulated above and they were also extended two financial up-gradations one under the TBOP Scheme on completion of 16 years in Postal Assistant cadre and the second financial upgradation was extended under BCR Scheme on completion of 26 years in the Postal Assistant cadre. On introduction of the MACP Scheme, all the petitioners requested for financial up-gradation under MACP III, along with other benefits, but the same was rejected by the respondents, hence they preferred the O.A.s' before the CAT. The Administrative Tribunal vide orders dated 29-08-2016, 11-08.2016, 08.01.2016, 05.12.2016, 02.01.2017, 26.10.2016 and 16.10.2016 dismissed all the O.A.s' and hence the petitioners have approached this Hon'ble Court

by way of the above writ petitions.

- 6. The petitioners' further contention is that their appointment to the post of Postal Assistant after successfully passing the Departmental Test cannot be considered as promotion but should be considered only as Direct Recruitment.
- 7. On the other hand the contention of the respondent is that the appointment of the petitioners as Postal Assistants consequent to the passing of Departmental Test is to be considered only as promotion and not direct recruitment. If it is considered as a promotion, then the petitioners would not be eligible for MACP III.
- 15. The respondents counsel with reference to the service books of the petitioners submitted that the petitioners had already availed the three financial upgradations viz., MACP I by promotion to the cadre of Postal Assistant from Postman & Group 'D' and MACP II by way of financial upgradations under TBOP and MACP III by financial up-gradation under BCR. The counsel therefore submitted that the petitioners were given three financial upgradations and they were not entitled to any further financial upgradations under the MACP scheme.
- 21. It is pertinent to note here that promotion through tests is restricted to in service candidates and further the age and educational qualifications prescribed for direct recruits is not applicable to promotees. Therefore, the recruitment through Direct Recruitment is a different method with its own prescribed rules. Once the petitioners admit that they wrote the departmental (Test) as Departmental candidates only, it is not possible to accept their contention that nevertheless recruitment is Direct. When

a separate quota of 50% is earmarked for departmental candidates and it is admitted by the petitioners that they took the tests as departmental candidates it is incomprehensible to consider their recruitment as Direct Recruitment. The petitioners as departmental candidates form a separate class and on their passing the tests, they become a class within that class for whom 50% quota is reserved for promotion through tests.

23. Whereas for Direct Recruits the consequence is their discharge from service but for Departmental Candidates the consequence is revertion to their former lower Post. If the contention of the counsels for the petitioners is accepted, then on nonconfirmation, even departmental promotees ought to be sent out instead of reverting them to lower posts. Therefore in our view when the Recruitment Rules are clear, there is no scope for any interpretation against the letter of the Rules.

26. If the above said principles are applied to the facts of the present case it could be clear that the appointment of the petitioners as postal assistants is only promotion and not direct recruitment. The factual reasons for the said conclusion is not far to seek because the Postal Assistant is admittedly a higher post carrying higher scale and the appointment to the said post was by way of selection through Departmental Test. Therefore both legally and factually we conclude that the appointment of the petitioners to the post of Postal Assistants from the lower post of Postman and Group D is promotion and not direct recruitment.

29. In view of the above facts and circumstances and the law, we are of the view that the writ petitioners having availed the promotion to the post of Postal Assistant from the lower post of Postman and Group D post, are not entitled to the grant of financial up-gradation under MACP III and they are also not entitled to the consequential benefits thereof.

### Payment of Medical Bills of Retired Employees - Allotment of Funds & Payment.

This has reference to the above subject. In this connection it is intimated that:

- 1. The Corporate CBB section has allotted funds to the Circles for making payment of medical bills up to 31-3-2022 to the retired employees. The medical bills to working employees as well as CGHS reimbursement to retired employees are already been paid every month together with salary.
- 2. Going forward, the Circles should post the parked medical bills of retired employees and deduct TDS as applicable and these will be disbursed along with the salary of working employees on monthly basis.
- 3. From September onwards, the Circles should regularly post/create the liability of medical

bills in ERP-SAP through defined procedure and deposit the TDS deducted regularly.

Effective 1st September, 2022, all retired employee vendor payments will be made by Corporate CSC i.e. House bank/ Account ID of Corporate CSC Bank will get updated in liability document. Therefore the Circles must ensure that Bank particulars of retired employee vendor are accurately captured in the system; credit to incorrect account shall be the responsibility of the Circles. Once the payment is made, the Circle should ensure that no old bill /liability prior to 31-03-202 should appear in the retired employee vendor account group.
