

Audiences

The Coordination Committee of Central Government Pensioners Associations, Karnataka (CCCGPA) organised a convention of Pensioners of the Associations participating in the Forum of Civil Pensioners Associations. The convention was held in the auditorium of the Telephone House, Bengaluru, on 31st August 2025. More than 300 pensioners attended the convention. Com G Gopala Krishnan, President, (CHQ) All India BSNL Pensioners Welfare Association (AIBSNLPWA), Chennai was the Chief Guest. Com G L Jogi, General Secretary, Sanchar Nigam Pensioners Welfare Association (SNPWA) was the Guest of Honour, Com K B Krishna Rao, President CCCGPA presided. Com S. Radhakrishna, General Secretary welcomed the guests and Pensioner participants. Com Krishna Rao introduced the guests and explained in brief the purpose of the convention being organised as the third phase of a series of struggles chalked out by the Forum to force the government to withdraw the validation clause introduced through Finance Act 2025. General Secretary placed the memorandum prepared by the Forum and also informed that, the same will be presented to the Hon'ble Governor of Karnataka for onward transmission to the Hon'ble Prime Minister.

Com D.Gopalakrishnan, the Chief Guest, fondly called DG, in his detailed presentation, explained the impact of the Validation clause citing various Supreme Court judgments. He explained how the provisions of the Validation clause are ultra virus and unconstitutional. He said "while we challenge the Validation clause in the Supreme Court simultaneously, we should mobilise pensioners all over the country to put pressure on the government to withdraw the Validation provisions."

Com Jogi, in his brief speech, called upon pensioners to actively involve themselves in all the struggles as struggles only bring success.

President, in his concluding remarks, called upon all to prepare for the next phase

of agitation, which is rally in Delhi on 10th October, 2025.

Vice president Com P.Gangadhar Rao proposed a vote of thanks.

A write-up on the subject by Com D G which covers his speech at the convention is reproduced below.

Dear Civil Pensioners.

As President of All India BSNL Pensioners' Welfare Association, CHQ, I extend my warm greetings to all. "Forum of Civil Pensioners' Association" (FCPA) is formed which includes our association.

What is the necessity for forming this FCPA and for what purpose this was formed?

Necessity is the mother of Invention. That necessity arose because of the Central Government's action. In Parliament, Hon Finance Minister introduced finance bill 2025-26. In that bill, in PART IV, "Validation of the CCS Pension Rules and Principles for Expenditure on Pension Liabilities from the Consolidated Fund of India" was also introduced. This validation of CCS Pension Rules takes effect retrospectively from 1.6.1972. The Hon President gave her approval within 4 days and a gazette notification was issued by Ministry of Law and Justice on 29/3/2025.

This was the necessity for forming FCPA. Thanks to the Central Government, because of this move, most of the pensioners' associations in the country came together under one umbrella organization of FCPA to oppose this.

We have several questions to ask the Central Government particularly Hon. Finance Minister.

- * Why Validation of CCS Pension Rules was introduced through Finance Bill 2025-2026?
- * When CCS Pension Rules 1972 was

- replaced by CCS Pension Rule 2021 what is the need for introducing this 'Validation' from 1/6/1972 (from which date CCS Pension Rules 1972 came into effect)?
- On the floor of Parliament, Hon Finance Minister told that 6th CPC, an expert body. recommended for distinction which was accepted by the then Government. But this Government did not make any distinction between pre-2016 and post-2016 pensioners and parity was ensured, thanks to Modiji. Then now what is the need to bring distinction, through validation, based on date of retirement with retrospective effect? She clarified that Keeping in view the recommendations which were made by the 6th CPC, a distinction among pensioners is inevitable and that is what is being brought in as an amendment and by way of Validation.
- * When five member constitutional bench of Hon Supreme Court in its judgment on 17/12/1982 declared that dividing the pensioners based on retirement date is unconstitutional, against article 14 of the constitution, how this 'validation' stands before judicial scrutiny?

No Rule can be static and amendments may be needed. Even Indian Constitution was amended more than 100 times. CCS Pension Rules was amended on earlier occasions and no pensioner association opposed them. But this is not such an amendment.

Let us understand the difference and intention of this Validation.

Whenever amendments to CCS Pension Rules were carried out on earlier occasions under Article 309 of the Constitution, the Gazette Notification was issued by Ministry of Personnel & Public Grievances (Department of Pension & Pensioners' welfare). For example we can take the gazette notification issued on **20.12.2021** introducing the CCS (Pension) Rules, 2021. This notification repealed CCS Pension Rules 1972. Then what is the need for 29th March 2025 notification to amend the said rules from 1/6/1972?

Never before, amendment to CCS Pension Rules was part of Finance Bill. So, introducing the Validation of CCS Pension Rules as part of finance bill reveals the clear intention of the Government. **The clear intention is to reduce the pension liabilities.** To reduce the pension liabilities, the Government has taken over the powers to make distinction among the pensioners based on date of retirement.

To substantiate that point I quote 29.3.2025 gazette notification para 149(1) "Without prejudice to the provisions of the pension rules, the Central Government shall have the authority to establish distinctions among pensioners as a general principle".

Para 149(4) states "The norms, principles and method of pension revision, as per accepted recommendations of a particular Central Pay Commission, shall be effective from such date as may be determined by the Central Government and the benefit of such accepted recommendation shall not be given effect to from an earlier date".

I also quote para 150 of 29th March 2025 notification which gazette states "Notwithstanding anything contrary contained in any judgement, decree or order of any court, tribunal or authority and notwithstanding anything contained in the pension rules" (a) "It is hereby clarified that the Central Government has the authority and shall always deemed to have had the authority, to classify its pensioners, and may create or maintain distinction amongst pensioners as deemed expedient for implementing recommendations of the Central Pay **Commissions under this Part:**

(b) "It is also clarified that the date of retirement of pensioners shall be the basis of distinctions and for classification in regard to pension entitlement". Can any pensioners' association, worth its salt, remain a silent spectator to this development? The reply is an emphatic "NO".

That is why many pensioners' associations, at the initiative of NCCPA (National Coordination Committee of Pensioners' Associations), an umbrella organization, came together and formed Forum of Civil Pensioners Association (FCPA)

Sole objective of FCPA is to oppose Validation of CCS Pension Rules 2025 through struggles and also by way of challenging it in Hon Supreme Court through a Writ Petition.

The first phase of agitation, Human Chain, was held on 25/7/2025 throughout the country. The response from the pensioners, particularly telecom pensioners (members of AIBSNLPWA, AIBDPA, SNPWA, AIRBSNLEWA, RTOWA, MREWA) was tremendous and it reflects their understanding of the issue and the impending danger. It shows that they are the real soldiers and not pawns in a chess board as narrated by someone.

FCPA which met virtually on **6.8.2025** congratulated the pensioners who made the first programme a grand success; decided that FCPA should be formed at all states reflecting the unity of pensioners associations; decided to conduct further programmes like State-level convention, memorandum to Governors, pressmeet, meeting MPs of all parties, Delhi-chalo (on 10.10.2025) successfully.

On behalf of Registered Civil Pensioners' Associations whose pension is regulated as per CCS Pension Rules shall file the Writ Petition in Supreme Court shortly. Shri Kapil Sibal, learned lawyer has agreed to appear and argue the case on our behalf.

In our country, constitution is supreme. Art.50 of our constitution mentions about separation of powers between Legislature, Executive and Judiciary. This division ensures that each branch has defined functions and

powers to prevent the concentration of power in one entity, promoting a system of checks and balances. The separation of powers, even with its flexible application, is crucial for maintaining a democratic and accountable government in India. It safeguards against the concentration of power and potential abuse, promoting a system where the rule of law is upheld. Usurping the powers of the judiciary by the Executive is against this article.

Irrational, illogical distinction on the basis of date of retirement is against Art.14 of our constitution as declared by 5 member Constitutional Bench of Supreme Court pronounced on 17th December 1982 in D S Nakara & Ors Vs Uol case. It is a settled law.

Many laws passed by legislature, if it is arbitrary, not in consonance with the constitution have been declared as null and void by Hon. Supreme Court. One such example is that NJAC (National Judicial Appointment Commission) which was passed by Parliament unanimously was struck down by Hon Supreme Court.

We believe that Validation of CCS Pension Rules through Finance Bill 2025 will be declared 'ultra vires of constitution' by the Hon. Supreme Court.

Constitute 8th CPC immediately

The Government's decision to appoint 8th CPC was announced on **16th January 2025** but even after 7 months it is not constituted, though consultations were held by Cabinet Secretary with JCM, staff-side. The delay causes concern and anxiety among the pensioners. The Central Government is urged to constitute 8th CPC and finalize the Terms of Reference without further loss of time.

6th CPC was announced and constituted on the same day i.e. 5/10/2006. It was because of then prevailing political situation (UPA–1 Government was headed by Dr. Manmohan Singh supported by left parties).

Submission of Digital Life Certificate through the "Face Authentication Technology"

All the pensioners/family pensioners are required to submit their Life Certificate to the Pension Disbursing Authority every year in November before 20th of the month. Pensioners aged 80+ can submit their life certificate either in October or November. During last year, 33 members voluntarily visited residences of 1444 aged infirm pensioners to help them to submit their life certificate from the confines of their homes/ Old age homes. They organized 39 Digital Life Certificate Camps, 27 in Bengaluru and 12 in other places like Mysuru, Nanjanagudu, Chamarajanagara, Hassan, Chikmagalur, Shivamogga Tumakuru,

Davanagere, Chitradurga, Kolar, Robertsonpet, Thirupathi. They helped a record number of 3536 pensioners /family pensioners to submit their digital life certificate making use of the "Face Authentication Technology" launched by the Department of Pension and Pensioners Welfare in collaboration with UIDAI & Ministry of Electronics and Information Technology (Miety). Similarly, during this year 2025, in association with Coffee Board Pensioners' Association, we will conduct DLC Camps and our volunteers will also visit residences of aged pensioners who register their names with us.


