As senior citizens like us are vulnerable to this new virus, my appeal to all our pensioners/family pensioners is to STAY SAFE AT HOME AND KEEP OTHERS SAFE, AND LET US NOT BECOME A SOURCE TO SPREAD THIS VIRUS TO OTHERS AND VICE VERSA.

2. Even during the Lockdown period, which commenced in March 2020, as former Chairman of Co-ordination Committee of Central Government Pensioners Associations, Karnataka, (CCCGPA), Bengaluru, to which

more than 30 Pensioners' Associations in Karnataka are affiliated, and as former President of Karnataka P&T Pensioners' Associations, Bengaluru, I have been observing that the CCCGPA, under the leadership of its Chairman, Sri K B Krishna Rao, General Secretary, Sri S. Radhakrishna, Joint General Secretary, Sri T V Suryaprakash, and other MC members, has been actively involved in taking care of welfare of pensioners/family pensioners of not only the Central Government, but also the Pensioners/family pensioners of Autonomous/Statutory Bodies of Central Government. They are continuing to be in touch with the CCCGPA affiliates and other pensioners/family pensioners through WhatsApp, E-mail and Video Conference on important issues relating to pension, CGHS, income tax returns to be filed, health, etc. which have to be highly acknowledged and commended.

- 3. During the Lock Down Period and even after the lock down was lifted, the CCCGPA in association with Pensioners' Associations of Autonomous/Statutory Bodies of Central Government, had conducted Video Conferences, as detailed hereunder, for the benefits of pensioners/family pensioners and other Senior Citizens:

- Importance of making nomination, writing of will and utilities of Permanent Lok Adalat
   by Sri Ashwathanarayana, Chairman, Permanent Lok Adalat on 7.9.2020
- 4. In addition to the above, Sri S. Radhakrishna, General Secretary, CCCGPA, spoke on 'family pension and other related issues" through power point presentation on 10.5.2020, which was very useful to pensioners/family pensioners. On 15.6.2020 he spoke on "Comparative study of tax determination under old tax regime and new tax regime for AY 2021-22"

- 5. Though the monthly magazines by the affiliates of CCCGPA, viz. Karnataka P&T Pensioners Association, Karnataka Central Government Pensioners Association, Karnataka IA & AD Pensioners Association and Coffee Board Pensioners Association could not be posted to all their members during the lockdown period till May 2020, these affiliates had continued to post their monthly magazines to all their members who ever had WhatsApp and E-mail facilities. During June, July and August 2020, they ensured to post their monthly magazines to all their members even though there were many containment zones and the movement of persons and delivery of mails in those places had been restricted. Their concern in communicating the important information relating to Pension, CGHS and other related issues, to their members, during this pandemic period, has to be highly appreciated.
- 6. Sri K B Krishna Rao, Chairman, and Sri S. Radhakrishna, General Secretary, CCCGPA, were in constant touch with the Additional Director, CGHS, Karnataka, and interacted with her about the procedural formalities to be observed by the CGHS beneficiaries during the lockdown period and also thereafter. As a result of this continuous interaction with the Additional Director, CGHS, Karnataka, the Additional Director made an Appeal, through CCCGPA to all CGHS beneficiaries to take utmost care of their health and stay home unless needed to go out for reasons of health requiring immediate medical attention in case of an emergent situation and also gave procedural aspects to be followed by the CGHS beneficiaries during this pandemic period. CCCGPA, accordingly, circulated the appeal and advice given by the Additional Director, CGHS, to all the CGHS beneficiaries through WhatsAPP and also the monthly magazines of the affiliates. CCCGPA had also circulated all the instructions issued by the DoP&PW, Ministry of Health and Welfare, Department of Finance, Ministry of Home Affairs and other Ministries in the

- Government of India and also the Guidelines issued by the Government of Karnataka, from time to time on COVID 19, through WhatsApp and affiliates' monthly magazines. These services to the pensioners have to be appreciated and commended.
- 7. Having foreseen the difficulties that the pensioners might have to face when the pensioners aged 80+must submit their life certificate to the pension disbursing authorities in October and all other pensioners in November, by which time there is no hope of the present pandemic covid-19 situation in the country abating allowing unrestricted movement of senior citizens, CCCGPA sent an email to the Secretary, Dept of Pension and PW, requesting that the time limit for submission of life certificate be extended up to 31-3-2021.
- 8. When DoP&PW vide its order dt. 11-9-2020, extended the time limit by only one month and fixed the last date for submission of life certificate as 31-12-2020, CCCGPA again sent an email on 13-9-2020 requesting that the decision be reconsidered in view of the fact that ICMR and medical experts have opined that Corona virus infection is likely to surge and may not end soon. Bringing to the notice of the Secretary, DOPPW, that pensioners associations may not be in a position to conduct Digital Life Certificate camps or visit residences of old pensioners this year, as they did in the previous two years to assist pensioners in submission of life certificate, CCCGPA reiterated the request that the time limit be extended up to 31-3-2021.
- 9. Conscious of their social responsibility, many affiliates of CCCGPA Viz., All India BSNL Pensioners' Welfare Association, Coffee Board Pensioners Association, Tobacco Board Pensioners Association, Spices Board Pensioners Association, Karnataka IA&AD Pensioners 'Association, Karnataka P&T Pensioners' Association and Karnataka Income Tax Pensioners' Association sent donations in lakhs to the PM Cares Fund and Karnataka Chief Minister Relief Fund —Covid-19.

10. As pensioners /family pensioners of Central Government have been permitted to avail both indoor and outdoor medical treatments under Central Government Health Scheme on cashless basis and as the similar facilities have not been allowed to the pensioners/family pensioners of Autonomous/Statutory Bodies of Central Government, Pensioners Associations of Autonomous/Statutory Bodies of Central Government, Karnataka, with the assistance of CCCGPA, had approached empanelled hospitals/labs under CGHS to provide medical/diagnostic services to the members of their affiliates and spouses at CGHS rates on payment of cash. We are glad that some of the empanelled hospitals under CGHS, not only from Bengaluru, but also outside Bengaluru, have conveyed their acceptance to extend CGHS facilities on payment of cash to the members of affiliates of Pensioners Associations of ABs/SBs of Central Government and their spouses. With this, financial burden of these pensioners has also got reduced to some extent.

11. I wish to acknowledge and appreciate the yeoman services rendered to the pensioners' community during this pandemic period by Sri K B Krishna Rao, Chairman, CCCGPA, S. Radhakrishna, General Secretary, CCCGPA, and Sri T V Suryaprakash, Joint General Secretary CCCGPA, and their team.

#### SHRI PRANAB MUKHERJEE



**Bharat Ratna Shri Pranab Mukherjee,** former President of India, passed away on 31st, August 2020 at the age of 84 years. He was the 13th President of the Republic of India

## Waiver of recovery of wrongful/excess payments made to retired Government servants

The undersigned is directed to say that Hon'ble Supreme Court in the case of State of Punjab and Others Vs. Rafiq Masih (White Washer), etc. in C.A. No. 11527 of 2014 summarised a few situations wherein recoveries by the employers would be impermissible in law. One of these situations relates to recovery from retired employees or employees who are due to retire within one year of the order of recovery.

- 2. Based on the above judgment, Department of Personnel & Training has issued instructions vide their OM No. 18/03/2015-Esst. (Pay-I) dated 02.03.2016 that the issue of wrongful/ excess payment made to Government servants may be dealt with in accordance with the decision of the Hon'ble Supreme Court in the above mentioned case. The instructions further provide that wherever the waiver of recovery in the situations mentioned in that OM is considered, the same may be allowed with the express approval of Department of Expenditure in terms of DoPT's OM No. 18/26/2014-Estt (Pay-I) dated 06.02.2014.
- 3. In order to examine the matter in its entirety, all Ministries/Departments and Pension Disbursing Banks are requested to provide the following information regarding excess payment of pension and other retirement benefits to the retired Government employees:
- 1. No. of retired employees from whom recovery of excess payment of pension and

- other retirement benefits has been made or is sought to be made by the Ministry/Department as well as its attached offices and subordinate offices.
- 2. No. of pensioners from whom recovery of excess payment of pension and other retirement benefits has been made or is sought to be made by the Pension Disbursing Bank.
- 3. Period of excess payment in each case and the date on which excess payment was noticed.
- 4. Amount of excess payment in each case.
- 5. Whether any court/CAT order has been received for waiver of recovery of excess payment in the light of the judgement of Hon'ble Supreme Court in Rafiq Masih's case. If so, the details of such cases received in last three years (year-wise) and action taken on the order of court/CAT may be indicated
- 6. Whether any representation has been received for waiver of excess payment. If so the details of such representations received in last three years (year-wise) and action taken on the representations may be indicated.
- 7. All the Ministries/Departments are, therefore, requested to furnish the information sought in para 3 above to this Department by 15.09.2020 positively

#### **Submission of Life Certificate**

Greetings from the Co-ordination Committee of Central Government Pensioners Associations, Karnataka, Bengaluru.

We wish to convey our sincere thanks to your good self for extending the time limit for submission of life certificate by the pensioners/family pensioners by one month and permitting submission on or before 31.12.2020 this year, as per the OM No.18/1/2020-P&PW (C) 6681 dated 11.9.2020 – in the context of the prevailing Covid-19 pandemic situation in the country and also keeping in view the vulnerability of elderly population to Corona Virus.

In this connection, kindly refer to our E-mail dated 7.9.2020 to your good self, wherein we had requested you to extend the due date for submission of life certificates by the pensioners/family pensioners to the Pension Disbursing Authorities up to 31.3.2021 in view of the reasons mentioned therein. A copy of this e-mail is in the forwarded e-mail for your ready reference.

As per the recent reports of ICMR, WHO and other experts in the field, which are

being broadcast in Electronic Media and published in printmedia, the spread of Covid-19 is not likely to ease and scale down till April/May 2021 or until a vaccine is available at least by March 2021 to contain the spread of this highly infectious contagion. As such, many pensioners/family pensioners may find it extremely difficult to go to the Pension Disbursing Banks or Post offices and submit the life Certificate on before 31.12.2020.

The Pensioners' Associations may also not be in a position to conduct special 'Digital Life Certificate Camps" as was done during the last two years for the fear of spread of the infection.

Further, many of the Pension Disbursing Banks and Post offices may also find it difficult to accept the life certificates in physical format from the pensioners/family pensioners, or to generate Digital life certificate after getting their bio metrics whenever the Pensioners visit the Pension disbursing authorities (PDA), since all pensioners are most vulnerable to this virus.

Officials from the PDAs also may avoid visiting the houses of pensioners for the fear of contracting the infection.

It is also observed that, in all the orders issued by DoP&PW regarding pension revision or pension disbursement, mention of banks only is made and there is no mention of post offices. We, therefore, request that

"Pension Disbursing Post Offices" may also be mentioned alongside "Pension Disbursing Banks" in all the orders on Pensioners issued by the DoP& PW. Similarly, we also request you to kindly mark a copy of this order and also in all the orders on pensioners issued by the DoP&PW to all the "Ministries of Government of India and other Departments/ offices working under them".

Under the above circumstances, we request you kindly to reconsider the decision taken by your good self to extend the time limit for submission of life certificate by one

month only and accept our earlier request for extension of due date for submission of life certificates, this year, up to 31.3.2021, as made in our e-mail dated 7.9.2020 and cause issuance of revised orders accordingly. If this is done, all pensioners/family pensioners will be grateful to you Sir.

#### SMS alerts on credit of pension

Respected Sir,

We hope that your good self has seen the matter on the subject cited above published in page 3 of the August 2020 issue of the association's journal "Pensioners' Champion "sent to you by email on 28-08-2020

- 2. In continuation of our email, we would like to write that almost all of our members got the messages on 1.9.2020 regarding credit of pension for August 2020 with details such as Basic pension, DR, FMA, Additional pension etc. We understand that lakhs of SMSes were sent 1st Sept 20.
- 3. We are extremely glad to place on record that under your initiative, guidance and perseverance, the Department of Posts could be successful in its maiden attempt, to send messages to lakhs of Postal Pensioners regarding credit of their pension with all the details, which would almost serve as a pension slip for the month. Sir, on behalf of the 3000 members of KPTPA, we express our deep gratitude to your good self for your pensioner friendly initiative.
- 4. While there would always be scope for further improvement, in the content and transmission of the SMSes, we appreciate the alacrity with which the matter was pursued at the highest level in the department, which only ensured implementation of the scheme in right earnest on 1.9.2020 to the satisfaction of a

multitude of Pensioners in the country.

- 5. Notwithstanding the minor discrepancies in the messages, it is to be highly appreciated that the Department ,has made a sincere and laudable effort in this regard and the system is sure to stabilise and improved upon further in the future.
- 6. We request you kindly to consider indicating the commuted part of pension also in the SMS, since only the reduced pension is being shown now. Basic pension, commuted part of pension and the percentage of DR, and balance at the credit of the pensioner after credit of the pension for the month, if indicated in the SMS in addition to the existing details, the message would give all the details that a pensioner needs to have.
- 7. At this juncture, we may please be permitted to bring to your kind notice that in a note on SMS sent to you earlier, we had mentioned about non-receipt of SMS regarding acceptance of the Digital Life Certificate by the HPO after its submission by Postal pensioners.
- 8. All pensioners have to submit their life certificates during the months of October (pensioners aged 80+) and in November (All pensioners) and the time for submission of life certificate this year is fast approaching. Hence, it is earnestly requested to cause sending of a message to the registered mobile phone number of the Postal Pensioner about successful acceptance of the DLC by the Head post office concerned as it happens in respect of a Pensioner drawing pension from bank who gets SMS on his registered mobile phone immediately from Jeevan Pramaan on

submission of DLC and subsequently from the CPPC of the pension disbursing bank confirming successful acceptance of life certificate by the bank and the process is completed to the satisfaction of the Pensioner. But, in the case of a postal pensioner, though he/she gets a message from Jeevan Praman on submission of DLC, subsequently SMS on acceptance of the DLC by the HPO

concerned is not being received now and the postal pensioner will not be sure of its acceptance by the HPO. Hence there is a need for sending SMS on acceptance of DLC by the HPO.

## Extension of period for submission of Life Certificate from October 2020 till December 2020.

Every Central Government pensioner has to submit life certificate in the month of November for further continuation of his/her pension. It has been observed that a large number of Central Government pensioners physically visit bank branches for this purpose.

- 2. Earlier, as a measure to enable additional dedicated time to very senior pensioners, this department, vide OM No. 1/20/2018-P&PW(E), dated 18.07.2019, allowed the pensioners in the age group of 80 years and above, to submit Life Certificate from 1st October onward instead of 1st November, every year.
- 3. In view of the ongoing Covid-19 pandemic and keeping in view of the vulnerability of elderly population to Corona Virus, it has now been decided to extend the existing timeline for submission of Life Certificate. This year, all Central Government pensioners may submit Life Certificate from 1st November, 2020 onward, till 31st December 2020. However, the pensioners in the age group of 80 years and above, can submit Life Certificate from 1st October, 2020 onwards. to 31st December, 2020. During this extended period, the pension will be continued to be paid by the Pension

Disbursing Authorities (PDAs) uninterrupted.

- 4. Further, in the line of RBI notification no. RBI/2019-20/138, dated January 9, 2020, which permits Video based Customer identification Process (V-CIP) as a consent based alternate method of establishing the customer's identity, PDAs may also explore the said methodology for obtaining a Life Certificate from the pensioner, to the extent permitted by RBI guidelines, in order to avoid rush at the branches.
- 5. The above measures are expected to avoid rush al branches and maintain social distancing, while obtaining Life Certificates from the elderly this year. PDAs shall also ensure proper arrangements and social distancing measures at the branches and prevent overcrowding.
- 6. All Pension Disbursing Authorities are requested to take note of this OM for compliance and give wide publicity to the same amongst the pensioners.

This issues with the approval of the competent authority.

## Medical Facilities for DoT Pensioners

#### Reimbursement of medical claims

Gol, Ministry of Communications, Department of Telecommunications OM No:4-35(01)12019-PAT Dated: 28/07/2020

#### Reimbursement of medical claims to pensioners residing in non-CGHS area

This refers to medical claims being received from pensioners residing in non-CGHS areas. In this respect, Ministry of Health and Family Welfare's (MoH&FW) OM No. S. 14025/23/2013- MS.EHSS dated 29.09.2016 may be referred (copy enclosed). As per this OM, the pensioners residing in non-CGHS have following options to avail medical facilities:

- (a) They can avail Fixed Medical Allowance (FMA) @ Rs. 500/- per month or as revised from time to time. At present, vide OM 4/ 34/2017/P&PW(D) dated19.07.2017, FMA is @ Rs. 1000/- per month.
- (b) They can also avail benefits of CGHS (OPD & Department (OPD & Department) by registering themselves in the nearest CGHS city after making the required subscription.
- (c) They also have the option to avail FMA for OPD treatment, and CGHS for IPD treatment after making the required subscriptions as per CGHS guidelines.
- 2. In addition, in accordance to MoH&FW's OM No. S.11011/11/2016 CGHS (P)/EHS dated 09.01.2017 (copy enclosed), pensioners have option to avail CGHS facilities by making contribution on an annual basis (1 year/ 12 months) or by making contribution for 10 (ten)

years (120 months) for getting a pensioner CGHS card with life-time validity.

- 3. The undersigned is directed to request all the Pr. CCA/CCAS and others concerned offices that the pensioners of this Department residing in non-CGHS areas may be intimated/ sensitized (more than once) by an appropriate means about the above options for medical facilities available to them as per MoH&FW OM dated 29.09.2016 and OM No. S.11011/ 11/2016 CGHS (P)/EHS dated 09.01.2017. They may be advised that for availing reimbursement of their medical bills, they have tomandatorily register themselves with the nearest CGHS facility as per one of the options above. They may also be advised that if they fail to register themselves w.e.f. applicable date with the nearest CGHS facility for availing OPD/IPD treatment, their further medical bills may not be reimbursed by this Department.
- 4. Compliance report in respect of the above may be furnished to this office for appraisal of Secretary, DoT. This issues with the approval of competent authority.
